

Club By-Laws

- (1) No one shall hunt on Lick Run Hunting Club Leased Lands except members set forth in the guidelines. Members retrieving game from surrounding properties shall seek permission of the landowner before entering private land.
- (2) Any destruction of Coastal Lumber Company properties will be grounds for dismissal after being brought before the Board of Directors.
- (3) All club members shall do all within their power to prevent and suppress forest fires.
- (4) Any infractions of DNR hunting regulations COULD be grounds for dismissal of membership in the Lick Run Hunting Club after review by the Board of Directors.
- (5) Club President and Vice-President will have a voice vote.
- (6) To hold Lick Run Hunting Club meetings, the President or Vice-President shall be present.
- (7) Any infraction of Lease Agreement with Coastal Timberland Company and Pardee and Curtain Timberland LLC could be grounds for dismissal of membership upon a decision by the Board of Directors.
- (8) Club member's dues will not be refunded for any reason except for denial of application.
 - A. All dues will be paid by March 1st of each year. (1/26/2025) SMM
 - B. Dues paid between March 2-8 will be assessed \$50 late dues fee. (1/26/2025) SMM
 - C. Dues paid between March 9-15 will be assessed \$100 late dues fee. (1/26/2025) SMM
 - D. Any member that did not pay the assessed dues within the set time, without making prior arrangements with the board, will have their membership terminated, and will then have to reapply. (1/26/2025) SMM
 - ~~B. If your dues are not paid in full by February 28th, your membership position will be terminated. (1/26/2025) SMM~~
 - ~~C. To reactivate your membership, you will be treated as a new member. (1/26/2025) SMM~~
 - D. Any new applications for membership must be reviewed by the President or membership committee and may be subject to a background check for infractions of DNR regulations. The board withholds the right to refuse membership. (3/16/2025) SMM
 - E. All new members will pay the current membership fees.
 - F. Membership is limited to 105 not include 70 + members. (3/16/2025) SMM

~~G. A 70+ member will be charged one half the membership yearly dues when they have reached their 70th birthday. They must be a Lick Run Hunting Club member for five years prior to their 70th birthday. (Currently Suspended)~~

~~H. A member that is a Disabled Veteran will have membership discounted same percentage as their Military Disability, up to 50%, after five consecutive years of membership. Proof of disability will need to be provided. (Currently Suspended)~~

I. When a member's son or daughter reaches 22 years of age, they must become a paying member. (Only exceptions would be if they are full time Military (must show orders))

~~J. For a member to take advantage of section 8-G, they need to provide proof of age when they renew their membership, either driver's license or birth certificate. Sections 8-G and 8-H will be in effect if the club is financially solvent or rescinded by a vote by the Executive Board. (Currently Suspended)~~

(9) Excessive use of alcohol and the use of illegal drugs are not permitted.

NO HUNTING WHILE UNDER THE INFLUNCE OF ALCOHOL. THIS WILL BE ENFORCED!!!!

(10) Camping areas must be kept clean.

(11) The land must be kept clean of all trash. Whatever you take into the hunting area, you must bring back out with you and dispose of in a legal manner.

(12) Lick Run Hunting Club will not give out guest passes.

(13) Only exception to the guest policy is a member whose son or daughter is on Active Military Duty. (This does not include the National Guard or Reserves).

(14) Members are required to give 24 hours of work service to the club per year. Usually between April and October. This does not count towards the grass cutting for those that have a camper spot.

(15) As a member, you will not sell, give, or loan his or her membership to a second party. You cannot and will not sell or give permits for any reason for anything.

(16) ANY INFRACTION OF ITEM 15, THE FOLLOWING WILL OCCUR.

A. All privileges will be removed, and you will no longer be a member.

B. There will be no refunds, and the decision will be final.

(17) A Board of Directors meeting will be held as soon as possible when any infraction of any Club Rules occurs.

(18) All Campers must have a current Coastal Lumber Camper sticker displayed on their camper. The Board will place the stickers on all campers.

If you are selling or giving away a camper already on Lick Run Hunt Club property you must notify the Executive Board. **Campers must be habitable as determined by the board of directors. (1/26/2025) SMM**

(19) If a member does not renew or if their membership is not paid by March 1, they must remove all property from Lick Run Hunting Club property within 30 days **as determined by Webster County Magistrate (1/26/2025) SMM**. If not removed in said period, the property will become the property of Lick Run Hunting Club after legal notification required by law.

(20) ALL MEMBERS MUST SHOW RESPECT FOR OTHER MEMBERS.
NO LOUD NOISE AFTER 10:00 PM.

(21) Abusive and reckless riding of ATV/UTV will not be tolerated. Continued problems could result in membership suspension or termination. All State Laws regarding ATV/UTV will be enforced.

Parents and/or guardian are responsible for the action of their children/guest while operating ATV/UTV and need to be supervised.

(22) Tree stands and/or ground blinds will be limited to two per membership. (All stands must be portable, ladder stand, hang on, or ground blind.) A third stand may be allowed for a family member (husband and spouse who hunts as a team or a child of a member when they are old enough to hunt alone) and must be approved by Board of Directors. NO NAILS IN TREES. NO CUTTING OF TREES. Due to safety reasons, cables or chains on trails will be prohibited. Tree stands must be identified and tagged. **This is to be accomplished by the end of the day set for club cleanup each year (1/26/2025) SMM**. Any stand found not tagged will be considered abandoned and made available for another member. **Stand markings require an active date (year) and tree stand number. If a member's stand is displaced by active logging, that member shall have the first choice on whether to return to that area or not. (1/26/2025) SMM**

(23) A. You must follow the guidelines set forth by the WVDNR while hunting on Club Property. Members will be allowed to harvest one buck with antler's less than 4 points any additional bucks harvest must be 4 points or larger following WV DNR guidelines which is currently **2 (1/26/2025) SMM** bucks per season. Only one doe can be harvested per calendar year.

B. The use of dogs to hunt/train bear or to track deer is prohibited on Lick Run Property.

(24) There shall be no "Sighting-In" of firearms on Lick Run Hunting Club property.

(25) Campfires are allowed, but only on the campsite approved by the local CTC regional manager. All campfires must be contained by a barrier no less than 6 inches in height and a ring no larger than 6ft in diameter. Campfires may not be left unattended and must be fully extinguished before campers leave the fireside. No new fire ring will be allowed other than the portable type rings that can be cleaned and stored when you leave.

Campfires will not be allowed during times of extreme drought or when State Burn Bans are posted.

There will be no burning of trash/garbage at any time, take your garbage home with you.
