1. Commitment:

2. Class Participation & Fees:

If selected, I agree to the following **class times** on Mondays and Wednesdays:

• *Intermediate*: 6:30pm - 7:30pm

• *Advanced*: 7:40pm - 8:40pm

If selected, I agree to the following **class fees**:

- *Students*: \$110/biweekly or \$200 per month
- *Adults*: \$130/biweekly or \$250 per month
- 10-15% off total amount for paying the semester in full

- This includes weekly rehearsals, live vocal coaching, teaching, and participation in at **least** two live performances this semester (from now until the end of May), with a special final concert in May featuring award-winning guest artists.
