

# Top Gun Springers Puppy Pick-Up Policy

## PUPPY PICK-UP POLICY CONTRACT

This contract sets out the terms and conditions for the purchase and pick-up of a puppy from Top Gun Springers. By purchasing a puppy from us, you agree to the following:

Since 1992.

Visitors and Appointments: We welcome visitors by appointment only, after the puppy reaches 6 weeks of age.

Puppy Release: No puppy will be released before 8 weeks of age, as required by state law.

Deposit: Buyers with deposits may come to pick out their puppy at 6-7 weeks of age, but must wait until 8 weeks of age to take the puppy home.

Placement: We begin placing puppies at 8 weeks old. Buyers with deposits must have already chosen their puppy and made arrangements for shipping, delivery, or pick-up.

Boarding: We provide boarding for buyers who want to wait until after a vacation or holiday to pick up their puppy. Prior arrangements must be made, and boarding fees of \$35.00 per day will apply after 9 weeks of age, unless the buyer has selected one of our training plans.

Shipping: If the puppy is being shipped, arrangements must be made and paid for in full before 7 weeks of age. We may wait until 10 weeks of age to ship if needed. We prefer to fly with the puppy as a carry-on in a small soft-sided crate.

Delivery: Hand-delivery arrangements will be made in advance.

Retention: We reserve the right to retain any puppy from any litter at any time, regardless of deposits for that litter. We may retain all puppies from a litter for 12+ weeks to determine quality and traits of puppies in a litter.

Prices: Puppy prices range from \$1,500 to \$2,500.00, depending on quality and training. Basic prices are \$1,700.00 for males and \$2,000.00 for females. Tri-color and roan are available at an additional cost of \$200. All puppies are sold with full registration. Trained puppies (when available) are priced accordingly based on their level of training.

Training: We charge \$500-1,000.00 per month for basic training, and hunt training is based on available hunting training grounds at the time of intake. We prefer to take a dog 6 months to a year for hunt training.

Contact: Please provide us with your contact information, including your address and phone number, so we can contact you about your puppy.

By signing below, you acknowledge that you have read and agree to the terms and conditions of

this contract for the purchase and pick-up of a puppy from Top Gun Springers.

## **PICKING UP YOUR PUPPY:**

Your assigned puppy will need to be picked up between 8 and 9 weeks of age. If your puppy is not picked up by the 9th week and no prior arrangements have been made with the seller, Top Gun Springers has the right to void the Puppy Sales Contract and find another buyer. If prior arrangements have been made with the seller the buyer will be charged boarding fees of \$35 each week extended from the 9th week of age. All fees are required to be paid in full before the puppy is released to the buyer.

## **SHIPPING YOUR PUPPY:**

Shipping arrangements can be made for your puppy. Shipping charges and all associated fees are charged to the buyer and are due before shipping can occur. The shipping fees associated with your puppy will be listed in the Puppy Sales Contract. Your assigned puppy will need to be shipped between 8 and 10 weeks of age. Seller reserves the right to delay shipping if health of puppy is at risk. If your puppy is not shipped (by fault of buyer) by the 10th week and no prior arrangements have been made with the seller, Top Gun Springers has the right to void the Puppy Sales Contract and find another buyer. If prior arrangements have been made with the seller, the buyer will be charged training/boarding fees of \$100.00 each week extended from the 8th week of age. All fees are required to be paid in full before the puppy is released to the buyer. If we are keeping a pup past 8 weeks, we automatically begin training.

#### FIRST RIGHT OF RECOVERY:

If the buyer is unable to care for or chooses to change his/her mind about caring for the puppy purchased Top Gun Springers retains the right for recovery of the puppy at the buyers' expense. The buyer must notify Top Gun Springers as to the change in circumstance and give the seller first right to the dog before any other action is taken. This includes and is not limited to selling the dog to another buyer. The original purchase price of the dog is non-refundable if there is

nothing wrong with the puppy/dog and the buyer is just unwilling or unable to care for the animal. There are NO EXCEPTIONS
