

Top Gun Springers Purchasing Agreement

PURCHASING AGREEMENT FOR PUPPY FROM TOP GUN SPRINGERS

This agreement ("Agreement") is made on the date of purchase between Top Gun Springers, ("Breeder"), and the undersigned buyer ("Buyer").

Since 1992.

Deposit: The Buyer shall pay a non-refundable deposit of \$200 to reserve a puppy from any current or upcoming litter. The deposit shall be applied towards the purchase price of the puppy.

Puppy Reservation: The Breeder reserves the right to retain any puppy from upcoming litters until the Breeder releases them. The Breeder will accept up to six deposits for a specific litter. Any additional deposits shall be considered general deposits until the litter is born, at which point the Breeder will reevaluate the deposit list. The Buyer must specify the gender, color, and purpose (hunting or companion) of the desired puppy. If there is no puppy matching the Buyer's requirements, the deposit may be applied to the next available litter. Natural Breeding Program: If the Buyer wants a puppy from specific parents, the Buyer should wait until the parents have a litter. The Breeder will not refund the deposit if the desired parents do not have a litter. The Breeder reserves the right to choose which dogs to breed and when.

Deposit Refund: If, for any reason, the Breeder chooses to return the deposit to the Buyer, this action ends all further transactions between the Breeder and the Buyer.

Holding Deposit: If the Buyer is not ready to take the puppy when it is available, the deposit may be held by the Breeder for up to two years. If the Buyer passes on the current litter and the deposit is held, the Breeder reserves the right to place the puppy with another buyer if the temperament warrants it.

Communication: If the Breeder is unable to contact the Buyer regarding the deposit for a current litter within four weeks, the deposit shall automatically be applied to a future litter, allowing the Breeder time to find a home for the puppy that had been reserved for the Buyer.

Since 1992.

Puppy Selection: The Buyer may choose the desired puppy at about 6-7 weeks of age. The Buyer should choose the puppy as early as possible so the next person in line may choose their puppy as well. If there is only one puppy of the desired sex and color, and the Buyer is first on the list for that puppy, the puppy shall be reserved for the Buyer. If the Buyer chooses a puppy, that puppy shall not be shown to other potential buyers.

Puppy Price: The price of the puppy shall be determined at the time of release and shall be based on traits, temperament, confirmation, and training.

Payment: All payments made prior to the birth of a litter, full or partial, shall be considered a deposit and are therefore non-refundable.

Refusal of Service: The Breeder reserves the right to refuse service to anyone.

Governing Law: This Agreement shall be governed by the laws of the state in which the Breeder is located.

Entire Agreement: This Agreement contains the entire understanding between the parties and supersedes all prior negotiations, understandings, and agreements between the parties.

The undersigned Buyer acknowledges that they have read and understand the terms and conditions of this Agreement and agree to be bound by them.
