### New Hope Blooms in the Fight Against AIS

Following a multi-agency response to the discovery of zebra mussels in Christmas Lake (near Excelsior, MN) last August, results of initial diver searches indicate experimental treatments were effective. On April 13th, divers from Blue Water Science and Waterfront Restorations conducted a thorough survey inside and directly outside the treatment area around the public boat access in the City of Shorewood and found no evidence of zebra mussels. Subsequent monitoring of the lake will be necessary

to confirm whether or not zebra mussels are present in other areas of the lake.

“We are encouraged by these early results,” said Keegan Lund, DNR AIS Specialist. “We used every available tool to treat the isolated zebra mussel infestation and learned valuable information in terms of responding to new zebra mussel infestations”.

Minnehaha Creek Watershed District's (MCWD) aggressive early detection


monitoring effort led to the discovery of zebra mussels near the Christmas Lake public boat launch in Shorewood on August 16, 2014. In coordination with the DNR and the City of Shorewood, the affected area was cordoned off and treated with Zequanox®, followed by a copper-based product and then potash.

Zequanox®, a natural substance made up of a dead bacterium, was first applied to the treatment area in September. That application was fol-

## Roger's Report—by Roger Brekken

### FALL 2014 FREEZE-UP SAGA

Emily and Little Emily froze over on 11/14. Lawrence froze over around 11/20. But the first significant sub zero weather was not until Thanksgiving when temperatures dropped to -7 to -10° F. At that time there were still large areas of open water on the south end of Roosevelt. Migrating swans were seen taking advantage of the open water.

The last 10-15 acres of open water on the south end of Roosevelt skinned over on 12/4. However, it opened up again on the 6th with high wind, temperatures in the low 30's and a light rain which turned to snow in the afternoon.

Starting 12/10 we had three days of light hoar frost followed by dense fog on the 13th and 14th with temperatures between 39° and 44°F. The open area expanded to 20-25 acres.

It skinned over again on 12/18, but a small patch (maybe 5 acres) opened up again on 12/23 after three days of mist and light rain and temps up to 37°F. On Christmas morning two bald eagles were seen standing on the edge of the ice looking into that patch of open water (maybe dreaming of summers days?).

As a testament to the late freeze-up and thin ice, Mikie Walker snapped this picture on December 27th of

some ice fishermen who broke through with their four wheeler while taking a shortcut in front of the Walker's home on South Roosevelt.



On 12/28 there was still open water just south of the islands on South Roosevelt with vapor rising from the open water. On the 29th, despite a temperature of -8F, there was still open water. The lake finally froze over completely either during the night of January 1st or early in the morning of January 2, 2015!

### SPRING 2015 ICE--OUT

Lake Emily, Little Emily and Lawrence Lake were ice free on or before April 11th. On April 12th, a strong and warm (65-70° F) wind pushed the ice on South Roosevelt to the Outing bridge area. Late that evening there was still a

patch of ice on the very north end of North Roosevelt. That ice was gone the next morning, April 13th. By the end of the day, the remaining ice by the bridge

was also totally gone for a same day ice-out on both North and South Roosevelt of 4/13/2015. This was, however, followed by two inches of snow on 4/21 and another inch or more on 4/24!

### DNR LIAISON

Due to my hectic schedule, the 2014 annual meeting with the DNR in Brainerd did not take place until December 4th. A three man delegation (Denny Neill, Bob Lee and I) made the trip to Brainerd and met with Marc Bacigalupi, DNR fisheries manager, and Mike Knepp of the DNR fisheries department. Here is what we learned:

result in nearly as high amount of revenue without being so burdensome for our volunteers. I hope you will prove that this technique can work by contributing generously.

Our contractor, Environmental Sentry Protection has worked diligently over the winter to improve and enhance our two I-LIDs located at the Roosevelt and Lawrence Lake boat launches. They now not only have bigger and better solar collectors but also improved hardware and software. Both units are now working very well and uploading launch videos via cell phone modem. Although we are looking at some video, we could definitely use a couple of volunteers to review the rest for possible violations. You can do this at your convenience from any PC with a reasonably high speed internet connection. Instruction will be provided. If you have an interest in helping us with this, please give me a call or send



me an e-mail.

In addition, we could use some help with taking water samples from all of the lakes we monitor. If you have an interest in helping with our data collection efforts, please contact Darril

Wegscheid (see p. 9 for contact information).

I also wanted to mention that you should consult with the City of Emily or Crooked Lake Township before doing any grading or tree removal on your lakeshore. It was brought to my attention that some of our neighbors have paid very large fines for violating permit ordinances related to lakeshore protection. If you notice activity along the lake you would probably be doing your neighbor a favor by suggesting they check with the city or township too.

Jan Mosman asked me to tell you all that on June 1st at 5:00, you should attend a meeting at the Emily City Hall to talk about a regional comprehensive plan for Emily, Outing, Fifty Lakes, Little Pine and Fairfield Townships. They would welcome your input and ideas.

**New Decontamination Unit at Land O' Lakes Marine—by Kirk Smith**

Land O' Lakes Marine in downtown Outing, has recently completed it's Minnesota state training update for AIS.

In addition, we have just added a new piece of equipment to our service department. It is called a Marine Dynamometer. This machine will allow us to test run outboard, inboard/outboard & inboard powered boats under load (simulating loaded, in the water operating conditions) without the necessity of a lake test for diagnosis and testing of engine running problems.

Until now, if a boat came to us from an AIS contaminated lake, we have had a



policy of returning the boat to it's home lake for testing, to assure that we were NOT contaminating our nearby lakes.

This new device will save hours and

dollars, previously spent on excessive time & travel.

Woods Bay Project—Marc was very enthused about the proposed aquatic management area on Woods Bay. He thinks it is a super use of state and private donor funds. He hopes that the deal will be closed in 2015.

Sandpiper Pipeline—DNR has concerns about groundwater at the Spire Valley State Fish Hatchery. The hatchery started producing rainbow trout 5 years ago and currently produces about 1/3 of the state's supply of rainbows.

Spire Valley has some unique geology. The shallow aquifer that supplies the hatchery is vulnerable to pressure loss by downstream construction. Tests indicate that it may be difficult to get below the aquifer with horizontal drilling. The DNR also is concerned about the water crossings. They have requested an alternate route and/or additional shutoff valves. (There have been

subsequent reports of Enbridge purchasing property further south of the hatchery to avoid these issues but this puts the line even closer to North Roosevelt).

Stocking—Roosevelt is Brainerd DNR's number one muskie priority. The stocking level is 380 fish in the 9-12 inch (4 fish/lb) size. The larger fish are less prone to predation by herons, etc. The fish are expected to grow about 6 inches per year. They reach sexual maturity around 40 inches and then grow about 2 inches per year. Marc expects that it will be another 3-5 years before there is much muskie fishing on Roosevelt. Wall-eyes are stocked in odd numbered years. If fingerlings, they are stocked in the fall; if fry, they are stocked in the spring. There is a better survival rate for fingerlings. The rate is 390 lbs with about 20 fingerlings to the pound (i.e. 7500 to 8000 fingerlings per stocking).

FISH SURVEY—The next fish survey is scheduled for 2018.

LOCAL TROUT LAKES—

Allen—has good habitat for both brook and rainbow trout. It is stocked annually with a mix of 3300 brook and rainbow. The 2014 fall survey showed brook trout mainly in the 6 to 9 inch range but with fish up to 12.7 inches. The rainbows were mostly in the 10 to 12 inch range with the largest at 13.7 inches.

Snowshoe(Little Andrus)—The fall survey showed a low catch of brook trout, but they were large. The lake has been stocked with surplus brood stock (100 to 300/year) for last three years. If you want the big ones, Snowshoe is the place. In addition, Snowshoe is stocked in the fall with 3300 fingerling brook trout. This will be changed to spring yearling brook trout in 2016.

Margaret—The lake has good habitat for rainbow. A lake survey is planned for 2015. The lake sometimes winter kills.



## A Brief History of the CLT AIS Committee—by Ed Evans



The residents of Crooked Lake Township take the threat of AIS (Aquatic Invasive Species) contamination in the lakes of the Township very seriously. In 2012, the residents voted at the Annual Town Meeting to create a Crooked Lake Township AIS Committee to serve as a focal point for AIS programs in the Township. The CLT Town Board and both of the Local Lake Associations – RALALA (Roosevelt and Lawrence Area Lakes Association) and LWA (Lake Washburn Association) became and remain active members. The Committee serves as a sounding board to help organize AIS Programs involving everyone.

In 2012, Volunteers from the Lake Associations were stationed at the public landings on Washburn, Lawrence, and Roosevelt Lakes, handing out AIS literature to the boat owners and discussing the threat that these non-native species posed to our lakes. These volunteers were not actually allowed to inspect watercraft.

In 2013 and 2014, a real Watercraft Inspection Program was initiated at the public landings on the CLT lakes using DNR trained Level 1 Watercraft Inspectors that were employees of ERC (a Brainerd based Employment Agency). The Inspection program was administered by Crooked Lake Township (Lloyd Thyen) with help from the Lake Associations and the AIS Committee.

The Lake Associations paid for the Inspectors in 2013 and several DNR Inspection Grants awarded to the Township and the Cass County AIS Program paid the bill in 2014. AIS banner signs were purchased and posted in several locations in Outing to help educate the public and an AIS postcard was sent to property owners to remind them of the AIS risks.

The Watercraft Inspection Program is changing again in 2015, with the Cass County AIS Program now managing and paying for the Level 1 Watercraft Inspectors at the landings. Cass County receives its AIS funding from their share of the 10 million dollars the Minnesota State Legislature appropriated for distribution to Minnesota counties for AIS Programs in 2015.

Cass County also purchased a Decontamination Station (High Pressure – High Temperature Power Washer) to install in Crooked Lake Township to serve the local area and boat owners coming north on Highway 6 to help protect all the lakes in

Cass County and northern Minnesota. The Decon Unit will be installed and operated in the Town Hall/Fire Hall/Cannister Station area of Outing and stored here permanently. Cass is also hiring and managing the DNR Trained Level 2 Watercraft Inspectors needed to operate the Decontamination unit. It will be open and operational all summer, the current plan is on weekends and holidays.

In addition to these changes, RALALA has funded the installation of the I-LIDS Video monitoring system at the Roosevelt Highway 6 landing and the Lawrence Lake landing. All watercraft launches and retrievals from the lake are recorded and the images reviewed by experts. If weeds are shown in the images, tickets can be issued to the boat owner.

The AIS message is very clear in Crooked Lake Township. We are serious about protecting our lakes from AIS contamination.

It is stocked every spring with 600 yearling rainbows. It will likely be open to winter fishing in 2015.

Marion— The lake is good habitat for brook trout. A survey is planned for 2015. It also occasionally winter kills. It is stocked every spring with 660 yearling brook trout. It too will likely be opened to winter fishing this year.

INVASIVE SPECIES—(according to Marc and Dan Swanson, the Brainerd DNR specialist on invasive species).

Asian Carp—The closing of lock and dam # 1 in Minneapolis should thwart the migration of asian carp up the Mississippi and its tributaries. But baits and minnow transport will be an issue because asian carp minnows look a lot like fatheads. The DNR will also be experimenting with an electric barrier and a sonic barrier in SW Minnesota to thwart the migration of asian carp.

Zebra Mussels— Christmas and Independence lakes are experimenting with Zequanox and potash (KCl) to control zebras. An experiment in a confined area showed Zequanox is quite effective, but needs warm water and is quite expensive. Potash works in cold water but needs prior EPA approval for use. A potash slurry was injected through the ice in early winter. (See positive report on page 1, but note that this infestation of Zebra mussels was

detected quite early, and it will take five years with no sign of mussels before the lake is taken off the DNR infested lake list.). The zebra level in Mille Lacs has plateaued, albeit at a high level: Here are the actual counts showing just how explosive the growth rate for zebra mussels really is:

Emily Lake—For the past several years the DNR has been treating purple loosestrife in Emily using a special beetle. While monitoring the beetle damage to the loosestrife, the DNR also found Eurasian Milfoil that had likely been in the lake for 3-5 years. Treatment with aquatic herbicide is not possible because of the proximity of the milfoil to water lilies (a protected species). The lake association is using a mechanical harvester and hand pulling to get the roots. Because of low water quality in Emily Lake, Dan indicated that the milfoil will not grow too fast which should help with control.

Ruth Lake—There is also a 15-20 acre area of milfoil in Ruth. Dan indicated that the late spring was helpful in delaying the growth of the plant. Ruth Lake Association has a very active program headed up by Art Patterson. Dan indicated that about 10 acres have been treated with an aquatic herbicide. Art stated, however, that a significant area is not being addressed because the DNR has designated that area as a fish spawning area.

Washburn Lake—Dan said the Washburn Lake Association has been very proactive in attacking the milfoil that was found several years ago. The treatment involved aquatic herbicide and pulling remaining plants out by the roots using scuba divers. Now even lake association members have become accredited scuba divers in order to do some of the work. No plants were found for a couple of years after the initial treatments, however, last year the plant appeared again. A seven acre area was treated in August 2014 and is being monitored.

NOTE: Dan's opinion is that once a lake becomes infested with an invasive species, the modus operandi has to change from prevention to control because it is virtually impossible to totally eliminate the species once it has established a presence.

no sign of daffodils yet. There may not be much blooming this year as the plants are young, but this should improve every year.

Our annual Memorial Day plant and book sale will be from 9-3 on May 23rd and 24th. We welcome plants to sell and could use more volunteers to help an hour or two at the sale. lowed by a copper treatment of EarthTec QZ® in October and November. In December, a contractor working with the DNR injected 1,000 pounds of potassium chloride (potash) under the ice near the public boat access. It was only the third time potash was used for zebra mussel control in the United States.

“We are very pleased with the effectiveness of this multi-agency response to this infestation,” said Craig Dawson, Director of Research and Monitoring for MCWD. “It underscores the importance of early detection, which greatly improves the chances of eradication,

and partnerships will help expedite action.” “We appreciate the rapid and thorough response to the discovery of zebra mussels in Christmas Lake,” said Scott Zerby, Mayor of the City of Shorewood. “We hope to continue working together to protect this natural treasure and ensure these early indications of success are permanent.”

Beginning in May, MCWD staff and the DNR will conduct searches along the shoreline and in the lake and will place zebra mussel samplers at the Christmas Lake public boat access and at docks on the property of participating

homeowners. Extensive in-lake monitoring will be required over a period of years to determine whether zebra mussels were completely removed from the waterbody.

Zebra mussels are an invasive species that can crowd out native mussels and compete for food sources with other aquatic animals such as larval fish. They attach to boat hulls and other water-related equipment and can create a hazard for swimmers due to their sharp shells.
