Milfoil Update-Lawrence/Leavitt/Smokey Hollow—by Bob

I am happy to report that we received good news from the Eurasian Water Milfoil survey that our contractor, PLM, did on Lawrence, Leavitt and Smokey Hollow Lakes. The surveyors completed this project on August 28th when any milfoil plants would still have been growing and easily spotted. All three surveys came back with "no Eurasian Water Milfoil present"!

The lead surveyor made the following observations:

1. Lawrence Lake has a lot of Northern Milfoil, Coontail and floating leaf vegetation. Considering the channel between Lawrence and Roosevelt, I would continue to survey and have landowners report anything suspicious. Much like Roosevelt, there is a relatively steep

drop off but the lake could still support an EWM infestation.

2. Leavitt appeared similar to Lawrence. Considering the proximity to other infested lakes, I would continue to survey annually and have landowners report anything suspicious.

3. Smokey Hollow is very tea stained and has little submersed vegetation. Watershield and Water Lilies appear to thrive. An EWM infestation is possible, but would not do well considering the low light. Surveys are optional.

On the basis of these observations, the Board authorized our President to negotiate an arrangement for surveying these lakes on a regular basis.

Please contact us if you have questions and be sure to call us if you spot anything suspicious on these lakes. .

Watersheds and the Community —by Darril Wegscheid

A "raindrop" view of our continent might be that "wherever rain falls", it is into a basin on the planet. That rain drop might soak into the ground, but with enough drops, the water will flow. If there were so much water, any pond or lake would in theory "overflow" and continue to move towards the ocean. The edges or perimeters of the area that would flow to the same outlet comprise a "watershed".

On our RALALA waters, as well as Morrison Lake and other smaller waters, we are in the minor watershed known as the "Crooked Creek Watershed". That in turn is part of the larger "Daggett Brook Watershed", which in turn is part of the Pine River Watershed, and

that is part of the Upper Mississippi Watershed, etc. Lake Washburn is in a separate minor watershed, which joins us to form the Daggett Brook Watershed. The Emily area (Ruth Mary, Emily Lakes) are in the "Little Pine River Watershed" which also joins into the "Pine River Watershed" south of Cross Lake.

Watersheds are critical to water management. What happens to water on the land affects its condition and whether it reaches a wetland, creek, river or lake – and eventually the ocean. Forests, cultivated fields and gardens, roads and roadsides, lawns, playgrounds, trails, parking lots and the other varied

surface areas of the watershed can all affect the water quality. Underground water reservoirs can be "recharged" by the surface waters, and they can also release water into the flowages.

Thus, a watershed view of our wonderful area is a very useful tool to help manage our waters – by managing the activities and condition that affect water. For example, trees shelter the ground, and keep it cooler. Thus, we would normally like trees as helpful to water quality. Grasses help control soils and provide some isolation from heat. Soils eroding into streams and lakes are normally a detriment.

Barren land, especially inclined surfaces, can more easily be eroded and washed into creeks, rivers, and lakes. Thus, buffers along the edges that “control” any run-off into wetlands and prevent direct discharge to lakes or streams are desirable. Plantings in these buffers that have strong roots and resilient structures, along with good coverage can assist the effectiveness of soil protection.

The Pine River Watershed Alliance (PRWA - www.prwa.us) is proceeding, with the collaboration of Cass and Crow Wing Counties and the MN Board of Water and Soil Resources (BWSR), to prepare a

“One Watershed One Plan” (1W1P) framework. Once adopted, this would assist local activities in addressing elements in the watershed that we can protect, enhance and preserve. The plan is being developed “upward from the local level” so that activities are based on the real world, not from some “think tank” somewhere removed from the sites. It is expected to be a major factor in distributing public funds to local needs.

Our area is participating, with a horizon for completion of the draft plan during 2019, and adoption of a final plan by the Counties before the end of 2019. Your ideas are solicited and will be valued.

Please consider aspects of our

watershed that you believe are most valuable for the success of our community and the surroundings.

a variety of speakers on relevant topics and lively discussions about how our waters are affected by the environment around us.


