Currently 70 newsletters are mailed and 270 are sent electronically. Two were returned from non-members.

There will be some investigation into looking at covering the Big Foot celebration in Remer.

Darril Wegscheid is looking for more brochures. Bob Lee says a lot of the old brochure ares obsolete and he will send a new one to the board for approval. John Rowell motioned for reprint the brochures with changes, Jackie Evans seconded. They will print as many as the last order. Approved.

Discussion about suggestions from Dave Lawson for raising money for milfoil treatment.

Fall newsletter—Bob Lee is looking for articles. John Rowell will send an annual donation thank you. and a final year end financial report. Gary Langer suggested that it needs to include where all the money was spent.

Bob Lee has started talking to people about getting a LID

In a discussion of the Crooked Lake Township AIS committee, Gary Langer said there is an initiative from the AIS group to propose an additional \$10,000 (CLT provides \$5000 to the group every year.) This year they spent \$4000. Bob Lee will add this to the newsletter as well as information about getting new board members. Gary Langer thinks every board member should have a responsibility for an initiative.

John Rowell motioned for adjournment, Mikie Walker seconded. Approved.
