I. Registration Fees (Non-Refundable)

All registration fees are **non-refundable** and must be paid in full by the first day of school.

III. Tuition Supplement and Fundraising Requirement (\$700.00)

Each family is responsible for a Tuition Supplement/Fundraising obligation of **\$700.00 per family**. This may be fulfilled through participation in designated fundraisers or by selecting the buy-out option.

A. Fundraising Requirement

Total Fundraising Obligation: **\$700.00 per family**, consisting of:

- Buy or sell a minimum of 25 Bishop Golf Car Raffle Tickets at \$10 per ticket – \$200
- Buy or sell a minimum of 4 Cumbia Night Tickets – \$150
- Buy or sell a minimum of 15 SummerFest Tickets at \$10 per ticket – \$150
- Buy or sell a minimum of SummerFest Ride Tickets totaling \$200

Buy-Out Option: \$700.00 per family

- \$250 must be paid by the end of Trimester 1
- \$250 must be paid by the end of Trimester 2
- \$200 must be paid by May 1, 2027

IV. Parent Involvement Participation (PIP) Hours

Each family is required to complete **30 PIP hours** per year or will be billed **\$30 per hour** for hours not completed.

- One-third of PIP hours must be completed by the end of each trimester.
- **PIP Buy-Out Option:** \$900.00 per family
 - One-third must be paid by the end of Trimester 1
 - One-third must be paid by the end of Trimester 2
 - Final third must be paid by May 1, 2027

V. Tuition Policy

1. Tuition rates are determined on a **family basis**. A “family” is defined as individuals residing permanently at the same address where the responsible party has full custody and/or guardianship of the student(s).
2. Grandchildren, cousins, and step-children residing at separate addresses, or registered under separate families, are not eligible for the family/sibling rate.
3. FACTS Management Company will process all tuition and incidental billing for the school.
4. All payments must be made through the FACTS Payment Management System.
5. Tuition is due on the 1st or 10th of each month, depending on the date selected in FACTS.
6. A **\$25 late fee** will be assessed for failure to pay on time.
7. **Failure to pay two months in succession will result in suspension of the tuition agreement, and the student will not be allowed to return to class until the account is current.**
8. All fees and balances from the previous year must be paid in full before a family can register for the new school year.

B. Other Fees

- \$65 – Third Grade Sacramental Preparation Fee
- \$100 – 8th Grade Graduation Fee
- \$50 – Kindergarten Graduation Fee
- \$25 – Late Fee
- \$35 – Returned/Declined Payment Fee (waived only in cases of school error)
- \$30 – “No Show” Fee for failure to show up or work a shift at a major school event (SummerFest Carnival, Fireworks Booth Fundraiser, Sunday Food Sales, etc.)

IX. Refund Policy

- If a student withdraws or is dismissed, the following policies apply:
- **No Refunds on:**
- Registration fees
- Technology fees
- Tuition if the student leaves after the 15th of the month
- Late fees, returned check fees, or declined card payment fees (except when caused by school error)

Refunds:

- If a student withdraws or is dismissed **before** the 15th of the month, a prorated refund on tuition will be issued.
