- f. Uniform Code of Military Justice (UCMJ, 2019)
- g. Army Regulation 623-3 (Evaluation Reporting System, 14 Jun 19)
- h. Army Regulation 15-6 (Procedures for Administrative Investigations and Boards of Officers, 1 Apr 16)
- 2. Currently, the 1st Mission Support Command (1st MSC) does not have an assigned Commanding General Officer authorized to approve or disapprove legal actions emerging from the 1st MSC, which by regulation require the ratification or consideration of a General Officer to dispose of the legal action. In accordance with RCM 306, UCMJ, as General Court-Martial Convening Authority, I may delegate certain disposition authorities or retain the authority to withhold authority in individual cases, types of cases, or generally. Therefore and effective immediately, I delegate to the Commanding General (CG), 81st Readiness Division, all authorities listed below in this memorandum.
- a. Administrative Separation Boards. I delegate authority to the CG, 81st Readiness Division (RD) to initiate and convene show cause boards for officers per AR 135-175

SUBJECT: Delegation of Authority to Commanding General, 81st Readiness Division, to act on Behalf of 1st Mission Support Command for All Matters Requiring Consideration and/or Ratification by a General Officer

and AR 600-8-24 and convene enlisted separation boards per AR 135-178 and AR 635-200, on behalf of the 1st MSC. After approval of board findings, those packets will continue routing to this headquarters, for either final disposition or recommendation as to disposition, as prescribed by regulation.

- b. Enlisted Separation Actions. I delegate authority to the CG, 81st RD, to approve or disapprove administrative separation actions involving enlisted Soldiers assigned to the 1st MSC or its subordinate units, which require ratification by a General Officer as part of the final disposition.
- c. Permanent Filling of Reprimands. In accordance with AR 600-37, paragraph 3-5b, I delegate authority to the CG, 81st RD, to consider non-punitive administrative memoranda of reprimand, admonition, or censure, which may be considered for a potential permanent filing of the reprimand in the Army Military Human Resource Records (AMHRR) of all military personnel assigned to the 1st MSC and its subordinate units.
- d. Other Administrative Actions. I delegate authority to the CG, 81st RD to consider all other administrative legal actions involving the 1st MSC and its subordinate units personnel, which require by regulation the consideration or ratification of a General Officer for final disposition of the action. These actions include, but are not limited to, initial disposition authority for violations of Article 120 of the UCMJ, necessary FLIPL authorities, relief for cause, and any other legal or administrative actions within the 1st MSC requiring decision or ratification by a General Officer to dispose or processing of the legal action as mandated by regulation.
- 3. This is a temporary delegation of authority limited to decision and ratification actions of the CG of 81st RD as it pertains to the specific delegation authority and does not create any other relationship between the 1st MSC's staff and 81st RD's staff. This delegation of authority is effective the date of this memorandum and will be rescinded upon the date a General Officer assumes command over the 1st MSC.

- 5. IAW AR 600-85, para 16-8a(3) administrative separation must be initiated and processed to the separation authority for decision on any Soldier with a positive drug test that could not have resulted from legitimate medical use of a drug. Accordingly, separation / elimination proceedings are being initiated IAW the Army regulation identified above. You will be flagged IAW AR 600-8-2 and all favorable personnel actions suspended while your adverse administrative action is pending. Additionally, notice to DoD CAF will be made via DA Form 5248-R and an incident report entered in the Joint Personnel Adjudication System (JPAS), potentially resulting in an adverse impact to your security clearance eligibility. Lastly, IAW 18 USC 922(g)(3), divestiture of any personally owned firearms or ammunition for one (1) year from the date the drug offense was discovered (positive urinalysis) is mandatory. A copy of Army EXORD 240-18 as well as a Frequently Asked Questions (FAQ) handout about this mandatory divestiture as required by 18 USC 922(g)(3) is attached to this counseling. 
