Subject: Notice of Upcoming Sewage Rate Increase for 2025

Dear Residential and Commercial Customers

We are writing to inform you of an important update regarding your sewage service with West Mifflin Sanitary Sewer & Stormwater Authority (WMSSSA). Due to rising operational and maintenance costs, we will be implementing an adjustment to our sewage rates, effective January 1, 2025.

Why is this increase necessary?

As part of our ongoing commitment to providing safe and reliable sewage services, we must continuously invest in the maintenance and upgrade of our infrastructure. The increase in sewage rates will help us cover essential costs, including:

- Repairs and upgrades to aging sewage systems.
- Increased regulatory compliance requirements.
- The rising costs of materials, labor, and energy.
- Ensuring the continued quality and safety of the sewage treatment process.

We understand that rate increases can be an inconvenience, and we have worked diligently to first reduce costs internally to minimize the impact on our customers. Additionally, WMSSSA has not increased its rates in six years. However, this adjustment is necessary to maintain the high standard of service that you rely on.

What does this mean to you?

- The new sewage rates will take effect starting Jan 1, 2025.
- Residential Monthly Service Charges will increase by \$1.00 and Commercial by \$1.50.
- Residential and Commercial Usage Charge will increase by 6%.
- Example of monthly change:

Residential usage bill of 3000 gallon:

2024 - Monthly service charge 19.00 + (3000 gallons x 0.858) = total bill 44.742025 - Monthly service charge 20.00 + (3000 gallons x 0.909) = total bill 47.27
