Deyla Robles and Angela Connell further reported on the 2017-18 accomplishments which included pool improvements (Power wash deck, bathroom repairs, new chairs), m eeting room air conditioning repair, mulch added to playgrounds, new swings, tree trimmed over playground, and community events. The 2018-19 goals include continued community events, fire station rehab.

Election of Directors was then conducted. The following nominations were made: Deyla Robles, Anthony Duran, John Cekar, Dan Malone, Liliana Gamba, Jason McKinney and Cesar Lopez. Each candidate was given an opportunity to speak to the owners present. After tabulation of the votes, Angela Connell announced the new Board of Directors included Deyla Robles, John Cekar and Cesar Lopez.

An owner forum was held with items discussed relating to the association, pool bathrooms, landscaping, Firestation, and deed restriction enforcement.
