
Industry Update



EXECUTIVE SUMMARY

As of May 2025, the mechanical contracting industry is navigating a complex landscape shaped by both chronic challenges and emerging opportunities. A persistent headwind in the industry is the ongoing skilled labor shortage, with the industry averaging nearly 400,000 job openings per month — a trend that has continued for the past three years. This labor shortage affects both field workers and leadership roles, leading to project delays and increased labor costs. Additionally, rising material costs and supply chain disruptions continue to pressure profit margins, with construction costs expected to increase through 2025.

Despite these challenges, several macro trends are propelling the industry forward. A declining rate of inflation and a 75-basis-point reduction in interest rates since September 2024 have lowered borrowing costs, encouraging investment in new facilities, upgrades, and expansions. Government infrastructure projects, particularly those funded by the Bipartisan Infrastructure Law, continue to proceed, with 18% of surveyed contractors reporting work on such projects — double the percentage from the previous year. Moreover, the increasing demand for large-scale AI data centers favors those operators with the ability to handle large-scale, highly technical projects.

M&A activity in the mechanical contracting sector has been robust, driven by the need for scale, technological capabilities, and skilled labor. Emcor Group has continued its aggressive acquisition strategy, completing its acquisition of Jacksonville, FL based Miller Electric Company in February 2025 for \$856 million. Similarly, multiple financial sponsor buyers have engaged in a buy-and-build strategy, creating regional and national platforms in the mechanical contracting space. These moves reflect a broader industry trend where companies are leveraging M&A to access new markets, enhance capabilities, and drive growth.

Looking ahead, mechanical contractors have several avenues for growth. The increasing demand for sustainable and energy-efficient building solutions presents opportunities in green construction practices, such as the installation of energy-efficient HVAC systems and the use of sustainable materials. The integration of digital technologies, including AI and data analytics, is expected to further transform project management and execution, enabling more accurate cost estimates, real-time adjustments, and proactive risk assessments. Additionally, firms that invest in workforce development through apprenticeships, training programs, and partnerships with educational institutions will be better positioned to address labor shortages and meet the evolving demands of the industry.

INDUSTRY TRENDS & UPDATES

Mechanical contractors continue to play a crucial role in the construction ecosystem, providing the design, installation, and maintenance of critical building systems such as HVAC, plumbing, refrigeration, and fire protection. As buildings grow more complex and energy-efficient, the demand for specialized mechanical expertise has grown accordingly. These systems are not only vital to operational functionality but also heavily influence energy usage, indoor air quality, and regulatory compliance — factors that have risen in priority across sectors from healthcare and education to data centers and advanced manufacturing. As a result, mechanical contractors are increasingly seen as value-added partners rather than rapid-response emergency contractors, particularly on large-scale or technically demanding projects.

Over the past three years, several macroeconomic and policy trends have driven significant growth in the mechanical contracting sector. First, post-pandemic infrastructure stimulus—particularly from the Bipartisan Infrastructure Law, the CHIPS Act, and the Inflation Reduction Act—has spurred a wave of federal, state, and private investment into infrastructure, clean energy, and semiconductor facilities. These large, capital-intensive projects almost always require advanced mechanical systems, creating strong demand for contractors with the scale and skill to execute at high volume. Simultaneously, persistent labor shortages have accelerated the push for prefabrication and modular construction — areas where many mechanical contractors have made significant investments to improve efficiency and reduce schedule risk.

Another major growth factor has been the sharp increase in construction of mission-critical facilities like Alenabled data centers, modern manufacturing plants, and life sciences campuses. These facilities require sophisticated MEP+ (mechanical, electrical, and plumbing) solutions that can support high-density equipment, meet tight environmental standards, and operate with redundant safety measures. Mechanical contractors with expertise in design-build delivery and the ability to execute under fast-track conditions have benefited immensely. Additionally, the rising emphasis on sustainability and decarbonization has pushed property owners to retrofit existing systems and adopt high-efficiency HVAC technologies — further boosting service revenue for contractors who offer sustainable, energy-focused solutions.

Looking ahead to the second half of 2025, the industry remains optimistic about continued growth and profitability. Stabilized interest rates following the most recent cuts in January 2025 have allowed for more consistent borrowing costs, improving construction financing conditions. Firms anticipate continued strong demand in sectors like healthcare, semiconductors, warehousing, and clean energy, where both public funding and private capital are driving new builds and facility upgrades. Furthermore, industry consolidation is expected to continue, with both strategic buyers and private equity pursuing M&A opportunities to gain geographic scale, workforce capabilities, and advanced prefabrication capacity. This consolidation trend is likely to drive valuation premiums for firms with a strong backlog, recurring service revenue, and an established reputation for quality and safety.

However, risks remain. Skilled labor availability is a persistent challenge, especially for field supervisors, pipefitters, and welders. Firms that invest in training, apprenticeships, and technology adoption will be better positioned to manage labor constraints while maintaining margin. Additionally, supply chain volatility and material inflation — though stabilizing — could resurface as global demand for building materials and energy infrastructure increases. Still, the industry outlook through the end of the year remains solid, supported by high demand in critical sectors, a robust project pipeline, and strong fundamentals for well-run mechanical contracting firms.

APi Group Corporation has seen steady growth driven by a focus on safety and specialty services, including fire protection and HVAC systems. Recent strategic acquisitions have expanded its service offerings and geographic reach, positioning it well in the infrastructure and industrial sectors. Analysts maintain a positive outlook, citing APi's diversified portfolio and consistent revenue streams as strengths.



Comfort Systems USA has benefited from the surge in data center construction, providing specialized HVAC solutions critical for cooling high-density computing environments. The company's modular delivery business accounts for 17% of operations, reflecting its adaptability to market demands. Analysts are optimistic and expect continued earnings growth into 2025.



Emcor Group has outperformed peers, attributed to its diversified market presence and strong backlog in high-growth sectors like data centers and advanced manufacturing. The acquisition of Miller Electric has further enhanced its capabilities in the Southeastern U.S., aligning with the company's strategic expansion plans.



Johnson Controls International faces mixed sentiments, related to downgraded EPS forecasts and anticipated revenue declines. Industry analysts expect a rebound in 2025 driven by demand for energy-efficient building solutions.



Limbach Holdings Inc (LMB) has reported record gross profit and net income, focusing on ownerdirect relationships and services for existing facilities. This strategic shift has led to increased demand across sectors like healthcare and data centers.



M&A CASE STUDY: LIMBACH HOLDINGS ACQUIRES CONSOLIDATED MECHANICAL

Transaction Overview

- On December 2, 2024, Limbach Holdings (NYSE: LMB) ("Limbach") completed its acquisition of Consolidated Mechanical, Inc. ("CMI").
- Limbach acquired CMI for total consideration of \$23.0 MM at closing in an all-cash deal, funded from cash-on-hand, and includes a performance based, contingent earnout totaling \$2.0 MM, potentially payable over 2026 – 2027.
- Total consideration paid by Limbach could reach \$25.0 MM if earn-out targets are achieved.

- CMI provides a wide range of specialty mechanical services to a customer base across the US, as well as specializing in plant maintenance and support and providing a fullservice ASME-certified UA fabrication facility.

Limbach Overview

Limbach Strategic Rationale



The acquisition allows Limbach to expand its range of services to include CMI's expertise in mechanical, millwright, steel fabrication, plumbing construction, maintenance, and outage services for complex industrial systems.



CMI's presence in Kentucky, Illinois, and Michigan, and its satellite office in Western Michigan, expanded Limbach's geographic reach, allowing improved service to customers in those regions.



Limbach anticipates CMI to contribute significant revenue and EBITDA in 2025, further bolstering Limbach's financial performance going forward.



2025 M&A UPDATE

In 2023 and 2024, the US economy benefited from a rare confluence of supportive fundamentals including strong income growth, resilient private sector balance sheets, expansive fiscal policy and notable gains in productivity. These forces helped position the US as a global growth leader and gradually fueled investor confidence with dealmaking activity rebounding in 2024 following two years of contraction.

2025 M&A activity showed early signs of continuing that improved trend, but has experienced a noticeable slowdown during the first five months of the year, with deal volume declining by approximately 30% compared to the same period in 2024. This downturn is attributed to a combination of economic, political, and regulatory factors that have collectively dampened corporate enthusiasm for dealmaking. Although the number of announced deals in Q1 did decrease year-over-year, the total aggregate deal value remained consistent at \$482 billion, compared to \$484 billion a year earlier. This trend has continued into Q2, with fewer deals but sustained high-value transactions. Private credit funds have also emerged as an alternative option to traditional corporate and private equity buyers, reshaping corporate lending and attracting significant investor interest. Should investor appetite for syndicated debt continue to weaken due to broader economic uncertainty, private credit funds could see significant deployment opportunities in both sponsor-backed and opportunistic lending.

Despite early challenges, the broader M&A market has shown signs of resilience. Goldman Sachs reported a 30% rise in large deals (over \$500 million) year-to-date, indicating a robust pipeline of deals coming to market. M&A professionals remain cautiously optimistic, anticipating a strong rebound in deal activity in the latter half of the year across industries and company size, contingent on economic stabilization and resolution of trade tensions. As we continue to navigate these choppy waters, opportunistic buyers are actively searching for high-quality assets that are often overlooked in a gloomy environment.
