- Option 1 Full cost to stay in current website \$1,000-\$2,500
- Option 2 Redesign under new web press format ITRE currently uses
- Option 3 Relocate to another website

Go Daddy – would charge \$300 to host

If E-Commerce is offered in purchase of new website location, need to move away from ITRE. This would allow us to sale merchandise. \$4,000 is high for static website Domain and website would be housed in one place if we go with Go Daddy Go Daddy may have online support- 1 point of contact-changes can be made by NCPTA board members or designee Currently, ITRE require NC State credentials to make changes, Brian McClung made a motion to move forward with it.

Some counties have indefinite stay at home orders

Right of termination clause will be used moving forward with future contracts.

## DPI Updates:

Due to the conference being cancelled, DPI need to come up with a plan to address LEA need for remote learning opportunities.

DMV will need to think about offering classroom training in a different way

Senate and House are addressing this issue by extending expiration dates for DL renewals.

Over the next couple of months, we expect to see stay at home orders relaxed and possibly start reducing the number of people trained at one time.

During summer visits, DPI will look at testing strategies.

In place of summer conference, entertain Zoom options for training.

LEA's and vendors will be contacted regarding concerns.
