RATES- MATERIAL HANDLING(shipments)

• Advance material handling costs are incurred when we receive your freight in our warehouse or on show-site and deliver your freight to your booth. Minimum rates apply for shipments under 199 lbs; 200 lbs plus, the fee is based on every 100 lbs & increments.

(This service also includes removing your empties from the show floor, returning your empties at the close of the show and loading your freight on your outbound carrier from the show-site).

• **Return to warehouse charges** apply if we are required to bring your freight back to our warehouse at the close of the show. Minimum rates apply for shipments under 199 lbs; 200 lbs plus, the fee is based on every 100 lbs & increments.

• Please note: Exhibitors are responsible for arranging pick-up of their own freight at the close of the show either from the show floor or from our warehouse and for making customs arrangements. Please provide Legault Companies with complete pick-up information. Freight must be removed from our warehouse within 5 days. Beginning day 6, daily storage fees of \$100 + tax will be charged.
