

#### The Lord's Prayer

"Thou to the mercy seat our souls doth gather, to do our duty unto thee—OUR FATHER, to whom all praises, all honor should be given. For thou art the great God—WHO ART IN HEAVEN, thou, by thy wisdom, rules the world's whole fame, forever, therefore—HALLOWED BE THY NAME. Let nevermore delay divide us from Thy glorious face, but let--THY KINGDOM COME, let thy commands opposed be by none. By thy good pleasures and--THY WILL BE DONE. And let our promptness to obey be given the very same---IN EARTH AS 'TIS IN HEAVEN. Then for our souls, O Lord, we also pray.

Thou wouldest be pleased to---GIVE US THIS DAY the food of life, wherewith our souls are fed, sufficient raiment, and---OUR DAILY BREAD; with every needful thing do thou relieve us, And of they mercy, pity---AND FORGIVE US all our misdeeds, for Him whom thou didst please to make an offering, for---OUR TRESPASES. And forasmuch, O Lord, as we believe that thou wilt pardon us---AS WE FORGIVE. Let that love teach, wherewith thou dost acquaint us, to pardon all---WHO TRESPASS AGAINST US.

#### A Update from the Virginia Flaggers - A New Roadside Flag



This morning, after extensive weather and construction delays, but in God's perfect timing, we quietly raised a 10'x 15' Confederate battle flag on a 50' pole in Petersburg, Virginia. Dedicated to the glory of God, and in memory and honor of all of our Confederate dead, this site was dedicated in particular to honor Gen A. P. Hill, who was mortally wounded nearby.

The landowner contacted us shortly after the city of Petersburg voted to change the name of nearby A P Hill Elementary School, furious at those who chose to dishonor our veterans and attempt to rewrite Petersburg's rich Confederate history and heritage.

The Petersburg Boydton Plank Rd. Gen AP Hill Memorial Battle Flag is the 29th flag raised by the Va Flaggers in the Commonwealth since the fall of 2013, and like those raised before her, will fly as a 24/7 reminder that there are still those of us who will not go quietly into the night in the face of vicious and hateful attacks on our history, our heritage, and the men who bravely fought to defend the Commonwealth from invasion.

A formal dedication ceremony is planned for later this fall.



Jack Hinson The Lone Avenger by Jack Bowen



It is often interesting to find that when you research one story you somehow come across another story that is even more interesting. The story of Jack Hinson starts in 1862.

John W. "Jack" Hinson, better known as "Old Jack," to his family owned a large prosperous plantation along the Kentucky-Tennessee border, known as Bubbling Springs in Stewart County. The War had been raging for two years, but somehow Hinson had managed to remain neutral, friendly to enlisted men and officers on both sides of the battle, even when one of his sons joined the Confederate Army and another joined a militia group.

After Ft Donelson fell to the Union, guerrilla attacks on Union soldiers and supporters increased and as a result it became policy to torture and execute any suspected bushwhackers without trial.

One late fall day two of Hinson's sons-George, age 22; and John, age 17, went deer hunting about a mile from their home as they so often did. Unfortunately, they came across a Union patrol who suspected them of being bushwhackers. The two boys were tied to a tree then shot, after which their bodies were dragged back to town. There the corpses were paraded around the Dover courthouse as an example of the Union's zero-tolerance policy toward resistance. The remains were then decapitated and left there, while the heads were brought to the Hinson plantation and placed on the gate-posts of the front yard as a warning to other members of the family.

Jack Hinson was understandably shocked and outraged. After all, hadn't the Union General himself, Ulysses S. Grant, once visited Hinson's plantation as a guest? Whatever kindness Hinson may have felt toward the North instantly and completely evaporated—he swore revenge. But Hinson, being an older man, did not hastily run off to join the Confederate Army. Instead, he conceived a more calculated plan; one that would ultimately result in the deaths of many Union soldiers and sailors and had hundreds of federal troops eventually hunting him. Of Scottish-Irish descent, Jack could not let the murders of his sons go unpunished. He buried his children's remains, then sent the rest of his family and slaves to West Tennessee to stay with relatives.

Hinson then commissioned a special rifle, built by a local blacksmith. A .50 caliber rifle, percussion -cap muzzle loader. Besides its lack of decorative brass ornamentation and weight of 18 pounds were intentional. The long, heavy octagonal barrel with a length of 41", would make the gun an excellent long-range sniper rifle, and the plainness of the rifle would aid in its camouflage.

#### Jack Hinson-The Lone Avenger, continued

As to the octagonal shape, it was based on the Whitworth Rifle. With its hexagonal barrel, it could shoot farther (2,000 yards) and more accurately than the Pattern 1853 Enfield (1,400 yards) with its traditional round rifled barrel.

The first victim of jack Hinson's new rifle was the lieutenant of the patrol that had killed Hinson's two sons. Hinson shot him from ambush while the lieutenant was riding horseback at the head of a column. Several months later, Hinson's second victim was the soldier who had placed Hinson's sons' heads on the plantation gateposts.

Moving into a cave above the Tennessee River, Jack became a bushwhacker at the age of 57.

The Tennessee and Cumberland rivers were major transport hubs, so Hinson frequented both. From his higher vantage points, he targeted Union boats, picking off captains and officers, as well as disrupting the flow of river traffic. Resting his heavy rifle on a rock or tree limb he would shoot men 500 or more years away. An excellent marksman, he used only open sights and tallied more than 100 kills (31 circles were cut in the barrel of his rifle to mark the number of Union officers he killed).

Hinson's shooting was so accurate that one boat even stopped in mid-stream, dropped anchor, and surrendered to Hinson by running a white tablecloth up the signal mast. It was the first and only time in military history that an entire boat surrendered to a single man. When Hinson saw the white flag, he ceased fire, but had no idea what to do next. Neither did the boat captain. The boat remained motionless in the river for a time, but when no Confederate soldiers swarmed from the woods to take command, the captain eventually ordered the anchor raised and the ship to move on. The incident was one of the strangest of the War Between the States.

Though he remained apolitical, he began helping the Confederate Army. In November 1864, for example he guided Lieutenant General Nathan Bedford Forrest to Johnsonville to attack its Union supply center.

Jack Hinson's famous custom-made muzzle loading sniper rifle still exists. After passing through some half-dozen hands through the years, it is today owned by Judge Ben Hall McFarlin of Murfreesboro, Tennessee.

"Captain" Jack Hinson died on 28 April 1874 and lies buried in the family plot in Cane Creek Cemetery. Today, the region where Bubbling Springs plantation once stood is part of Land Between the Lakes National Recreation Area.

#### The "Grape Shot" Revolver by Jack Bowen



Of all the revolvers identified with the Confederacy none attained the fame of the Le Mat, or "Grape Shot" revolver. While it lacked the simple mechanism and wearing qualities of the Colt, the criterion by which all the war revolvers were judged, the Le Mat was an ingenious and effective weapon and won instant popularity in the South.

The inventor of the Le Mat was Dr. Jean Alexander Francois Le Mat, a physician of New Orleans, who was an inventive genius. He was granted a patent by the United States on October 21, 1856 for his revolver but apparently none were made until the outbreak of the war. He was given a contract by the Confederate government for 5,000 of his revolvers.

Being unable to get the necessary machinery in the South, Le Mat took passage on the Trent, the same vessel which carried Mason and Slidell. Going to Paris, he began the manufacture of his 10-shot revolvers. Toward the latter part of the war, he entered into partnership with C. Girard, and evidence shows a branch factory was opened in England.

The Le Mat revolver contained a cylinder with chambers for nine ball cartridges of 42-caliber, the cylinder revolving on a center barrel shooting a 66-caliber grapeshot cartridge, all fired by percussion caps. After the war, the manufacture of Le Mat revolvers using metallic cartridges was carried on, but there is no evidence to show that they were made until after the close of the war.

The first of the Le Mat revolvers received in the Confederacy were presented to officers of high rank. In the Confederate Museum at Richmond are Le Mat revolvers used by Gen. J.E.B. Stuart, Gen. P.G.T. Beauregard, Gen. Patton Anderson, and others. How many of the weapons were made is uncertain, but a checkup of the specimens in public museums and private collections failed to show any with a serial number above 4,000, which would indicate the total number made did not exceed that.

Details of the Le Mat mechanism were changed frequently, and of half a dozen Le Mat weapons picked at random hardly more than two will be found alike. The marking also was changed. First, they were stamped on the barrel: "Le Mat's Patent," then "Col. Le Mat, Paris;" next, "Syst. Le Mat, Paris," and finally "Le Mat & Girard Patent." The last mentioned made in London.

Col. Payne's record book shows four cases of Le Mat revolvers received June 16, five boxes received May 16, and four cases received July 27, 1864. Delivery of the revolvers must have begun early in the war; however, for the Richmond Whig of December 4, 1862, contains this advertisement:

#### Le Mat Revolvers

#### The Witworth Rifle by Jack Bowen



The Whitworth rifle was made in England and was imported by the Ordnance Bureau of the Confederate States at a cost of about \$1,000, in the equivalent of gold, for each rifle and one thousand rounds of ammunition. A telescope, about ten inches long, fitted with lenses of great power and exquisite finish, could be instantly hinged upon the breech end of the barrel, the eye piece adjusted to be at the proper distance from the left eye of the rifleman.

The front, or object glass end of the telescope, was furnished with an arc sliding easily, but close, in a guide-piece fastened upon the barrel of the rifle. The axis of the telescope and that of the rifle barrel were exactly parallel in vertical line whatever the elevation of the muzzle; the aim was always made by sighting through the glass.

The cartridge was made with great care; the bullets of compressed lead, one and a half inches long, and of precisely uniform weight; the grains somewhat coarse, of uniform size finely glazed; the cartridge wrapped in parchment and coated with paraffine.

The men drilled in camp, and on the march, and even on the field of battle, in judging distances. They would be halted, for instance, and required to guess at the distance of a certain point ahead and then measure by steps on their way. When firing, these men were never in haste; the distance of a line of men, of a horse, an artillery ammunition chest, was carefully decided upon, the telescope adjusted along its arc to give the proper elevation; the rifle rested against a tree, across a log, or in the fork of the rest-stick carried for the purpose. The terrible effect of such weapons inn the hands of men who had been selected, one only from each infantry brigade, because of his special merit as a soldier and skill as a marksman, can be imagined. They sent these bullets fatally 1200 yards and were unpleasant a mile off.

The first organization of Whitworth Sharpshooters was that of Cleburne's division at Wartrace, in 1863; afterward a corps comprising all the Whitworth Rifles in Bragg's army was organized near Chattanooga and did service until the end of the War. The third organization was made at Meridian, in the army of Gen. Johnston, afterward known as the Army of Mississippi, and after the death of Gen. Polk, as Stewart's Corps of the Army of Tennessee.

During your stay feel free to visit the local Confederate Cemetery, the largest west of the Mississippi. Come walk where Bowie, Travis, Crockett, DeZavala, Muguara, Ford, Lee, Maverick, Longstreet, Hood, Thompson, Fisher, Roosevelt and many others walked. As Rip Ford once said, "come to San Antonio if you have the nerve".

Here are the rules: Participating Camps will send a \$5 entry fee donation to our Camp Commander at address below payable to the Alamo City Guards. These entry fees will all go to support the Heroes Dinner. Participating Camps will select 3 members (no spouses or friends) to represent their Camp. Once selected they can not be changed. The names of the participating members are not necessary, just the weights. Each Camp will provide their starting weights (eg, Camp 1325: #1-220, #2-250, #3-300 = total 770) on Aug 1, Sept 1, Oct 1 and again finally on Nov 1. The Camp with the greatest total loss of pounds will be declared the winner. Our Camp will publish the monthly progress results to the Division for distribution and will place them on our website and Facebook pages.
