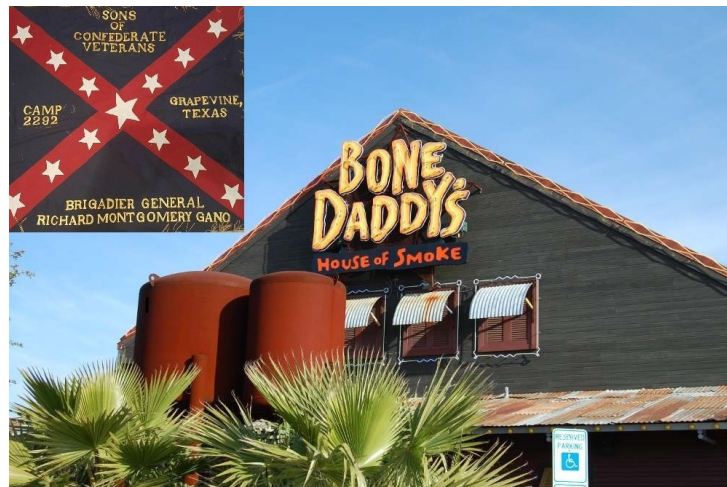

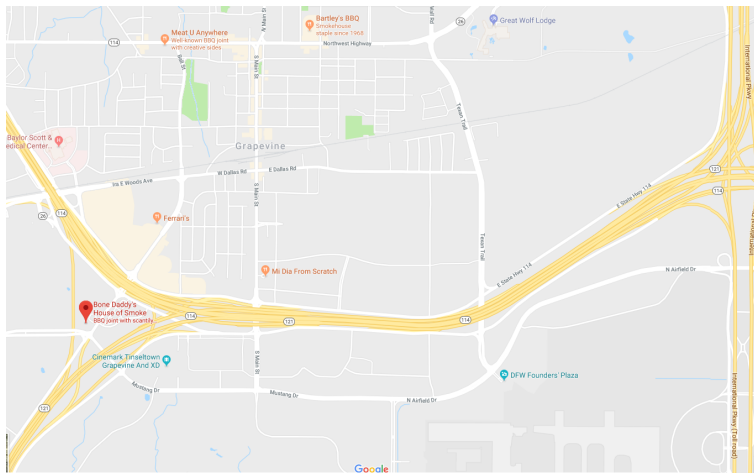
**This will be a great meeting with great friends of like mind. Bring someone and enjoy the great food.**

This month's speaker is Robert O'Toole from Navarro College. Bob is a Navy Vietnam veteran who served 10 years and obtained the rank of Chief Quartermaster. He retired as the Senior Field Representative of the National Veterans Service of the Veterans of Foreign Wars of the United States. While working in Washington, DC he and his wife build a home in the Wildness Battlefield in Spotsylvania County, Virginia. While living in Corsicana, Virginia his love for the Civil War became a passion. He volunteered at the Pearce Museum for five years before joining the staff about 18 months ago. Along with another volunteer developed a program that they take to the schools, civic groups and others interested in learning more about the Civil War. Bob portrays Confederate General Robert E. Lee while Carroll Sigman portrays Union General Ulysses S. Grant. To improve his knowledge Bob has spent six months at the Petersburg and Richmond National Battlefields as a volunteer guide. Bob is married to Donna Dickson Forrester O'Toole, they have six children, twenty-six grandchildren and two great grandchildren. Bob joined the SCV under his Great- Great Grandfather Andrew Jackson Frady, Sr., of the 28th North Carolina Infantry Reg. They served with the Army of Northern Virginia from just after First Manassas through the surrender at Appomattox. Of the 1,190 men who travelled north to join the Army of Northern Virginia 230 returned.

## *Chaplains Corner*

“Teach us to number our days, that we may apply our hearts to wisdom”-Psalm 90:12

Life is filled with opportunities, but the big question is what we do with them. Do we let them slip by, saying “Maybe, next time? There is always another day”? Or do we seize them? We may not have as much time as we think.

I read recently that a professor calculated the average length of a life using the hours of one day to illustrate the importance of recognizing the value of time. He concluded that if your age is 15, the time is 10:25 a.m. If your age is 20, the time is 11:34. If your age is 25, the time is 12:42 p.m. If you’re 30, the time is 1:51. If you’re 35, the time is 3:00. If you’re 40 the time is 4:08. At age 45, the time is 5:15. If you’re 50, the time is 6:25. By age 55 the time is 7:24. If you’re 60, the time is 8:42. If you’re 65, the time is 9:51. And if you’re 70 the time is 11 p.m.

Jesus told the story of a man who went on a journey and left his money with his servants. This was not an uncommon thing in those days. A wealthy man or a ruler would have many servants in his household, from those who performed basic labor to those who managed the financial affairs of his household, even his business. In many cases some of the man’s servants would be better educated and skilled than he was. Highly trusted slaves had a virtual free hand within prescribed areas of responsibility while the owner was at home.

When the owner would go on a journey, he would leave full authority in the hands of these key servants, who would have the ancient equivalent of a power of attorney. So, Jesus described a scenario in which a wealthy man went on a journey and left the key servants in charge of his possessions. It’s difficult for us to know exactly what sum he left them, but one possibility is that he gave the equivalent of \$5,000 to the first servant, \$2,000 to the second servant, and \$1,000 to the third.

What Jesus is saying in this story is obvious. Jesus is like that wealthy man who goes on a journey, which spans the day he left this earth to the day he returns in the Second Coming. We are the servants he has invested in, and we are to take what he has given us and use it for his glory while we await his return.

In the New Testament a word that is often used for “slave” or “servant” is the Greek word *doulos*. It’s a term that describes a unique class of servant, not someone who was made that way by constraint or by force. A *doulos* was someone who had been freed by their master yet still chose to serve out of love. The servant was so thankful for his pardon that he or she would willfully choose to serve.

The apostle Paul referred to himself as a *doulos*, and that is what we are as followers of Jesus Christ. In Jesus’ story, the first servant invested it, and received a 1000 per cent return. He doubled his master’s investment. The second, though he had less, did the same thing.

This demonstrates that it isn’t a person’s talent that matters as much as how he or she uses that talent. God never demands from us the abilities we don’t have. But he does demand that we should use, to the full, the abilities that we do possess. We may not be equal in talent, but we should be equal in effort.

Take what God has given to you and do the most that you can with it for His glory. God can do a lot with a little. If you don’t believe me, just ask the boy with the five loaves and two fish who gave everything he had to Jesus. It didn’t seem like a lot, but Jesus used them to feed a hungry multitude. Jesus can take a little, bless it and multiply it. He can use it beyond our wildest dreams.

If we as members of Sons of Confederate Veterans are willing to do what is before us and be faithful in the little things, then I believe that there will be more to do, I would rather try and fail than never try at all. Any time you take a chance you can fail. But it is better to try than to never take chances and never have anything happen in lives.

So, seize the day. Seize the moment. Seize the opportunities before you. Don’t put it off too long, because you may not have as much time as you think. Be productive with your life. Be productive with your time. Seize the opportunities God has given to you and to us.

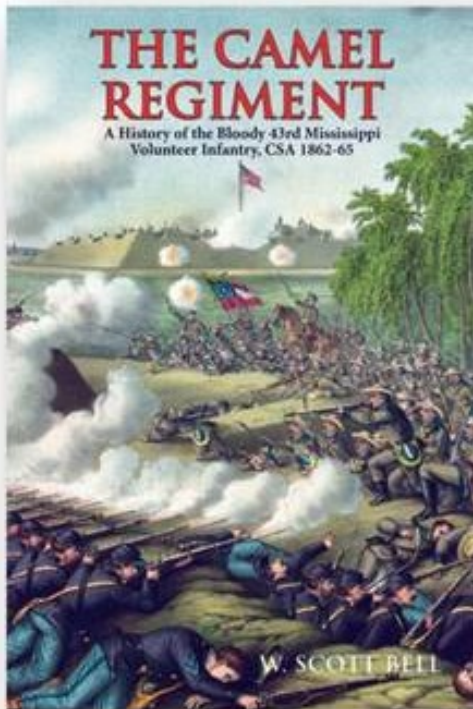

## *The History of the Bloody Forty-Third Mississippi Volunteer Infantry, 1862-65*

W. Scott Bell is a Life Member of the Sons of Confederate Veterans (SCV) and its Texas Division. Due to his scholarly research and published literature, he has been awarded membership into the Bonnie Blue Society of the SCV. He is also a recipient of the Jefferson Davis Gold Medal from the United Daughters of the Confederacy for his research, writings, and presentations to schoolchildren, as well as his efforts in the restoration of Confederate monuments. Bell's great-great-grandfather was Cpl. John K. Bell, a member of the 43rd Mississippi, who provided much of the inspiration to research and write about the regiment. Bell currently resides in Maydell, Texas.





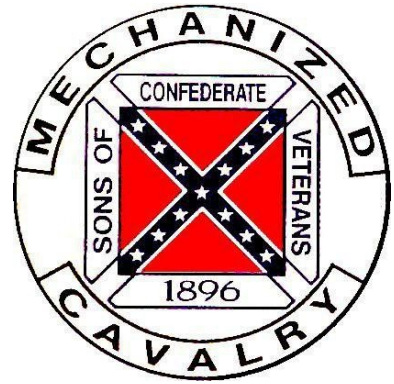

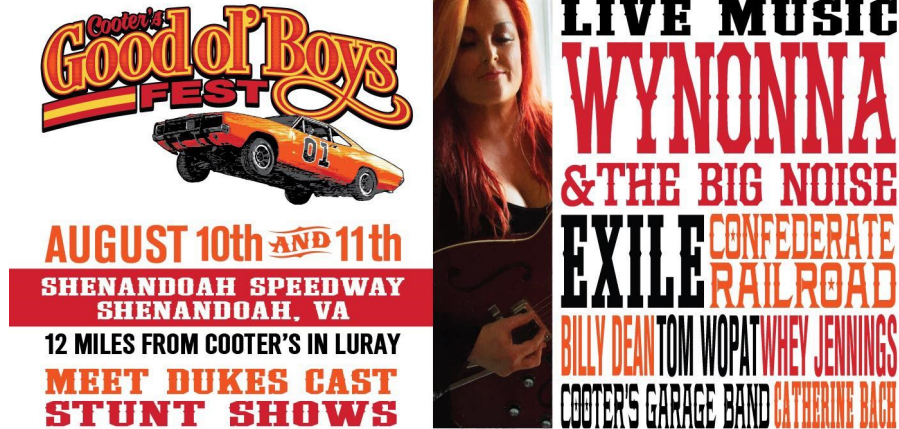

## *Forgotten History by Jack Bowen*

Although the State of Texas seceded from the Union on February 1, 1861, according to the following communication from the Secretary of State of the Independent Nation of Texas to the Secretary of War of the Confederate States of America, she was not one of the Confederation on March 13.

On March 4, the Confederate States called on the Governor of Texas to furnish a regiment of mounted riflemen to be organized and received into the service of the Confederacy. The following communication in reply to this was sent from Austin on March 13: "The people of Texas, having severed their connection with the United States of America, have assumed again the position of a sovereign State, and nothing since that period has warranted the construction that Texas is other than Independent. Your letter of March 4 informs Governor Clark that the President of the Confederacy assumes control of all military operations in this State; therefore, the inference is that Texas is regarded as one of the Confederacy and as such is subject to the provisional government established for the same. While Texas has resumed again the nationality with which she parted by annexing itself to the United States of America, her position before the world, and especially in relation to the Confederacy, seems to be misunderstood. Judging from your communication Texas is again deprived of her sovereignty and instead of an independent nation has become one of the Confederate States, subject to a government which her people had no share in making and a constitution which they have never seen. As Texas is not one of the Confederate States and therefore not subject to their government, and until his excellency is informed from some official source that the people of Texas have parted with their sovereignty and become a part of the government on whose instigation you write I am instructed to say that he cannot recognize any obligation to the same. I have the pleasure of assuring you; however, on the part of the Governor, that the States which have formed this provisional government have his ardent wishes for their welfare in the future, and the people of Texas are bound to them in sympathy and feeling no less closely than when members of a common union. But; however, close these ties may be in feeling, there are requirements due the national pride and dignity of a people who have just resumed their nationality which do not sanction the course pursued in annexing them to a government without their knowledge or consent."

The facts in the case; however, were that a convention (unauthorized by the Governor) had been previous to the State's secession from the Union. This assembly had elected and sent delegates to the Montgomery convention who, upon arrival, had been accredited to Texas and voted to go into the Confederacy, consequently the order for troops. But the "Lone Star State" did not hesitate long. Throwing her fate in the balance, she held with her sisters in grim determination in the War for Southern Independence.

### Texas Pensions in 1915

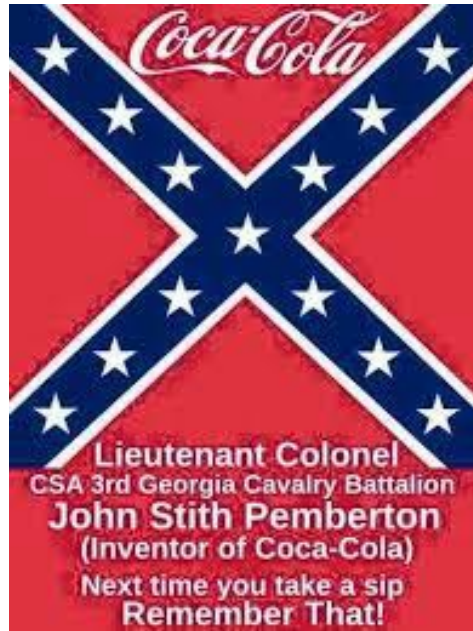
In June of 1915, Texas had on its rolls 18,633 pensioners. 1,743 draw \$100 per year being totally disabled, they receive the same amount every year. 16,890 draw at least \$79 a year payable quarterly. They also can draw as much as \$100 annually when there is enough money paid from taxes. Texas receives pension money from a tax of five cents on the \$100 ad valorem, which in 1915 amounted to about \$1,300,000.

In the Confederate Home for Soldiers there are 389 residents, and in the Women's Home there are 40 residents. There was appropriated \$100,000 per year to run the Soldiers' Home and an appropriation of \$17,000 per year to run the Widows' Home.

It is interesting to note that Texas has more pensioners than any other State in the South, drawing Confederate pensions. In addition, Texas had its Texas Republic pensions, which no other State has, and a Ranger force to keep and pension.



## *Success of Business After the War - Coca Cola*



The following was printed in the Confederate Veteran Magazine, July 1929

In the following, Mrs. J. S. Newman, of Clemson College, S.C., tells of the origin of the drink now world known, and which built up a family fortune.

“So much has been said about Coco-Cola and its origin, and so much of interest has been left out, that I believe I can add something that has not appeared in print and that is known to but few, and some of it know to no one else.

Dr. Pemberton, my brother-in-law, the originator of Coco-Cola, was born in Bibb County, near Macon, Ga., either in 1832 or 1833. I do not know in what institution he received his medical education but do know that he received his medical degree and was a licensed physician. After owning and operating a drug store for several years in Oglethorpe, Macon County, Ga., he moved to Columbus, Ga., where he operated a large drug business for several years.

When the War Between the States started, he joined Wheeler’s command until the close of the war. The last engagement he was in was on the bridge which he was defending at Columbus, Ga. In a personal encounter with a Yankee major, whom he killed, and by whom he was desperately wounded, he was taken prisoner, remaining under guard for weeks.

At the close of the war, he began experimenting with drinks. We moved to Atlanta in the fall of 1875, and soon afterwards Dr. Pemberton moved to Atlanta and established a wholesale and retail drug business. He also installed a laboratory and began the development and manufacture of new drugs, medicine, etc. Among these was a substance he named wine of cola. I remember asking him if there was any alcohol in it, and his reply was, “No” with a “Yes” meaning. At that time, I had just read Westward, Ho! By Charles Kingsley. In this novel the hero, while lost in the woods in India, were surprised when a girl, crying, ran to him for protection from some young men who were chasing her. She told the hero that her pursuers were drunk on coco-cola.

Dr. Pemberton did not have the money to perfect and make the beverage he sought, and borrowed from my father, Col. Elbert Lewis, five thousand dollars and a like amount from my sister, Clifford, whom Dr. Pemberton married about 1853. This money and his earnings in his drug business were all used in the development of Coco-Cola. My sister sold all her rights in Coco-Cola to Asa Candler, who recently died. The price paid was \$500.”

### **Honorary Diploma by University of Alabama**

Acting upon the request of the United Daughters of the Confederacy, the trustees of the University of Alabama voted to award honorary diplomas to those students now living who were soldiers in the War Between the States and who on account of that service were denied the opportunity of completing their college course, provided that in each and every case the individual has subsequently lived a worth and honorable life.

These diplomas will be awarded to the veterans during the annual session of the United Daughters of the Confederacy on the occasion of the unveiling of the boulder in honor of the University's Confederate Sons of May 13, 1914.

All Chapters of the United Daughters of the Confederacy and all Camps of the United Confederate Veterans are urged to interest themselves in this matter and to notify all veterans to interest themselves in this matter and to notify all veterans within their knowledge who are entitled to this high honor. All applications for these diplomas should be made to Dr. Denny, President of the University of Alabama.

The university, in awarding these diplomas, is to be congratulated upon its wisdom in thus honoring the veterans of the South, and the Daughters of the Confederacy should be commended for their interest in securing this recognition.

### **Who Is Columbus?**

Gen. K. M. VanZandt, commanding the Trans-Mississippi Department, U.C.V., is known far and wide as intensely devoted to his Confederate Comrades, and is frequently absent from his chair as President of the Fort Worth National Bank attending the funeral of some comrade who has passed the great divide. Not long ago two old-time Confederates who were evidently short on ancient history, but long on the Major's love for his Confederate friends, approached his bank to get a check cashed and found it closed with the sign on the door, "Closed-Columbus Day," that being the legal holiday honoring the date of the discovery of America. As they turned away one remarked to the other: "The Major (his title as major of the 7th Texas Infantry) is attending another Confederate funeral. Columbus is dead." "Who's Columbus?" inquired the other, "One of his old regiment, I suppose," was the reply.

### **Both Surprised**

In 1864 Gen. William L. Jackson's brigade was in Pocahontas County, while the Yankees were in Randolph. No troops from either side occupied a considerable territory on the borders of each county except scouting parties. An Irishman by the name of John Baker, belonging to one of Jackson's cavalry regiments, was rather fond of liquor, and one day he went to a still house in this neutral territory and got his canteen filled. When he came out, to his surprise there was a Yank with is gun ready to fire, and he told Johnny to surrender. "Certainly," says Johnny, and handed over his gun. They started off together, each on his on horse, but had not gone far before Baker discovered that his captor was an Irishman also; so, he said to him: "What the devil is the use of us quarreling over this thing? We are both from the same country. Won't you have a drink?" The Yankee says: "Certainly." Johnny handed him his canteen, which he turned up and had a drink. When he took it down, behold, a pistol was pointing at his breast. With the remark, "Maybe you'll surrender to me now," the Yankee was taken a prisoner to Jackson's Brigade.

Uniforms are a necessity though - gray shell jacket with sergeant's stripes, white shirt, butternut pants, and red NCO sash are the basic components - but any serviceable enlisted man's uniform is acceptable. If you have a musket and prefer to be one of our guards, even better.

We have a fine core group but could use a few good Confederates to make sure we always have enough men to staff an event.

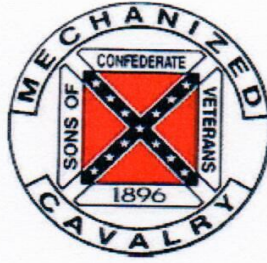
