## *Chaplain's Corner* - Essential Qualities of a Godly Leader

A quick search of my home library reveals many books about "leadership"; how to be a great teacher, successful businessman and business leader, to my youngest son's books on being a successful football coach. Amazon results on "leadership" yields 137,827 results with new titles added regularly. Go to Twitter and search #leadership and see how many experts and self-proclaimed gurus are speaking on the topic

President Theodore Roosevelt once said, "The leader leads, and the boss drives. The Boss often plays the Boss Card. They force obedience, strictly because of their position and status. But as author and expert John Maxwell says, "Leadership is not about titles, positions or flowcharts. It's about one life influencing another."

I believe that God has placed all of us in a position of leadership, if not in our workplaces or churches, Sons of Confederate Veterans, UDC, OCR, then certainly in our homes as parents. I know there have been times when I don't exemplify the qualities of a Godly leader. I'm not knocking all the great books out there on leadership; there are some terrific resources available from people who know far more than many of us do. But, there is one resource that has a lot to say on the topic of effective leadership, and it's available for free and I'll bet you have it at your home right now. It's the **Bible**, and the passage is **Proverbs 16:1**. This chapter is chock full of leadership lessons. Below are nine principles that are critical characteristics of a good, godly leader.

### **A good leader seeks God's direction.**

Is there anything more important in a leader than he or she seeking God's direction? **Proverbs 16:1** "The plans of the heart belong to man, but the answer of the tongue is from the Lord." Verse 3 adds, "Commit your work to the Lord, and your plans will be established." And verse 9, "The heart of man plans his way, but the Lord establishes his steps." A good leader seeks the Lord, commits his way to the Lord, and the Lord establishes the next steps.

### **A good leader is modest, not arrogant.**

We've all encountered the know-it-all leader, the "submit-or-else" type of leader. But **Proverbs 16:5** says, "Everyone who is arrogant in heart is an abomination to the Lord; be assured, he will not go unpunished." I don't know about you, but I don't want to be referred to as an abomination to the Lord. That's some pretty scary stuff.

### **A good leader is a peacemaker.**

**Proverbs 16:7** says "When a man's ways please the Lord, he makes even his enemies to be at peace with him." Yet so many leaders aren't interested in examining an opposing viewpoint or other ideas. We've lost the ability to empathize with others, and compromise has become a bad word. There's something to be said of sticking to principles. I believe God calls us to be steadfast. He doesn't, however, call us to be jerks. And, when our "boldness" is interpreted as "coldness," we are not doing it right.

### **A good leader is fair and just.**

"Better is a little with righteousness than great revenues with injustice." **Proverbs 16:8** I believe in goals and working hard to achieve them. But the end always justifying the means is simply not true. A good leader is more interested in doing things the right way.

## *Chaplains Corner* - Essential Qualities of a Godly Leader Cont.

**A good leader surrounds himself or herself with honest, trustworthy counselors...and listens to them.**

*"Righteous lips are the delight of a king, and he loves him who speaks what is right."* **Proverbs 16:13**

Do you know leaders who surround themselves with "yes" people? Personal insecurity drives them to seek only positive reinforcement for every decision they make. A smart leader surrounds himself or herself with smarter people, who are willing to speak their minds and offer sound counsel. After all, *"Without counsel plans fail, but with many advisers they succeed"*. **Proverbs 15:22**

**A good leader is a good learner.**

**Proverbs 16:16** says, *"How much better to get wisdom than gold! To get understanding is to be chosen rather than silver."* A good leader should always be learning, growing and improving. The day you feel there is nothing left to learn is the day that pride and arrogance have taken root. And, we've already discussed how the Lord feels about arrogance.

**A good leader is humble.**

We've seen countless prominent examples of **Proverbs 16:18** *"Pride goes before destruction, and a haughty spirit before a fall."* From politicians, celebrities, CEOs and unfortunately pastors who have grabbed headlines as their empires fell. In most of these cases, it is pride that crept in. They thought themselves invincible, but quickly found out that no one is. *"It is better to be of a lowly spirit with the poor than to divide the spoil with the proud."* **Proverbs 16:19**

**A good leader is sensible and kind.**

*"Good sense is a fountain of life to him who has it, but the instruction of fools is folly. The heart of the wise makes his speech judicious and adds persuasiveness to his lips."* **Proverbs 16:22-23**. Being smart and sensible makes a good leader more persuasive and effective. A good leader uses *"gracious words"* (verse 24), not speech that is *"like a scorching fire"* (verse 27).

**A good leader is slow to anger.**

We've all seen the caricatures in movies and television of the angry boss; the person who yells for no reason, barks orders and berates and demoralizes the staff. The **Bible** says that *"Whoever is slow to anger is better than the mighty, and he who rules his spirit than he who takes a city."* As member of the Texas Division of the Sons of Confederate Veterans we will be meeting in Temple at the end of this month. One of the orders of business is the election of new officers and voting on changes to our Division Constitution. As you read through these qualities of a good leader, hopefully you find them as challenging as I do. God tells us how to be effective, godly leaders. It's therefore up to us to put our human tendencies aside and embrace these principles. It is also up to us to pray for those under which we serve, that they also would be the good leaders God wants them to be.

## Chaplain's Corner

### God on Our Side

*The LORD is on my side; I will not fear. What can man do to me? The LORD is on my side as my helper; I shall look in triumph on those who hate me. (vv.6-7)*

Psalm 118:1-16

God's people have been given many promises, and among the most precious of these is that the Lord will be with us wherever we go. Old covenant Israel received the promise that God would never leave or forsake her, and this promise is extended to the new covenant church (Deut. 31:6; Heb. 13:5). Our Creator is with His people in a special way, bringing with Him provision and assurance. But what is perhaps most remarkable of all is that the Lord promises to fight for us (Es. 14:14). God is on our side. Some qualification is needed here. God is on our side only because we are on His side, because we have bowed the knee to Him and joined His army. Furthermore, that the Lord is on our side does not mean we are guaranteed immediate success in every endeavor. God fights only in the holy battles we wage, and not every conflict or endeavor that we pursue is a godly one. We also know that sometimes God allows what seems to be a loss in battle in order to win the war. Just consider the death of Christ; what appeared to be a defeat at the hands of sin and Satan actually became the means by which our Savior conquered them once and for all (Col. 2:13-15).

Yet there are many occasions on which the Lord's doing battle for us provides victory in the present. The author of Psalm 118 helps us see this, showing us how to praise God for His aid. He describes an occasion when he was surrounded by his enemies and there seemed to be no hope of victory (vv. 10-12). He found himself on the brink of disaster, but God intervened to save him (v. 13). The psalmist never identifies himself, speaking in generic terms as a representative of the people of God. Thus, this psalm has application to all manner of struggles both personally and as the corporate church. It is a model for how we are to thank the Lord for deliverance from many difficulties.

That God fights for us is easy to confess with our mouths but much harder to believe in our hearts. So, we must turn repeatedly to the promise that God will fight on our side, that we may rest confident in Him no matter what assails us. John Calvin comments that though all profess that the Lord is a better ally than anyone else, "*yet there is scarcely one among a hundred who is fully persuaded that God alone can afford him sufficient help. That man has attained a high rank among the faithful, who, resting satisfied in God, never ceases to entertain a lively hope, even when he finds no help upon earth.*"

No foe is too great for the Lord to handle, and so we praise Him in battle, knowing that He will bring the final victory.

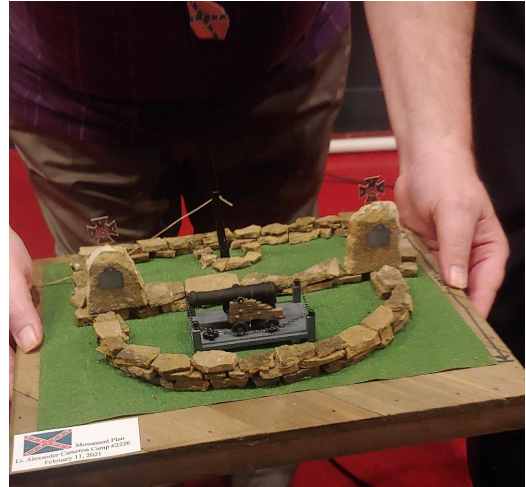

## *Texas Division UDC News* - PLEASE WRITE LETTERS

Hello!

I would like to request assistance from the gentleman of the SCV to assist in the last call for vote about the Texas Confederate Woman's Home in Austin. It looks like we will have one remaining opportunity to speak/write in favor of keeping the State Antiquities Landmark (SAL) designation and keeping the Historical marker.

We received a SAL removal request from the Austin Group for the Elderly (AGE) wanting to remove the marker. They complain more about 3 years of operation by the UDC than the 110+ years of other ownership- trying to draw on a nerve of people at the Texas Historical Commission(THC). The letter outlines issues that are not true about the UDC and the building. For example during the last THC Antiquities meeting, Commissioners and staffers noted that this building is a fine, structurally intact early example of a building technique with concrete blocks, the building because of its unique purpose is a possible candidate for a National Register designation (the only Woman's Home west of the Mississippi), and an early example of female leadership prior to the suffrage movement among other items discussed.

The Antiquities committee voted unanimously to *deny* the removal request; however, the THC is allowing the full board to vote in April. The Travis County Historical Commission wants the designation and marker to STAY. The delay in the final Board vote will give AGE more time to have public comments that support removal of the designation and marker.

**The deadline is February 25** to get letters to the below addresses to be noted during the 30 day comment period. AGE may have been waiting until now before they say much, so we have to come forward with continued letters.

Please email [mark.wolfe@thc.texas.gov](mailto:mark.wolfe@thc.texas.gov) and [esther.brickley@thc.texas.gov](mailto:esther.brickley@thc.texas.gov), put the Texas Confederate Woman's Home in the title. In the body of your statement, please note that you are replying during the public comment period along with your comments.

We need max effort to support this unique piece of Texas, Confederate History and our heritage. Together, we can keep Texas history!!

I thank you in advance for your assistance in this work to **KEEP** the SAL designation and the Marker at the Confederate Woman's Home.

## *SLRC Monument Cases Update*

The Return Lee to Lee Park Lawsuit is on its way to the all Republican Supreme Court of Texas. Our Petition for Review must be filed before 15 MAR.

At stake are big city syndicates free to ignore the Texas Antiquities code, bypass legal requirements to involve the Texas Historical Commission in tearing Historic landmarks? Is Texas' most radical judge free to dismiss a case for lack of standing AND dismiss the case claiming the Antiquities Code does not apply - when Texas law says you may dismiss for one of those grounds but not both!! The case must go back to the trial court!

The forceful dissenting Judge's opinion in the 5th Court of Appeals decision basically begs the Appellants to appeal to the Supreme Court. And so we shall!

Dallas Monument case # 2 - the Carter case may also soon be on its way to the Texas Supreme Court. The 5th Court of Appeal recently heard oral arguments AFTER letting the City add evidence in the case not in the record. When our legal team objected just before oral arguments the court overruled them but allowed us an unheard of 20 days, post arguments, to respond to the last minute supplemental brief and evidence slipped in by the city. Our legal team filed a masterful & hard hitting response, that calls out the City on its slimy tactic to create a bogus appeal record. If the City will go to this length to play "foul" with a marginalized group like the Heritage community, imagine what else seamy they are doing in Dallas that is yet undetected!

The city, trying to gild the lily may well have given the good guys' legal team the winning argument before the Supreme Court - should the 5th Court of Appeals uphold the dismissal of the Carter Appeal..

Back in 2017 when the City determined to take down the 1899 Pioneer Cemetery Confederate War Memorial the case went through the City Landmark Commission, where the city deliberately & illegally shortened citizen response time before ramming demolition through the Commission. This was upheld by the City Plan Commission before Plaintiff's filed in a Dallas County Court and dismissed by Texas' most radical judge.

The issue in this case is very simple must Dallas abide by its own rules, ordinances and procedures or is do the rules only apply to us peasants? At the oral arguments the city tried to slip in additional "evidence" not in the record to strengthen their position that the shortening of time for citizen response was a mere mistake or accident - not a deliberate illegal act of city officials.

The 5th Court of appeals may rule soon - and this will be case No 2 on its way to the Texas Supreme Court - whatever the decision of the Court of appeals. We may have to move to protect the monument wherever it is, if the Court rules against the good guys.

As I have said and will say again - the bad guys, bent, and broke the rules, violated the law and probably more to achieve their hateful purpose of getting rid of the people's art, the people's monuments.

The left of center crowd that runs Dallas believe they can do as they like- I really believe they think they are above the rule of law. In this age of universal deceit it is imperative that the Heritage crew rally ALL conservatives and lovers of liberty to the monument struggle as the most potent way to expose the illegal acts of Big city officials and strike a blow for liberty and resistance to tyranny.

There are potentially 80 million disenfranchised voters who are believers now and very recruitable to the cause of liberty. Let's get to work & bring them in to the Heritage fold - as a coalition movement we can be very big tent!

SLRC has spent \$3,000 to get the research & drafting of our response to the City's bogus supplement brief & evidence. A gallant Dallas patriot has donated \$1000 towards paying that debt. We need to pay the remainder off so our researcher can keep working for us (she's been our ally & help mate for 20 years and never let us down - her work is excellent).

In addition we will need about \$6000 to research, draft & file the Texas Supreme Court Petition for Review in Return Lee - with Carter possibly soon to follow. Send us the \$AMMO\$ so we can deliver to the American people the VICTORY!

## *Virginia Flaggers Update - NEW FLAGS & POLES!*



The weather is starting to break in the Old Dominion and our Guardians of the flags are busy checking flag sites and replacing flags that have been damaged during the severe winter storms we experienced. Yesterday, we raised a new 20' x 20' flag at the I-95 Wade Hampton Roadside Memorial Battle Flag site (photo above) and will be checking all of our sites and replacing flags as needed over the next few weeks.



Many thanks to our Guardians of the Flags who give so generously of their time to help maintain our roadside memorial flag sites across the Commonwealth, and to all of YOU whose generous support makes it all possible!

The breaking weather also means that we are FINALLY able to break ground on several new flag sites.

We are THRILLED to announce that TWO new projects are permitted and construction will start on both in the next few weeks. Both of these projects are joint ventures with SCV Camps in Virginia and we are excited to kick off 2021 by adding two new roadside memorial battle flags in the Commonwealth!

We have TENTATIVELY set a date for the dedication of one of these sites for Saturday, April 17th, to coincide with the 160th Anniversary of Virginia's secession. Please SAVE THE DATE and stay tuned for more information.

The second site will also be completed and dedicated very soon, and we will update with more information, including locations, as the dedication/flag raising dates are confirmed and approach.

2020 brought challenges like we have never seen before, and there was no exception with some of our existing flag sites. We are still dealing with zoning issues and litigation on several sites, and will have updates soon, when all legal and permitting issues are finalized.

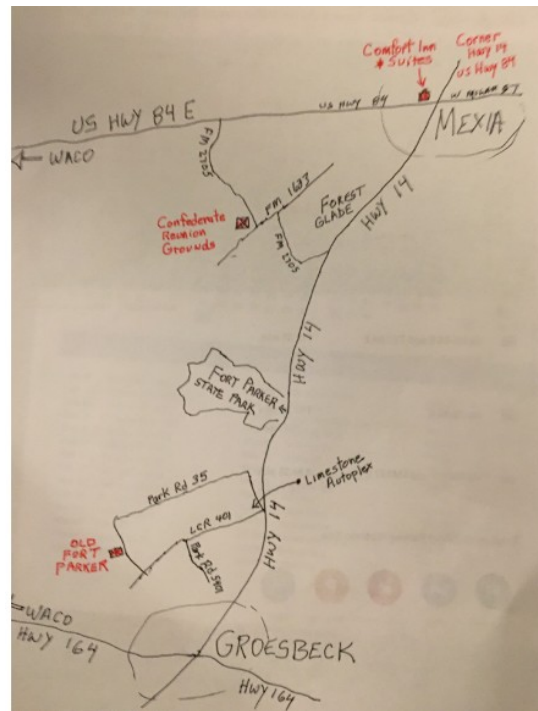

## **Two Confederate Generals, Two Battles, Two Deaths And Three Burials**

The two men, each in their mid-thirties, died on the same day on the same battlefield. The last words of one ("Never let it be said that Texans lag in the fight") were overheard. The death of the other came in a cloud of battle smoke so thick that no one saw him fall. Both men were generals. Both were trained as lawyers. And both would be buried three times before their mortal remains came to rest.

### **HOUSTON MONDAY JANUARY 25, 1864**

**We are as yet without much information regarding the part Texas troops bore in the battle of Missionary Ridge. We notice Smith's Texas Brigade gallantly held their place, being commanded by Col. Granbury, of the 7<sup>th</sup>, after the fall of Gen. Smith, that the 6<sup>th</sup>, 10<sup>th</sup> and 15<sup>th</sup> consolidated, led by Col. Mills, who was wounded, as was also Maj. Sanders, who lost an arm, was led by Gen. Cleburne in a charge which inflicted great injury upon the enemy. When these regiments were engaged the enemy was bloodily repulsed.**

In this era of instant and endless news coverage, we forget how slowly news traveled in the days before BT (before Twitter). Case in point: On January 25, 1864, the *Houston Tri-Weekly Telegraph* printed a report on the role of Texas soldiers in the War for Southern Independence's Battle of Missionary Ridge in Tennessee. The Battle of Missionary Ridge had been fought on November 25, 1863—*two months* before the newspaper account was published. Of particular interest the report mentions Confederate officers Colonel Hiram Bronson Granbury and General Patrick Ronayne Cleburne.



Patrick Ronayne Cleburne (left) and Hiram Bronson Granbury (right) survived the Battle of Missionary Ridge. But one year later and 130 miles away on November 30, 1864 Cleburne and Granbury (by then a general) were killed at the battle of Franklin in Tennessee. Four other Confederate generals died in the battle.

"The space between the enemy's first line and the main line was about two hundred yards. The ground was level, and I don't think there was a tree or bush between them. The fire and destruction were beyond description. I went up to the works with Granbury's brigade. Generals Granbury and Govan, and their staff, were on foot. About halfway between the first and main line General Granbury was killed. I was within ten feet of him and remember well the last words he spoke: 'Forward, men; never let it be said that Texans lag in the fight!'"

"One, not in the battle of Franklin, might think it strange that such a conspicuous character as General Cleburne should be killed and his death not witnessed by anyone; but the fire was so terrific and the smoke so dense that one could not distinguish an object at twenty feet distant. The morning after the battle information came to our headquarters that General Cleburne's body was found. I immediately went in search of it and found it laid out on the gallery of the McGavock brick house—boots, pocketbook, diary, and sword belt gone. I afterward found the latter on a soldier, who claimed to have found it. His (General Cleburne's) face was covered with a lady's handkerchief finely embroidered. Who placed his body there I have never been able to ascertain? General Cleburne received but one wound and that was from a Minnie ball which passed through his body. I procured coffins for Generals Cleburne and Granbury and Colonel Young, of the Tenth Texas, carried their remains to Columbia for interment, sent a courier ahead to have three graves dug in some suitable place in the country there; reached Columbia late in the evening. The remains of these three heroes lay, during that night, in the parlor of Mrs. Mary R. Polk. So while the body of Cleburne was lying in Mrs. Polk's parlor."

"The following verses were placed upon his coffin, written by the talented and accomplished Miss Naomi Hays, niece of ex-President Polk, who afterward married the late lamented Major W. E. Moore, chief commissary of the Army of Tennessee:

*Fare thee well, departed chieftain!  
Erin' land sends forth a wail,  
And O my country sad laments thee,  
Blow, ye breezes, softly o'er him,  
Fan his brow with gentlest breath;  
Disturb ye not the peaceful slumber—  
Cleburne sleeps the sleep of death.  
Rest thee, Cleburne, tears of sadness  
Flow from hearts thou'st nobly won.  
Mem'ry ne'er will cease to cherish  
Deeds of glory thou hast done.*

"Funeral rites were performed the next day by the Right Rev. Bishop Quintard. The bodies were borne to the cemetery and placed in graves beside General Strahl and Lieutenant Marsh, of his staff. After the burial, I discovered that these gallant men were buried in that portion of the cemetery known as the 'potters' field', between a row of negroes and Federal soldiers. I felt very indignant, and so expressed myself. General Lucien J. Polk, brother to General and Bishop Leonidas Polk, was present, and most kindly offered me a lot in the Ashwood Cemetery, six miles south of Columbia, which kind and generous offer I most thankfully accepted. The next day I obtained a detail from the commandant of the post and disinterred Generals Cleburne, Granbury, and Strahl, Colonel Young, and Lieutenant Marsh. I disinterred General Strahl and Lieutenant Marsh at the request of Bishop Quintard. Having only a slight acquaintance with those gentlemen, I did not feel authorized to remove their remains from where their friends had planted them, but did so at the earnest request of Bishop Quintard, who I know was a warm friend of General Strahl and Lieutenant Marsh. Five graves were dug in Ashwood Cemetery, in a row, where I buried these five noble and gallant soldiers. (1)

(1) In *Campaigns and Battles of the Sixteenth Regiment, Tennesse Volunteers, in the War Between the States*, a war memoir published in 1885, Confederate Veteran L. H. Mangum recalled the deaths of Granbury and Cleburne and Mangum's role in the original burial (and prompt reburial) of the two generals near the Franklin battlefield.

In 1866, two years after Granbury was killed, Hood County was formed by the State Legislature of Texas and named for Confederate General John Bell Hood. The county seat was named for General Granbury. The *Fayetteville Observer* located in Fayetteville, Tenn. Reported that the remains of Gen. Patrick Cleburne were finally interred in Helena, Arkansas, his adopted town, on May 29<sup>th</sup>, 1870.

Fast forward to 1893, Khleber Miller Van Zandt, Fort Worth civic leader and president of Fort Worth National Bank for forty-six years, had fought with Granbury at the Battle of Fort Donelson in 1862 and at the Battle of Missionary Ridge in 1863. Van Zandt wrote in his autobiography that in 1893 the town of Granbury was given permission by General Granbury's sister to move his remains from Tennessee to the town named for him for reburial. The town sent its mayor, Dr. John Doyle, to Tennessee to fetch the remains. When Doyle got to Tennessee, he found that only bones and buttons had survived.

On the train trip back to the town of Granbury, Dr. Doyle stopped in Fort Worth and left the remains of General Granbury with Van Zandt for temporary safekeeping. General Granbury would be honored in a ceremony in Fort Worth and his remains then escorted to Granbury for the reburial ceremony in Granbury's city cemetery a few days hence on November 31—the anniversary of Granbury's death. It is interesting to note that Van Zandt kept the remains of General Granbury in the safest place she knew of the vault of Fort Worth National Bank.

The remains of General Granbury were transported from Fort Worth on a special train of the Fort Worth & Rio Grande railroad. Rufus Columbus Burleson, who was president of Baylor University (and who in 1854 had baptized Sam Houston), served as chaplain at the reburial ceremony. Before the war General Granbury had been a resident of Waco and McLennan county judge.

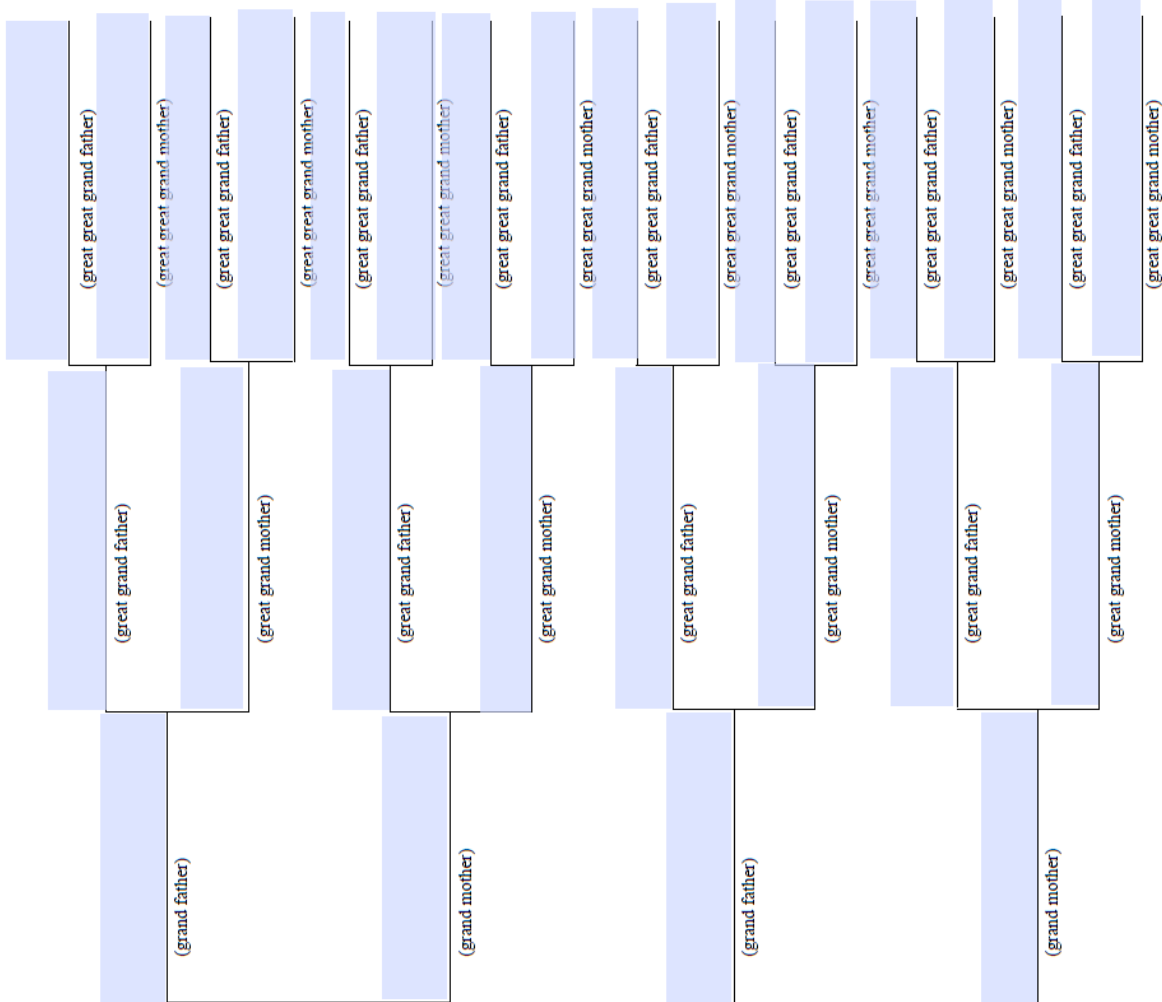

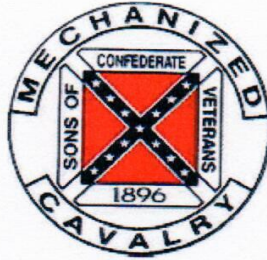
