



## *Chaplin's Corner - Values Over Valuables-A Legacy for Eternity*

When looking at family lineage the words often used are legacy, heritage and heirlooms. What is passed down from generation to generation? While we may initially think of heirloom items stashed away in cedar chests, what is really important are the values, character, reputation and integrity of previous generations of a family.

My mother, with the help of her cousin, became the historian of her side of the family. Mom was a collector of "valuables", including watches, jewelry, old letters, my Dad's WWII uniform, my Allen Military Academy uniform, and my Cub Scout uniform. Mom passed away before the advent of personal computers and the Internet so anything about Confederate ancestors was just a mention in old letters and a gravestone marker and stories of life before, during and after the War. Many thanks go to Kyle Sims for putting missing pieces together for me. I can now see how this research provided specifics about my family and how certain events shaped occupations, religion, interests, and passions that run in my family. The gold railroad watch from my grandfather, jewelry, class rings and other "heirlooms" may have some monetary and/or sentimental value but, chances are they will remain stashed away wherever we hide such items.

What is visible to others is the kind of people that we are. Are we compassionate? Are we caring? Are we honest in our dealings with others? Are we a person of faith? Chances are the values we live by are the values taught to us by our parents. And, our parents learned their values from their parents. When I read the biographies of my ancestors based on my "lineage notebook", I see hard-working people of faith. I am fortunate to have married a wonderful woman who also came from a family of hard-working people of faith.

If often am reminded of a pastor, David Tigert, who introduced me to a couple of books that are still in my library. I was walking as a baby follower of Jesus Christ, at that time and David knew I had an interest in history, so he gave me his copy of [The Great Revival in the Confederate Army](#), and a volume of works from R. L. Dabney, which included his remembrance of Thomas "Stonewall" Jackson. He added that you must always read about "men of faith" in order to see what "walking with Christ" means. Incidentally, David Tigert was from Jackson, Mississippi.

When you think about the word legacy, the first thought may be something is left behind after a person has passed. Webster's dictionary refers to the legacy of a person as "more about sharing what you have learned, not just what you have earned, and bequeathing values over valuables, as material wealth is only a small fraction of your legacy."

Mankind inherited a legacy of sin, but thankfully, people of the faith inherit the forgiveness of sin. Franklin Graham said, "The human heart is a type of cedar chest, storing valuable lessons, special memories, and the important pieces of one's life that live on throughout generations." The Bible says, *"And you also were included in Christ when you heard the message of truth, the gospel of your salvation. When you believed, you were marked in Him with a seal, the promised Holy Spirit, who is a deposit guaranteeing our inheritance until the redemption of those who are God's possession—to the praise of His glory (Ephesians 1:13-14).*

Reading the bios of my ancestors and other men of Christ, I can see how God has blessed each one of them even in times of struggle, defeat, and turmoil. We can pass on more than monetary blessings to our children. A culture of faith is far more valuable than a gold watch that doesn't work anymore and will probably remain in a dresser drawer for your children for your children to wonder what do with when you pass on to the next world. A reverence for God will be a gift that will sustain the next generation for eternity.

## *National News From Around the Confederacy*

### **IN SOUTH CAROLINA**

Columbia area businessman Fred Price Jr. has resigned from the prestigious position of chairman of The Citadel's Board of Visitors.

Price, 67, announced he would step down as chairman after meeting in an executive session Wednesday afternoon with a joint legislative panel that screens candidates for boards of South Carolina's public colleges and universities, said Sen. John Scott, D-Richland, a member of the panel.

Price is one of the few board members voting to retain the Confederate Flag and other symbols of the Confederacy on campus. We believe he is being pressured to resign. Since his resignation was tendered during an "executive session" we will never know what was said or why.

### **IN VIRGINIA**

Richmond's top prosecutor (a black woman) has asked the Richmond Circuit Court to appoint a special prosecutor to determine whether Mayor Levar Stoney broke any laws while arranging the removal of Confederate statues from Monument Avenue this summer.

McEachin is launching the investigation after details emerged about the city's selection of a shell company tied to a businessman who has been a large contributor to Stoney's mayoral campaigns since 2016.

The mayor has said the political donations did not influence the contract decision and that the selection was made after several firms declined to take the project.

### **ALSO IN VIRGINIA**

A Confederate soldier statue, cannons and cannonballs are being relocated to a battlefield in the Shenandoah Valley after they are removed on Saturday, officials said.

The Albemarle County Board of Supervisors voted unanimously at a special virtual meeting Tuesday to give the items to the Shenandoah Valley Battlefields Foundation.

### **IN MISSISSIPPI**

Dozens of demonstrators gathered in Lafayette, County Mississippi to call for the removal of a Confederate monument officials have previously refused to relocate.

In response Oxford officials have also raised questions about whether the monument is located on county or city-owned land and who has the authority to decide if it can be moved.

### **IN NORTH CAROLINA**

#### **FLAGGERS CAVE..?**

Drivers along Interstate 40 in Burke County, North Carolina have noticed a change of flags. About two years ago, 20-by-30-foot Confederate flags on an 80-foot pole were the features on either end of Burke County. Now, those flags have been replaced by American and World Council of Churches (mistakenly called a "Christian") flags.

It is unclear if the switch is permanent or temporary. The Sons of Confederate Veterans declined to comment on the change.

County leaders assure us that they did not remove the Flags because they were on private property and there aren't any ordinances against them.

The mayor of Hildebran, Wendell Hildebrand, said while he doesn't know what prompted the change, he is happy about it.



### **ALSO IN NORTH CAROLINA**

The Confederate monument in Graham will stay in place, for now. Alamance County commissioners decided in a meeting on Tuesday morning.

Sheriff's Deputies took four protesters into custody. Their charges range from Trespassing, Resisting an Officer, Assault, and Misdemeanor Riot.

### **IN ALABAMA**

The Confederate Flag and monument outside the Marshall County Courthouse on Emmett Street in downtown Albertville (population of almost 22,000 people) has become a new epicenter of protests as busloads of Soros-funded marxists have converged upon the town under the name of "Say Their Names Alabama," an organization that began holding protests outside the courthouse last month.

The group is also planning a "peaceful debate about the Confederacy" on Sept. 9, followed by another protest, according to its Facebook page.

### **IN FLORIDA**

From 8 a.m. Wednesday to 2 p.m. Thursday, Saint Augustine's Avenida Menedez was closed to traffic so that crews could remove the Confederate monument from the Plaza de la Constitution.

Just before 2 p.m. the monument was loaded onto a barge because protestors were there to destroy the monument had it been transported by truck. The barge on Thursday evening is transporting the monument up the Intracoastal Waterway north up the St. Johns River to Jacksonville.

Before the memorial was moved, a small private ceremony was held for the veterans whose names are listed on the the memorial. Some of their descendants attended. There was a 21 gun salute and "Taps" was played.

By the time this issue is released on Friday morning the monument should have reached its new home at the Trout Creek Fish Camp.

## Dental Fees During the War

Some time ago I came across the following entries on the ledger of a deceased relative who practiced dentistry during the Confederate War: "1860. Mrs. H. March 17, to four artificial teeth of gold plate, \$20; March 17, to extracting two teeth for servant (slave) girl, \$2; April 19, to extracting one tooth for servant (slave) boy, \$1." "1863. Mr. N.T.: July 8, to six gold fillings for son, \$63, July 9, to seven gold fillings for daughter \$50; July 9, one extra size gold filling, \$15; July 9, to three gold fillings for daughter (ordinary), \$30; July 22, to one gold filling for wife \$10; December 2, to one gold plate, \$975." In consequence of the depreciation of Confederacy the fees advanced enormously from 1860 to 1863. They continued to advance, and dental materials became so scarce that a gold filling cost \$1,000, and gold plates were unobtainable. A certain lady of note had planned to make a trip abroad, and that everything might be in good condition she went to a dentist of high reputation for some little necessary work. A friend meeting her some time after, inquired as to the date of sailing. "Oh, I've had to give up the trip," she said, adding naively, "but my dentist is going."

## The White Walkers Among Us

Bran: He'll come for me. He's tried many times before. Many times, with many Three-Eyed Ravens.

Sam: Why, What does he want?

Bran: An endless night. He wants to erase this world, and I am its memory.

Sam: That's what death is, isn't it? Forgetting...being forgotten.

If we forget where we've been and what we've done we're not men anymore. Your memories don't come from books, your stories aren't just stories. If I wanted to erase the world of men, I'd start with you. If we forget where we've been and what we've done, we're not men anymore, just animals." If you followed Game of Thrones for eight years you may have been either hooked on the story or gave up trying to follow each episode (at least nine per season) because you could not figure out what was happening or you were waiting for the next battle sequence. Three weeks ago, while locked up in the confines of home, I binge watched all eight seasons over three days. My hat is off to the script writers and George Martin for their writing, and it is not often you find a great deal of truth, wisdom and observations in the dialogue between each character and how this all comes to a climax in the eighth season.

The White Walkers are introduced in the first season and they have come to destroy and on the march South. The only thing that separates the civilized societies from the savages beyond is The Wall. The Wall is a monument to memory. It was so over-engineered and built on such an immense scale, lasting thousands of years, its size must have been intended not only to keep out the White Walkers, but to communicate its basic mission to all who see it . If the caretakers of the Wall were to die or abandon their charge, the notion would remain that someone built this structure to keep something out. Something terrible and unusual. Even if the particulars could not be remembered, the message would be clear. Monuments of Kings and Queens past were built to preserve memories and we find some placed in Winterfell. 
Jefferson Davis Statue being removed from the University of Texas-Austin mall.




