

ENTERTAINMENT AGREEMENT

This Entertainment Agreement (“Agreement”) is entered into as of the date signed below, by and between:

In Vino Veritas (“Venue”), located at _____, and
Performer/Artist (“Performer”), whose name and contact information are listed below.

1. Purpose

The Performer agrees to provide live entertainment at the Venue on the agreed date(s), and both parties understand and agree that **In Vino Veritas will not provide any payment, compensation, or guarantee of funds to the Performer**. The Performer’s compensation, if any, will come solely from **ticket sales or other promotional revenue generated directly by the Performer**.

3. Ticket Sales and Promotion

1. Ticketing:

- Performer agrees to sell tickets for their performance at a price mutually agreed upon with the Venue.
- The Performer is responsible for promoting the event and generating their own ticket sales.

2. Revenue:

- Performer shall retain proceeds from tickets they personally sell.

- The Venue shall not be responsible for any unsold tickets, promotional costs, or refunds.

3. Venue Ticket Sales (if applicable):

- If the Venue assists with online or door ticket sales, the Performer and Venue may agree in writing to a specific revenue split or service fee.
- Otherwise, all proceeds from Venue-managed sales shall be remitted to the Performer after applicable fees (if any) within 7 days of the event.

4. Compensation

- **In Vino Veritas will not pay any appearance fee, hourly rate, travel reimbursement, or other compensation to the Performer.**
- The Performer's only potential earnings shall come from **tickets they sell or merchandise they independently provide.**

5. Performance Standards

- Performer agrees to provide a professional performance suitable for a wine bar environment.
- Performer shall comply with all Venue rules, including volume levels, start and end times, and audience conduct.
- Performer shall bring and manage their own equipment unless otherwise agreed.

6. Cancellations

- Either party may cancel the performance with at least **7 days' written notice.**
- The Venue reserves the right to cancel the performance at any time due to circumstances beyond its control (e.g., inclement weather, emergencies, or legal restrictions).

7. Independent Contractor Status

The Performer is an **independent contractor**, not an employee of In Vino Veritas.

- Performer is solely responsible for all taxes, licenses, permits, and insurance related to their performance.
- Nothing in this Agreement shall be construed to create an employer-employee relationship, partnership, or joint venture.

8. Liability and Indemnification

Performer agrees to hold harmless and indemnify **In Vino Veritas**, its owners, staff, and affiliates from any claims, damages, or liabilities arising from the Performer's actions, performance, or use of equipment during the event.

9. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of the **State of Minnesota**.

10. Entire Agreement

This document constitutes the full and complete agreement between the parties and supersedes any prior oral or written agreements.
