

# Privacy Policy for The Grants Collective

## 1. Introduction

The Grants Collective ("we," "us," or "our") operates the website [www.thegrantscollective.com](http://www.thegrantscollective.com) (the "Site"). This Privacy Policy explains how we collect, use, disclose, and safeguard your information when you visit our Site and use our services. ## 2. Information We Collect

We may collect information about you in a variety of ways. The information we may collect on the Site includes:

### 2.1 Personal Data

## **4. Disclosure of Your Information**

We may share information we have collected about you in certain situations. Your information may be disclosed as follows:

### **4.1 By Law or to Protect Rights**

### **4.2 Business Transfers**

### **4.5 Marketing Communications**

With your consent, or with an opportunity for you to withdraw consent, we may share your information with third parties for marketing purposes, as permitted by law.

### **4.6 Other Third Parties**

We may share your information with advertisers and investors for general business analysis.

We use administrative, technical, and physical security measures to help protect your personal information. While we have taken reasonable steps to secure the personal information you provide, please be aware that despite our efforts, no security measures are perfect or impenetrable, and no method of data transmission can be guaranteed against any interception or other type of misuse.

We do not knowingly solicit information from or market to children under 13. If we learn that we have collected personal information from a child under age 13 without verification of parental consent, we will delete that information as quickly as possible.
