- 1. Peg called the meeting to order at 6:48
- 2. Karen made a motion to accept the minutes from the May 14, 2020 meeting. Harry seconded the motion. It was unanimously approved.
- 3. Treasurer Report-

Karen made a motion to pay Anchor Fence 415.00 for the gate, Harry seconded the motion

This seems like a high cost for some and it will not cover all of the repairs

Joel suggested asking the city if they would repair the gate

After a vote 3 members voted to pay to fix the gate and 5 voted to let it ride.

- 9. There is an opening for a steering committee member at large. Peg will ask around to determine interest.
- 10. Covid safety precautions-

Are they working? People seem to be following the protocols and the precautions seem to be adequate.

Peg modified the rules to take out repetitive statements and excess information. Harry made a motion to accept the modified rules, Harry seconded the motion, it was unanimously approved

Peg will post the modified rules at the garden, Karen will post them on the community garden website

11. Repair/ Repaint the shed?

Peg made a motion to paint the shed, Joel seconded the motion

The left side of the shed is falling apart. Screws might hold up better than renailing it. Should we budget for repairs and painting next year?

The motion to paint the shed did not receive any vote, the majority voted against it.

We will defer repairing and painting the shed until next year. This could be budgeted for and a contractor or handy man can be hired.

- 12. Excess (unnecessary) items in the shed will be thrown out if they are not removed by July 15th. All steering committee members agreed to this. Karen will send out a memo to the gardeners that this will occur
- 13. Japanese knot weed is creeping into the garden.

Can we ask the Parks and Rec to tend to this since they care for Hailey Park? Maybe they could extend their mowing to include this area. It could also be a volunteer opportunity to cut it back. We will talk with Ryan Sommer about our options

14. Volunteer opportunities-

The landscaping fabric still needs to be laid down. There has been no movement on this since Bruce made his video demonstrating how to do this.

The compost still needs to be sifted into buckets, we are short buckets to put the compost in. If anyone has spares that they want to donate, they can be used.
