The ~2,700-member Jewish community faces an increasingly hostile political environment with no dedicated government protection infrastructure.

Ireland's Unique Position: Ireland occupies an unusual space in the JCSI framework. It benefits from an absence of fatal attacks (unlike France, Germany, UK, Australia) and strong gun control. However, it suffers from a near-complete absence of Jewish security infrastructure, a government actively hostile to Israel (and perceived as hostile by the Jewish community), and a declining population with no political representation. The diplomatic rupture with Israel (embassy closure) is unprecedented among JCSI target countries.

Special Findings: Ireland's Unique Challenges

THE "ANTISEMITISM WITHOUT JEWS" PHENOMENON

Ireland presents a paradox: significant antisemitic attitudes (20% ADL; 35% agree Jews "talk too much about Holocaust") despite having virtually no Jewish population to interact with. Research by Professors Inbari and Bumin found antisemitism among Irish Christians at "Medieval levels," with religious supersessionism and anti-Zionism strongly correlated with antisemitic beliefs.

Key quote (Chief Rabbi Wieder): "Many are downright ashamed of their government. There is no doubt in my mind that the recent rhetoric by Irish political leaders against Israel has contributed to hatred against Jews in this country."

Key quote (Rabbi Lent): "There's no pro-Israel voice here - not in politics, not in the press."

TEXTBOOK CONTROVERSY

A November 2024 Impact-se report found Irish school textbooks contained:

- Auschwitz described as a "prisoner of war camp"
- Judaism portrayed as a "warmongering religion"
- Claims that Jesus lived in "Palestine"
- One-sided presentation of Israeli-Palestinian conflict

The World Jewish Congress president called this content "unabashedly antisemitic."
