**ALERT:** USA score dropped to CRITICAL (39) due to 2025 fatal attacks (DC Museum - 2 killed; Boulder - 1 killed), record 9,354 incidents in 2024, and constitutional gun accessibility creating unique mass-casualty risk profile.

#### **KEY FINDINGS SUMMARY**

The United States scores **39/100 (CRITICAL)** on the JCSI v1.2 framework - the only Western democracy in the Critical category. This assessment reflects the unique combination of: **1. Constitutional gun accessibility** - The Second Amendment creates a fundamentally different threat environment from all peer nations. With 393M+ firearms in circulation and no national registry, the potential for mass casualty attacks remains uniquely elevated. **2. Record incident levels** - The 9,354 antisemitic incidents recorded in 2024 represent a 893% increase over 10 years, with 25+ incidents per day. The 2025 fatal attacks in DC and Boulder demonstrate continued escalation. **3. Multi-vector threat landscape** - Unlike peer nations with primarily single-source threats, the USA faces simultaneous threats from ISIS-inspired actors, white supremacists, and pro-Hamas extremists. **4. Campus crisis** - With 1,694 campus incidents (+84%), 40+ encampments, and 34% of Jewish students hiding their identity, universities represent a critical vulnerability. Despite world-leading security infrastructure (SCN, \$454.5M NSGP funding) and robust constitutional protections, these structural factors place American Jewry in a uniquely precarious position among Western democracies.
