

LilyRay Training Contract

Through my training program I promise to uphold integrity and respect. Transparency is key for the success of you and your dog. I will never put you in a situation where your dog can't succeed. If you decide to train with me you agree that:

☐ **I agree that I have accurately assessed the health of my animal.**

My dog is up to date on vaccines and other medications they may be on. My dog has not shown any signs or been exposed to sickness such as: Giardia, Distemper, Hepatitis, Leptospirosis, Parainfluenza, Parvovirus, Bordetella(Kennel Cough) in the last 30 days. I am responsible for, and can be held liable if an illness is spread to other dogs or people. If my dog gets hurt or sick, I will let my trainer know and assess whether training should pause or stop. If asked, I can provide accurate health records from a licensed veterinarian.

☐ **I agree to learn.**

I will follow the fundamental values of the program(s). I will try new things, use the methods my trainer has advised and communicate with my trainer. The outcome of training depends on the work you put in. Training can be hard, but I ask for you to try and we can adjust as needed.

☐ **I agree to media usage**

Throughout training, photos and videos of my dog may be taken for training and media usage. I am entitled to have the videos and photos my trainer takes, as they are for training purposes and can help me understand the exercises given.

☐ **I agree with the cancellation policy.**

I will notify my trainer at least 24 hours ahead of time if I need to cancel a session. If I cancel less than 24 hours in advance that session will not be refundable and will count towards overall lessons. If lessons are not used, we are not actively training or in any form of contact within the month of purchase the program will terminate without a refund. (exceptions in emergency cases or if I am away)

☐ **I will train my dog**

Training does not work if you only train with the trainer. I will put in the work at home for the program. I will be prepared for training, with the necessary equipment needed. This equipment may include: 6 foot leash, flat collar, Hermsprenger prong, martingale collar, muzzle, treat pouch with treats, toys.

Failure to comply with these statements may result in a pause or termination of training. By signing you have acknowledged the responsibility of training.

Liability Waiver

I, _____ (the Releasing Party), have enrolled myself and my dog in dog training classes, private consultations, workshops or other related activities offered by Lily Ray Dog Training, The Released Party.

By signing hereunder, I certify that I have been informed and understand that there is always some unavoidable risk of injury involved when working with animals, especially animals with behavioral issues. I acknowledge that dogs can be inherently difficult to control and that not all dogs will be under control at all times resulting in the possibility of injury to myself, my dog, my family members, or third parties. Additionally, I have had full opportunity to discuss all concerns I have about the foregoing risks with Lily Ray Dog Training and its authorized representatives. I have also made all inquiries and investigations to my satisfaction related to such risks, including, but not limited to, an examination of the training area (if applicable). I hereby accept and assume, without reservation, all risks associated with my participation in the Classes, including, but not limited to: the risks of any and all injuries to myself, my dog and any of my family members or third parties who may attend; the risks that my dog may cause injury to other persons and/or dogs while training.

As lawful consideration for participating in the classes, I, for myself, my heirs, executors, administrators, legal representatives, successors and assigns hereby waive, release, discharge and agree not to sue and to indemnify, defend and hold harmless Lily Ray Dog Training and their members, managers, agents, and employees from any and all injuries, losses, claims and damages to any person or persons of any nature whatsoever, including claims arising from the Released Party's own negligence, and all costs associated therewith, including attorney's fees, court costs and consultant fees, arising from my participation in the Classes.

This Waiver of Liability & Informed Consent Release shall be legally binding on the Releasing Party. Should the Releasing Party assert a claim to the contrary to what has been agreed to in this Waiver of Liability and Informed Consent Release, the claiming party shall be liable for all expenses (including attorney's fees, court costs and consultant fees) incurred by both the Releasing Party and the Released Party. No waiver or modification of any provision herein shall be valid unless expressly agreed to in writing by both the Released Party and the Releasing Party. Every provision herein is intended to be severable. If any one or more of the provisions herein is found to be unenforceable or invalid, that shall not affect the other terms and provisions hereof, which shall remain binding and enforceable.
