FIP:

Be aware that at this time FIP is still being studied. It is felt by university researchers to be a mutation from the common Corona virus for which there is no vaccination. The common Corona virus is estimated to infect approximately 94% of all cats. We do take steps to minimize Corona infection in our cattery, however, there is no way to prevent FIP. The effectiveness of the FIP vaccine is still controversial. Many researchers and veterinarians believe it can create enough stress on the feline immune system to actually cause the disease, others believe that it is completely ineffective. However, should this cat/kitten die from FIP within 1 year of living in its new home, Breeder will replace the cat/kitten with one of Breeder's choosing (all shipping costs are the responsibility of the Buyer) under the following conditions:

- 1) Complete necropsy, histopathology and microscopic examination of tissue by a trained pathologist must be performed by either by Cornell University Veterinary Teaching Hospital or UC Davis Veterinary Teaching Hospital.
- 2) Written and signed necropsy report from the University Veterinary Teaching Hospital must be received by the Breeder.
- 3) If you have a multi-cat household, two Corona Virus Titres, six (6) weeks apart must be performed on the remaining cats by Cornell University Teaching Hospital (this is a simple blood test, sent via U.S. express mail).

Be aware that the FIV vaccination can cause a titer that is positive for FIV. Should your cat be vaccinated with it and somehow be lost and end up in a veterinary office, rescue or shelter, and be titered for the disease, your cat may be euthanized because of it's positive status. Due to the current status of the FIP and the FIV vaccinations, we highly recommend that our kittens/cats NOT be vaccinated with them. And if given, be administered well after the kitten is established within its new home and well after all other vaccinations have been given.

Should the Buyer fail to comply fully with the terms of this Contract Agreement, the Breeder shall have the right to reclaim the cat/kitten and the Buyer shall waive any right, title or interest in the cat/kitten. The Buyer will be responsible for any and all costs incurred by the Breeder, including but not limited to, shipping, veterinary costs, Feline Leukemia testing and legal fees.

Breeder guarantees that this cat/kitten is free of disease, to the best of the Breeder's knowledge, at the time of Adoption. Breeder shall allow the Buyer **three (3) calendar days** for the initial veterinary examination and confirmation of health. Should the licensed veterinarian diagnose, through examination and/or testing, find a disease, other than stress induced minor upper-respiratory infection, the Buyer shall have the option to either: 1) immediately return the kitten for full refund (shipping costs are the responsibility of the Buyer), or 2) receive compensation for veterinarian prescribed medications and follow-up office visits resulting from the diagnosed illness, up to the amount of \$75.00 (written veterinary diagnosis and receipts required). Seller will not be responsible for any veterinary bills beyond those stated in this paragraph.

<u>VACCINATION RECORD AND PARENTS' LAB WORK:</u> Upon delivery, new owners will receive kitten(s) full vaccinations record along with parents' complete lab work and DNA test results – All Negative.
RIGHT OF REFUSAL: We reserve the right to refuse an adoption to any person, for any reason, without explanation. We don't just adopt out kittens to anyone with the financial ability to adopt one and we do not grant adoption privilege to just anyone. As such we reserve the right to be selective in that search. If we feel there will be a lack of proper care with the new potential owner, we have the right to refuse the adoption at any given time during the adoption process. Any and all deposits or adoption fees will be returned in full if we refuse the adoption. We only place our kittens into the hands of the best pre-approved homes. Acknowledgment
THE RESPONSIBILITIES OF THE NEW OWNER(S) ARE: To have your kitten examined by your veterinarian within 3 calendar days of receiving Kitten/Cat. If vet finds anything wrong, it MUST be reported to us IMMEDIATELY. ALL kittens adopted as a 'PET' have to be neutered/spayed ONLY AFTER 8 months of age. Proof of such must be provided to us. Neutering/Spaying prior to 8 months of age can stunt growth development and cause potential problems or complications for a small kitten.
