Drone Photography Session

There is a \$150 per half hour fee for drone photography/ videography sessions at our farm with a minimum of 1 hour per session. Sessions are always booked outside of our normal business hours and must be scheduled and paid at least 2 weeks in advance. Drone operators must have a proper drone license, availability is limited, drop-ins are NOT permitted, and booking is at the full discretion of Southern Grace Lavender Farm. To reserve a drone photography session, send an email including date and time requests to info@southerngracelavenderfarm.com.

Photoshoot location requests and an alternate weather date must be scheduled at the time of booking. Date approval, submission of payment, proof of drone license and this completed form will reserve your session. We accept cash, check or credit cards. Drones must remain in their carrying cases until the scheduled time slot and a SGLF employee is present AND has given the go ahead.

Our 2020 daily farm hours are 10 AM – 4 PM, Saturday & Sunday; and by appointment only, Monday – Friday. Trespassing is unlawful and not permitted. Our farm is open to the public, event goers, employees and fellow lavender lovers. Paying any fee does NOT give exclusive rights or access. Please be considerate and kind to others and respect our farm. NO PETS. NO REFUNDS. Southern Grace Lavender Farm reserves the right to refuse photographer access at any time for any reason.

The photographer(s)/videographer(s) and photographed party(s) hereby agree to the following:

1. I grant Southern Grace Lavender Farm, those acting with permission, or its employees, the permission to use photographs or videos I have taken or those of me and my family with or without my name for various purposes, including, but not limited to public relations, social media, advertising, web content, illustration and publicity. I understand that I will not be paid for these photographs and/ or video footage. I hereby waive any right to inspect or approve the finished photograph/ video or advertising copy or printed matter that may be used in conjunction therewith or to the eventual use that it might be applied.
