Principle 3: Community-led specific plan	88	27	 Ensure this process is driven by stakeholders and community input; not by the county or consultants. (3) Worried about political influences in choice of GAC and TAC Who are "stakeholders"? (3) Suggested addition: "factors in the needs and environmental land use priorities" Sonoma and Glen Ellen are very different from each other – is that a conflict? (2) Agree with the goal, but unlikely that it can be achieved in the stated timeframe while fully honoring stakeho Needs to be rooted in economic realities; remember that this will ultimately need to be a fiscally viable proje Efforts should be made to gather input from residents who are not well represented at the workshop. Ensure represented, including Native American and developmentally disabled communities, wineries, youth groups, service (2) Not everyone in the valley identifies with Sonoma or Glen Ellen. Surprised there is no mention of BZ Verance Hot Springs, and other communities. Specify immediate neighbors, not only general community. Must appreciate impact on traffic. Important to evaluate trade-offs as the planning process progresses. "Existing land uses in Sonoma County" is a very broad statement.
Principle 4: Housing	59	50	 Emphasize housing for very low income, homeless, and/or disabled residents (7) Ensure housing is compatible with open space, wildlife corridor, historical culture, and Glen Ellen; minimize environment. (6) Needs greater commitment to truly affordable housing options, e.g. tiny houses, container villages; think ou Define affordable housing (4) Pair housing with sustainable transportation options to serve the community; need a community-wide transport Clarify the term "reasonable." (4) Limit housing scale and density (4) Traffic and density impacts need to be weighed heavily. (3) Very remote location and limited transportation options make this site best for workforce housing (3). Concerned about quality and fit of housing for vulnerable populations, particularly disabled. Clarify the term "appropriate." If very low and low income, could incorporate residents caring for community areas, gardens, etc. Implementation needs great care, with developer working under exact guidelines. This is not necessarily congruent with location and accessibility. Add "with proper support services in place for vulnerable populations." Specify usage percent for affordable housing. Need an interim housing plan.

(3) Add "national state, and local historic preservation guidelines" (2) Native and ecological legacy is significant (2) This should include exhibition and education of wildlife based on community desires. Not to promote tourism; emphasis on local uses and education. Ensure architectural as well as cultural preservation. Preserve the character of the site's overall ambiance and scale of buildings in relation to land. 	
Principle 7: Governance	74	34	 Consider creation of a public trust to serve as implementing agency (9) Confusion about "will be considered"; rephrase as "a governance entity will implement" (4) "Governance entity" is vague; needs definition. (2) Consider interim uses. How will representatives be appointed?
