- Consider and act on request from BVFD for acceptance Texas Forestry Grant in the amount of \$15,000.00 with a share cost of \$1,500.00 (Wildland Gear)
 Roger Goodwin made a motion to accept the request from BVFD for the Texas Forestry Grant in the amount of \$15,000.00 with a share cost of \$1,500.00 for PPE. Diane Snavely seconded the motion, motion carried 5-0.
- 11. Discuss and act on letter to BVFD dated December 20, 2019. No action taken.
- 12. Consider and act on request for de-annexation from James Harris. Diane Snavely made a motion, the request does not comply with the statues and the City has not refused to provide services or to cause services to be provided. The developer failed to comply with the Owners Certificate on the signed plat of March 29th, 2017 as recorded in Volume 24, Page 116, Plat records in the office of the County Clerk of Grayson County, Texas. The Owner's Certificate stated: That I, Harold Deane Munal hereby adopt this plat as Munal Addition, an addition to the City of Bells, and dedicate to the public use forever the streets an easements shown hereon (if any) for the mutual use and accommodation of any public utility desiring to use or using same for the purpose of construction, maintaining, adding to or removing any or all of their respective systems located therein, and further, that the Owner(s) do hereby acknowledge the requirement of completion of all water and sewer collection systems (if any) and all street, curb and gutter, and drainage improvements (if any) at the expense of the Owner(s) and guarantee(s) the performance of same. Therefore, denying the de-annexation from James Harris. Terry Crumby seconded the motion, motion carried 5-0
- 13. Consider and act on placement and screening around dumpster at Panther Place Apartments. Tammy Hartline made a motion to table this item until the February meeting when the owner could be there. Terry Crumby seconded the motion, motion carried 5-0
- 14. Consider and act on review of the amended Planning and Zoning Ordinance.

 Tammy Hartline made a motion to give copies to the Planning and Zoning Board and have them come to the February Council Meeting to discuss. Terry Crumby seconded the motion, motion carried 5-0.
- 15. Consider and act on the following recommendations from Manhole Rehab Inc after the assessment of Inflow/Infiltration of the city's sewer system and manholes.
 - 1. Camera for sewer lines in the area of Hwy 56 and Hwy 69N in and around Roddy Field for connectivity and flow and other areas of concern.

 - 3. Free seized Manhole lids and inspect 9-10 manholes.

- Consider and discuss the nomination of new members for the Bells Economic Development Corporation.Roger Goodwin made a motion to forward the bylaws of Bells Economic Development

Corporation and also Bells Community Development Corporation along with a copy of Council Meeting of this date to the Presidents of each boards respectfully; requesting them to revisit their bylaws concerning the members terms in office and in regards to the election of officers with terms. Bells Economic Development Corporation Bylaws Section 2.01(d) and Section 2.03.1.a Bells Economic Development Corporation have terms expiring January 31, 2020 and we are seeking nominations for the upcoming expiring terms. Bells Community Development Corporation will also be facing the same in June 2020. Terry Crumby seconded the motion, motion carried 5-0
