NOTICE IS HEREBY GIVEN in accordance with order of the Office of the Governor issued March 16, 2020, the City of Bells will conduct a Regular Meeting scheduled at 6:00 p.m. on Tuesday, September 8, 2020, located at Bells City Hall, 203 S. Broadway, Bells, Texas by telephone or video conference in order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") to slow the spread of the Coronavirus (COVID-19) in accordance with Section 418.016 of the Texas Government Code.

Videoconferencing capabilities will be utilized to allow individuals to address the Council. The public will be permitted to offer public comments electronically, via chat, as provided by the agenda and as permitted by the presiding officer during the meeting. Public Hearing

For the purpose of receiving community input on the Budget, which will cover the Fiscal Year beginning October 1, 2020 and ending September 30, 2021.

This budget will raise more revenue from property taxes than last year's budget by an amount of \$16,099, which is a 4.19 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$4,101. Public Hearing

For the purpose of receiving community input on the tax rate of 0.546400 per \$100 valuation has been proposed by the governing body of City of Bells, which is a tax rate greater than the no-new-revenue tax rate. This means that CITY OF BELLS is proposing to increase property taxes for the 2020 tax year. The following table compares the taxes imposed on the average residence homestead by City of Bells last year to the taxes proposed to be imposed on the average residence homestead by City of Bells this year:
