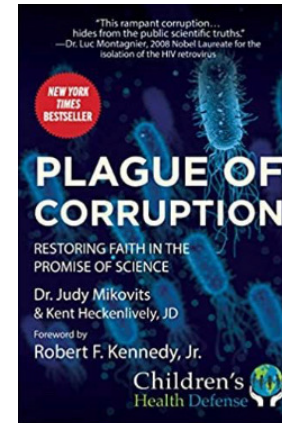
Secretary of State Hillary Rodham Clinton called for a renewed push for an “AIDS-free generation” in a November speech in the Clinical Center’s Masur Auditorium, marking 30 years of the fight against HIV/AIDS.

“The goal of an AIDS-free generation is ambitious, but it is possible,” Clinton said, emphasizing the use of scientific advances to stem the pandemic.

“We need to let science guide our efforts,” she told the packed crowd of scientists, administrators, and State Department and Department of Health and Human Services officials.

Clinton emphasized using a variety of tools in a “combination prevention” strategy as the most effective way to combat HIV/AIDS nationally and globally, with the focus on three key interventions: ending mother-to-child transmission, expanding voluntary medical male circumcision, and scaling up treatment of people living with HIV/AIDS.

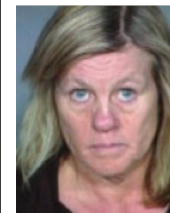
“None of the interventions can create an AIDS-free generation by itself,” she said. “But used in combination with each other and with other powerful prevention methods, they present an extraordinary opportunity.”

The pounding on the door of our boat-dock home located on Jamestown Way in Oxnard began at about 5:00 a.m. on November 9, 2011.



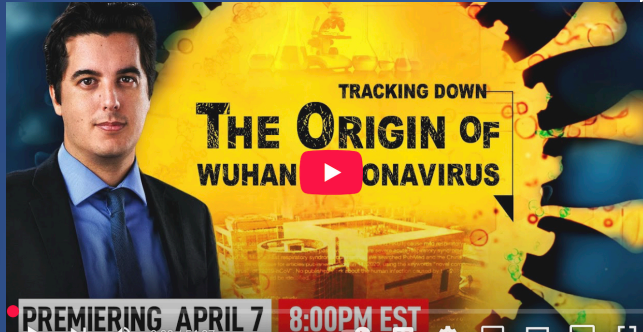
Controversial CFS Researcher Arrested and Jailed: By [Jon Cohen](#) Nov. 19, 2011

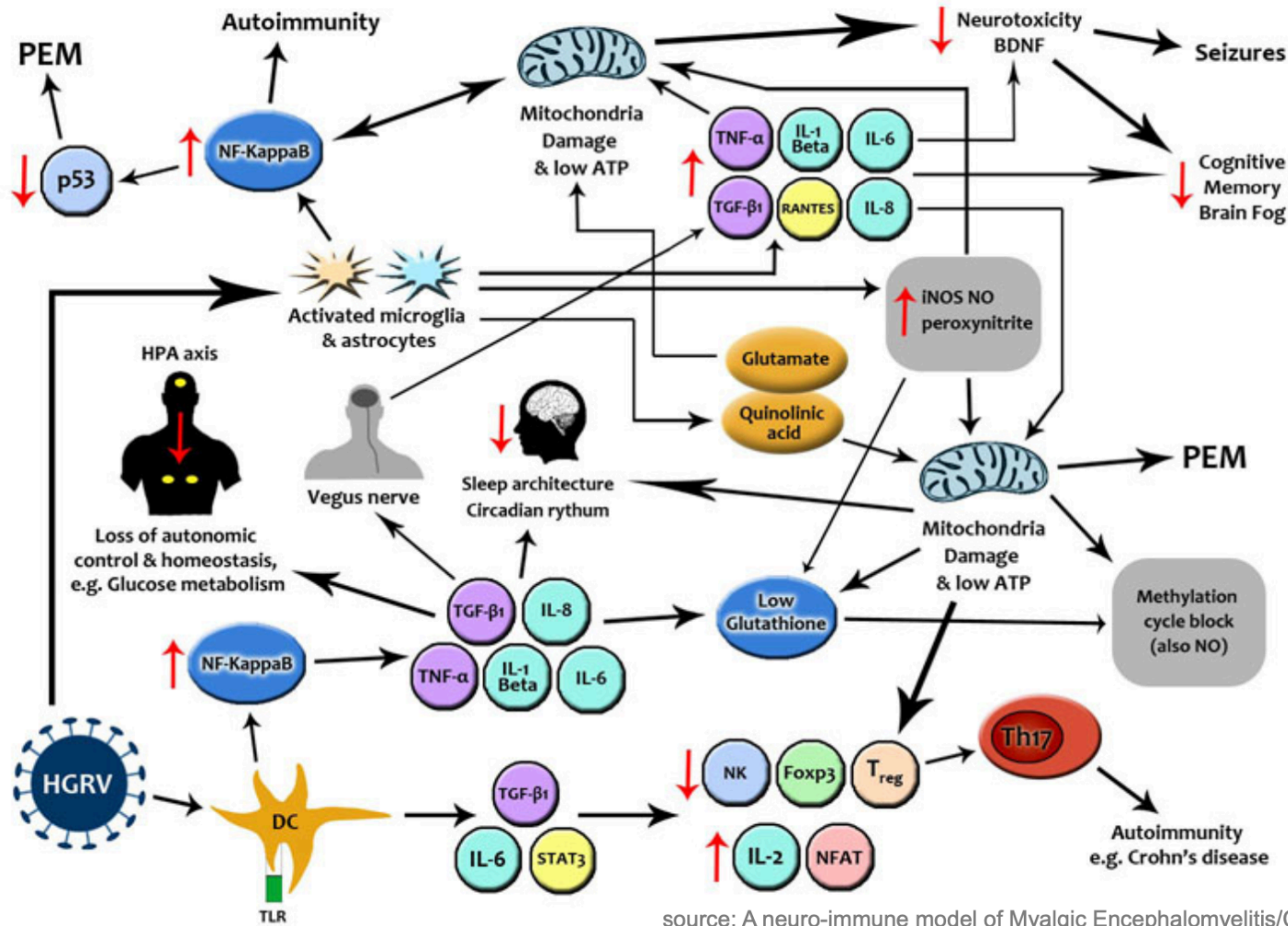

ABSTRACT

Botanical compositions comprising non-alcoholic organic extracts of Ganoderma lucidum, Salvia miltiorrhiza, and Scutellaria barbata for use in conjunction with bicalutamide therapy for cancer therapy, are provided. Methods for treatment or therapy of prostate cancer in a human is provided, the method comprising: administering an effective amount of a botanical composition that is effective for reducing androgen receptor protein expression; and administering concurrently an effective amount of a compound having anti-androgen activity, wherein the concurrent administration of the compound and the botanical composition achieves a therapeutic effect that is more effective than either agent alone.

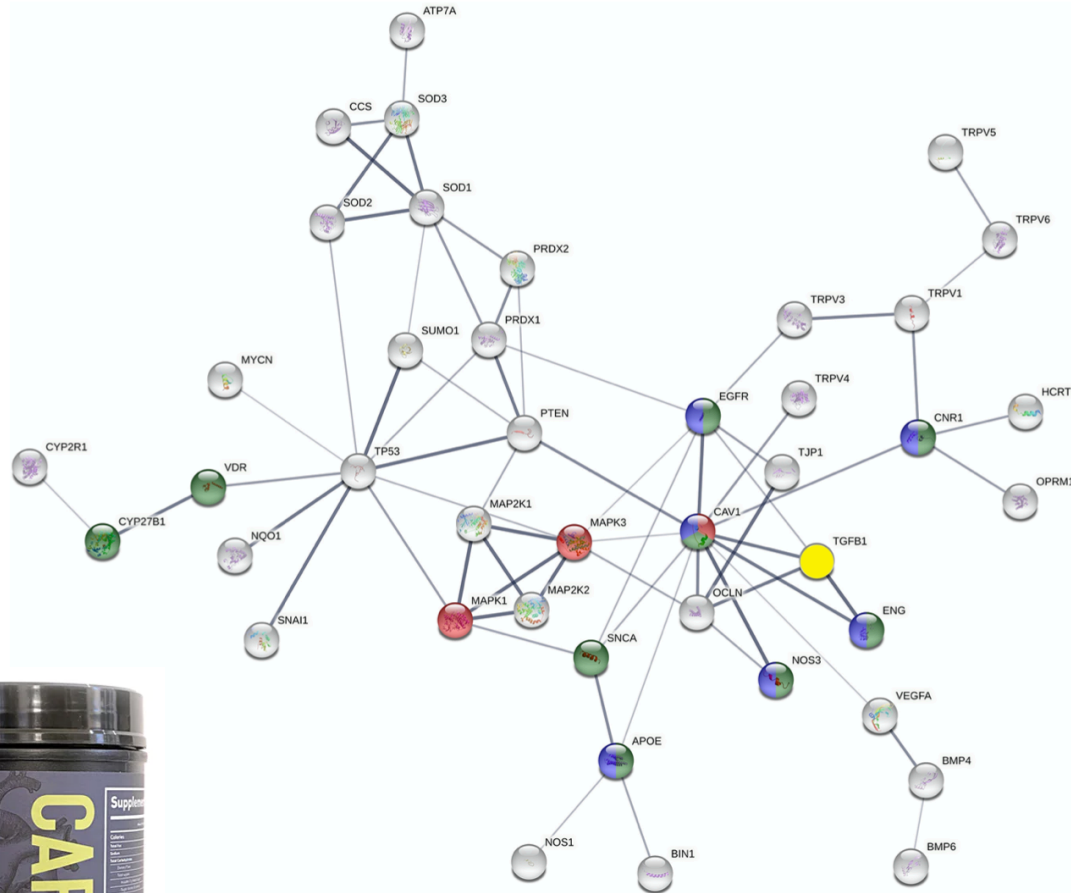

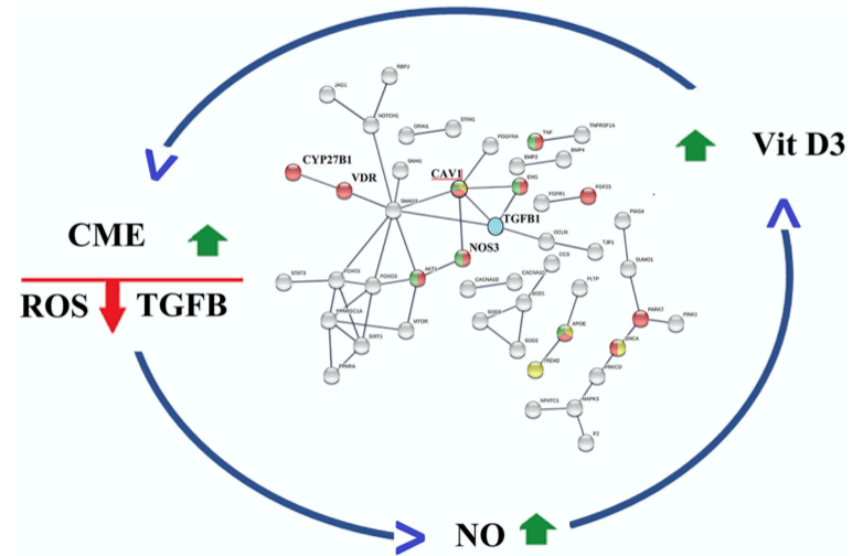

Caveola mediated endocytosis (CME) modulates activities of a reciprocal feedback loops that finetunes ROS production, TGF beta activity, Nitric oxide levels O and Calcitriol production.

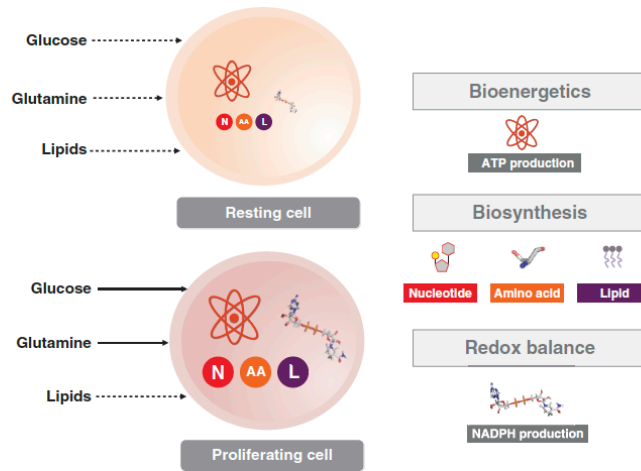


Figure 1. Metabolism: resting versus proliferating cells. Normal resting cells use a catabolic metabolism to satisfy the energetic requirements of homeostasis. This demand is met through fatty acid oxidation and the oxidative metabolism of glucose. Proliferating cells, however, must rewire their metabolic program to not only meet various energetic requirements, but to also satisfy the anabolic demands of macromolecular biosynthesis (nucleotides, lipids, and proteins), as well as the maintenance of redox homeostasis. Upon growth factor-mediated stimulation, proliferating cells increase their uptake of glucose and glutamine, which are the 2 primary substrates that fuel cell growth. Solid lines are indicative of increased cellular uptake.

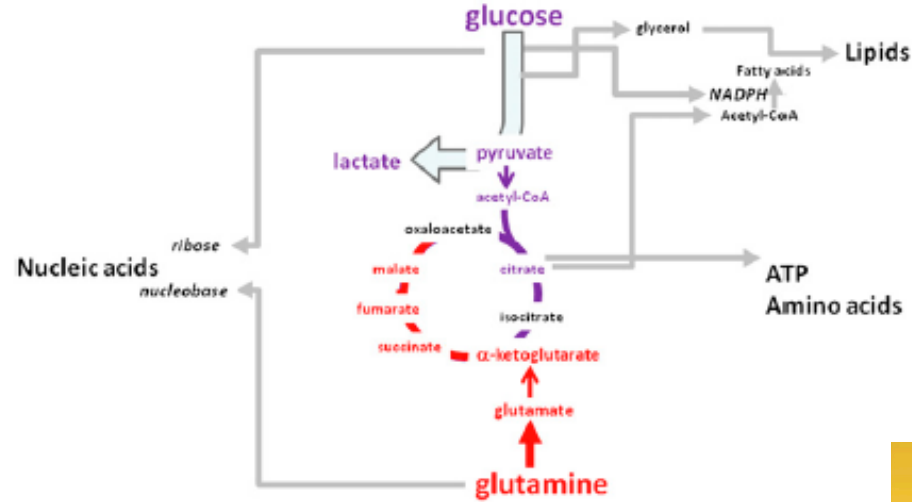
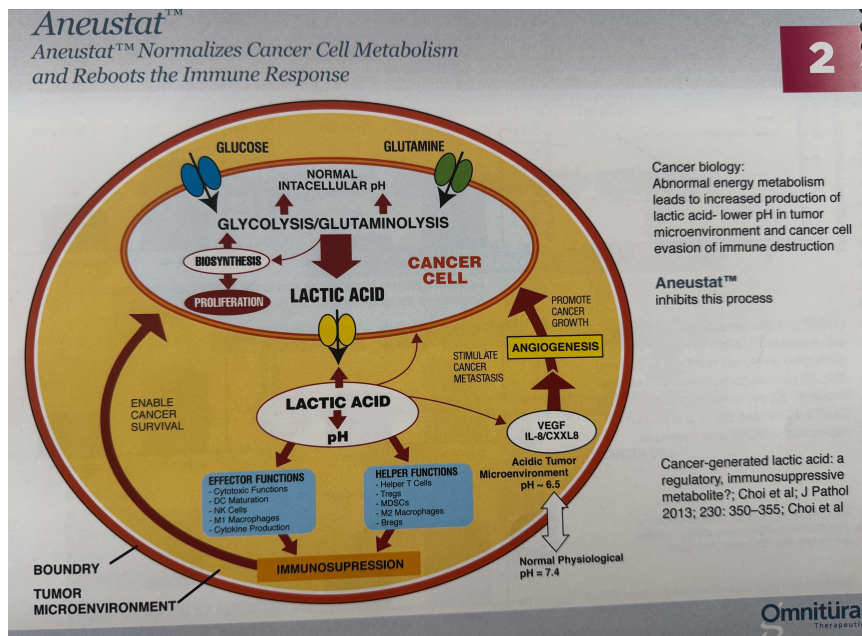


Figure 2. Hypoxic rewiring of metabolism. While aerobic proliferating cells use glucose and glutamine for biomass production through the TCA cycle, hypoxic cells shunt glucose to lactate and rewire glutamine metabolism. Glutamine can be used to drive the TCA cycle independently of glucose or contribute to lipid synthesis via IDH-mediated reductive carboxylation of ketoglutarate generated from glutamine.



Cancer biology: Abnormal energy metabolism leads to increased production of lactic acid- lower pH in tumor microenvironment and cancer cell evasion of immune destruction
