Depending on your location, lawful bases for processing may include consent, contract performance, legitimate business interests, or legal obligations.

4. AI & Data Use

We use artificial intelligence (“AI”) tools and technologies to enhance the quality and efficiency of our consulting services.

- **Client Data Protection:** Proprietary or sensitive business data you provide will only be used to deliver services to you, under the scope of our engagement. Your identifiable data will not be used to train or fine-tune general-purpose AI models.
- **Third-Party AI Services:** When leveraging third-party AI platforms, we require contractual safeguards to ensure data confidentiality, limited use, and compliance with applicable data protection laws.
- **Service Improvement:** We may use anonymized, aggregated, or synthetic data derived from client engagements to improve our methodologies, tools, and internal processes. This data cannot be linked back to you or your organization.
- **Transparency:** You will be informed when AI-generated insights or outputs are part of our deliverables. Human review and accountability are always maintained.

5. Data Sharing and Disclosure

We do not sell your personal or business information. We may share information with:

- **Service Providers:** Trusted vendors who assist in delivering our services (under strict confidentiality agreements).
- **Legal Authorities:** When required by law, regulation, or valid legal process.
- **Business Transfers:** In the event of a merger, acquisition, or restructuring.

6. Data Retention

We retain your information only as long as necessary to fulfill the purposes described in this notice, unless a longer retention period is required or permitted by law.
