Blanket portfolio protection of commercial loan or leased collateral without the need to monitor insurance.

Vehicle Service Contracts

Helps protect borrowers from unexpected repair cost while providing an additional revenue stream to the lender.

Credit Insurance & Debt Protection

Protects borrowers and their families in the event of unforeseen life events.

REAL ESTATE SOLUTIONS

Blanket Mortgage Hazard Insurance

A coverage alternative to lender-placed hazard certificates. Eliminates the need to track individual policies after initial verification.

Outsourced Insurance Tracking

Tracking of portfolios includes mail control, escrow reporting, letter cycles, agent contact, monitoring and placement.

Lender Placed Hazard & Flood (MortgageHazard.com)

Allows lenders to instantly cover uninsured properties online.

Blanket Mortgage Impairment (E&O) Insurance

Comprehensive Mortgage E&O coverage that protects lenders against uninsured physical damage or flood loss. Includes options to reduce or eliminate insurance tracking workload.

Protequity

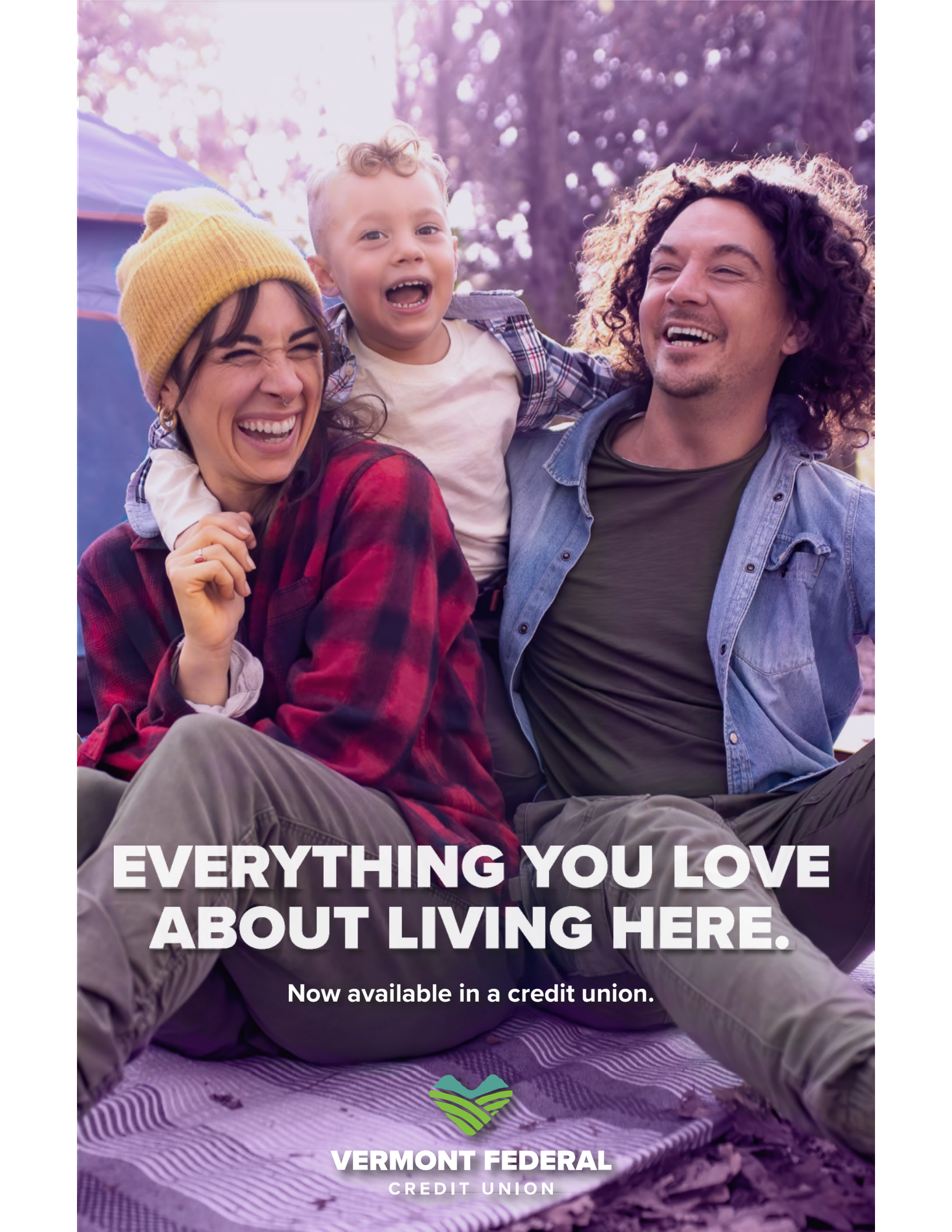
Allows lenders to increase loan-to-value for equity and second mortgages while being protected from loss due to borrower default.
