- If a parent/guardian decides not to send his ward after he has deposited the above-mentioned amount, the amount deposited towards admission fee will be forfeited.
- The Security Deposit is refundable only when the child leaves the school and after the final settlement of accounts, provided a settlement application for withdrawal of security deposit is made before 31st December in the year after which the withdrawal is sought.
- Transfer Certificate from the school may only be obtained on a payment of Rs.500/- and the final settlement of the child's accounts.
- The decision of the school authorities, in the event of a dispute as to the interpretation of these rules, is final and binding on the parents. The admission of a child to the school means a complete acceptance by the Parents of all school rules, as in force or amended from time to time at the discretion of the school authorities.
