# Helpful Voter Information

There are several things we suggest voters do before heading to the polls:

1. Check your Voter Registration - this can be done by clicking on the button below.

If you are unable to find YOUR voter registration information, you may register to vote in advance of election day. The last day to register to vote in the May Election was April 7th, 2022.

Register now so you can vote in run-offs or in November.

2. Read the Guide. Do your research. Learn about who is on the ballot.

We much prefer that you meet and speak with the candidates, however, we have provided links to existing Campaign Websites and Campaign Facebook pages.

This should help you narrow down your choices.

3. Verify the list of Early Voting locations by clicking the circle below.

All locations are included at the back of the Guide, however, they may change at any time, without notification, it would be wise to verify before you go.

4. Unless you are very politically active, you probably have never even heard of many of the candidates.

You are permitted to make a list of the people for whom you wish to vote and carry it with you into the voting booth.

## Useful Information

If you are a registered voter in Fort Bend County, you may be able to vote by mail if any of the following conditions would prevent you from going to the polls.

- Expected absence from the County during both the early voting period and on Election Day.  
(The ballot must be mailed to an address outside the county.)
- Disability
- Expecting to give birth within 3 weeks before, or after, Election Day
- 65 years of age or older
- Confinement in jail and not finally convicted of a felony



You must make a written request for a ballot by mail. In applying, you must:

- State the address at which you are registered to vote.
- Give one of the reasons listed above for requesting a ballot.
- Provide the address to which you want the ballot mailed. If the ballot is not being mailed outside the County, nor to the address at which you are registered, then you must provide a description of that such as nursing home, hospital, etc.

**You must sign the application** - signatures are required to match so you want to remember **EXACTLY** how you sign.

## Vote *For* or *Against* the following propositions

### Proposition A

The charter amendment to define the phrase “full City Council” to mean the full membership of the City Council as established by Section 3.03 of the charter.

### Proposition B

The charter amendment to increase the compensation of the Mayor and each Council Member by \$200 per month.

### Proposition C

The charter amendment creating a vacancy if the Mayor or a Council Member moves their residence from the territory from which they were elected and defining the term “residence.”

### Proposition D

The charter amendment requiring the City Manager to establish residency within the municipal limits of the City by no later than the first anniversary of the date of appointment and prohibiting such requirement from being imposed retroactively.

### Proposition E

The charter amendment authorizing the City Council to establish a filing fee and an alternative procedure to payment of the fee for an application for a place on the ballot and providing that the filing fee may not be refunded.

### Proposition F

The charter amendment to provide that no ordinance, resolution, or action of the City Council shall be subject to more than one referendum or initiative election per 12-month period from the date of the election.

### Proposition G

The charter amendment requiring a notice of intent to circulate a petition to be filed with the City Secretary prior to circulating a petition for initiative or referendum.

### Proposition H

The charter amendment to change the minimum number of signatures required for a petition for recall from 20 percent of the registered voters of the City to 20 percent of the registered voters of the territory from which the applicable office is elected.

### Proposition I

The charter amendment requiring that public hearings on the same subject matter be held not less than 24 hours apart unless otherwise provided by law and excepting joint public hearings.

### Proposition J

The charter amendment providing that no property of any kind shall be exempt from any special taxes, charges, levies, or assessments, except where required by law.

### Proposition K

The charter amendment to repeal Section 9.04 of the charter, being an obsolete provision for the manner of submitting the original charter to the voters.

### Proposition L

The charter amendment to repeal Section 9.05 of the charter, being an obsolete provision for transition elections held in the years 2017, 2018, 2019, 2020, and 2021.

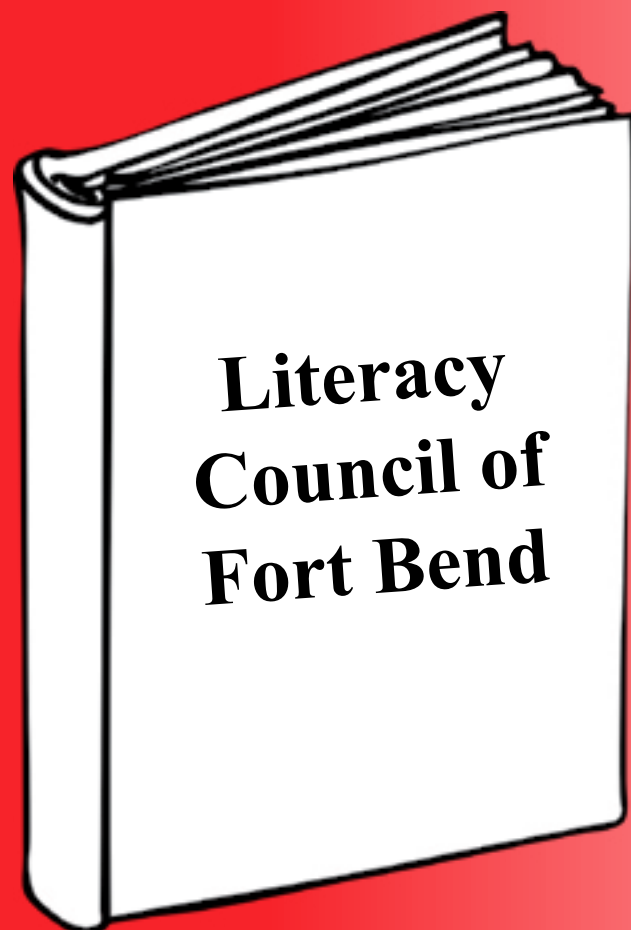

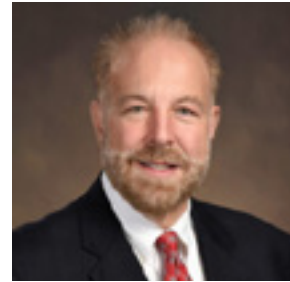

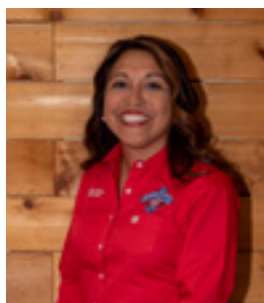
