

#### NEW Coach Learning Management System (LMS)

Over the course of the last year, we have been working towards the development of a new platform for all things related to Swimming Canada's NCCP.

This platform will allow coaches to sign in, complete their pre-tasks, register for a course, submit their portfolios, and view their training/certification status. Coach Developers will be able to view their class lists, communicate with their coach candidates, access course material, and evaluate portfolios. As administrators, you will be able to list all of your courses in the system, email your coaches, and view their training/certification statuses. This is an ongoing project that will be rolled out in phases as our technology allows. The preliminary target date for launch is September 2018.

We are very excited to be sharing this project with you. Please keep an eye on your inboxes as we will soon be testing various system functions and will be looking for your feedback.

## **NCCP Payment Model**

The CAC has recently made a change to its policy on professional development points and the maintenance of training and certification status in the Locker.

## Swimming Teacher Training & Certification Process

Listed below are the various steps to the training and certification process for Swimming Teachers:

- The Lifesaving Society National Office submits a list of qualified Lifesaving Society Swim Instructor and Lifesaving Instructor candidates on a monthly basis to the NCCP Coordinator. The list needs to include the following information in order for a Locker profile to be created:
  - Full name
  - Address
  - Phone number
  - Birthday
  - Email address
  - Date of evaluation



- Each month, a Locker profile will be created for the candidates, which will provide them with a NCCP # (the candidates will be sent an email from the Locker to verify their account)
- The training and evaluation for each of the candidates will be inputted in their profile by the NCCP Coordinator
- In order for candidates to become fully certified as Swimming Teachers in the NCCP, they will need to complete the online Making Ethical Decisions evaluation.
