## **IROSC TRIALS - 2022**

- a. The IROSC is organizing the trials for its members in Pistol and Rifle events on the 17<sup>th</sup> of September, 2022.
- b. The trials will be conducted in the following events at the given venue:
  - 1. 10M Air pistol /rifle NACIN, Faridabad, Haryana (9.00 am onwards).
  - 2. 25M Standard Pistol (M) / Pistol (W) .22 Manav Rachna Shooting Ranges, Faridabad, Haryana (1.00 pm onwards).
  - 3. 50M pistol (M) .22 Manav Rachna Shooting Ranges, Faridabad, Haryana (1.00 pm onwards).
- c. All matches will be conducted on paper targets.
- d. The scores achieved in the trials will be considered by NRAI for allowing the member shooters to participate in the Zonals / Pre-National championship (All India GV Mavalankar Shooting Championship) to further qualify for the National championship.
- e. The minimum qualifying scores as per para 1.4 of NRAI hand book are as follows:

- f. The 10M Air Pistol/Rifle event will be of 40 competition shots to be fired in 60 minutes.
- g. The 25M Standard pistol events for men will be conducted as follows:

| Stage | Number of series and shots       | Time limit for each |
|-------|----------------------------------|---------------------|
| 1     | two (2) series of five (5) shots | 150 sec.            |
| 2     | two (2) series of five (5) shots | 20 sec.             |
| 3     | two (2) series of five (5) shots | 10 sec.             |

#### h. The 25M Pistol event for women will be conducted as follows:

| Stage     | Number of series and shots         | Time limit for each   |

| Precision | three (3) series of five (5) shots | 5 min.  |
| Rapid     | three (3) series of five (5) shots | During each series of 5 shots, each shot shall be fired within 3 seconds with 7 seconds interval between each shot. The shooter is not permitted to raise his arm from 45 degrees to the vertical until the |

- i. The 50M pistol men event will be of 30 competition shots to be fired in 45 min.
- j. The participant will have to bear the cost of the ammunition, range and weapon charges for the 25m pistol event. The IROSC is in the process of arranging the weapons and ammunition for the members. However, in the event of weapons not being arranged, the 25M event will not be conducted.
- k. The 10m Air weapons are available at NACIN, Faridabad. The pellets will be provided by IROSC.
- I. A member can participate in either pistol or rifle events.
- m. The participants will have to make their own arrangements for accommodation and travel.
- n. The shooters participating in shooting competitions should appear like sports persons and no unsporting clothing should be used by the shooters and they should come to the ranges with proper uniform. The following shall not be used by the shooters during shooting competitions:

Chappals and sandles

Jeans

Sleeveless tops/mini skirts

All type of pants and shorts with external pockets like cargo pants and shorts

- o. The competitions will be conducted according to National Rules and Regulations as applicable unless otherwise stated. It is the responsibility of the competitor to be completely familiar, understand the competition rules of NRAI and it is so presumed when he/she signs the competition entry form and shall agree to abide by the said Rules.
- p. The decision of the Range official shall be final and abiding on all the participants.
- q. The shooting activities have inherent danger when firearms are handled inappropriately. While at the trials, the participants are required to strictly follow the Safety Doctrine and heed all commands from the range officer/officials.

NOTE: The shooters who have already played in any State tournament this year, in Pistol or Rifle events, are not eligible to participate in the trials.
