Purchase Contract/Health Guarantee

Congratulations on the purchase of your new puppy from Bitterroot Goldens!

We have made every effort to provide you with a happy and healthy puppy. Your puppy will be vaccinated and de-wormed as scheduled. You will be given vaccine records so that you can give them to your veterinarian to help keep your puppy healthy. Upon receiving your puppy, buyer has 72 hours to have the puppy checked by a licensed veterinarian. In the unlikely event your puppy is found to have a life threatening hereditary congenital defect at this exam, we will replace the puppy with another of equal value. You must notify us (Bitterroot Goldens) within 24 hours after this exam should there be any issues. If buyer does not have puppy checked by a licensed veterinarian within 72 hours, this guarantee/agreement becomes null and void. Puppy is guaranteed for One year from date of birth against life threatening congenital defects. If, within this time period, a life-threatening congenital defect is found, a replacement puppy will be given of equal value. The seller has the option to request the return of the puppy before any replacement is given. If this is deemed so, then the puppy must be returned to the seller with the registration papers within 48 hours at no expense to the breeder. The puppy must be accompanied by a written veterinarian report. Replacement will be subject to availability. The breeder is not responsible for any vet bills or expenses acquired by the buyer. If, in the unlikely event that the puppy dies within this one-year time period, due to congenital defect, a statement from veterinarian is required before any action will be taken by the breeder. If the cause is not known, and autopsy will be required. A diagnosis of coccidiosis or giardia, parasites such as these do not render a puppy unhealthy. This guarantee does not include non-life threatening or temporary disorders such as uneven bites, undescended testicles, demodex mange, injuries, inguinal or umbilical hernias, fleas, ticks or ear mites, kennel cough, intestinal worms and parasites, scabies, eye entropion and cherry eye and allergies. Breeder will not be responsible for parvo, distemper or corona virus after 48 hours of the sale. These diseases are highly contagious and can be contacted immediately after leaving the breeder. We will not be responsible for any illnesses that are diagnosed after this time period. Veterinarian check ups and vaccinations must be kept current for any warranties or guarantees to be valid. This contract is for the original buyer that purchased a dog from Bitterroot Goldens. If terms and conditions are not fulfilled, then this contract is null and void. Buyer agrees to ensure the puppies health by providing Instinct food, adequate housing and good medical care to keep health guarantee in effect. Responsible owner/buyers will provide puppy with routine preventative care and all immunizations and exams by a licensed veterinarian. Breeder commits to mailing AKC registrations to the buyer within 90 days if not provided at pick up. By signing below buyer acknowledges receipt of a copy of this agreement. Seller will not be responsible for any veterinary expenses, or any other expenses incurred by the buyer.
