Please note that clause 4 (2) of the Rules requires all members to contribute at least 1.5 hours per annum of their time to Co-op activities. Examples of these activities could include:-

- a) Attendance at a member’s general meeting
- b) Attendance at a community event organized by the Co-operative
- c) Staffing the Creative Retail space operated by the Co-operative.
- d) Assisting with any aspect of the day to day running of the Co-operative

Creator members will be required to sign an agreement and contribute a minimum 3 hours per month assisting with the running of the Co-operative. This is instead of the 1.5 hours per year, not in addition.
