

OFFICIAL SWEEPSTAKES RULES: Tiny Girl Big Trip with Tiny Girl Big Show

Timing. The Sweepstakes will begin at [3:00PM ET, 7/24/26,] and run until [11:59PM ET, 1/4/27] (the "**Entry Period**"). Sponsor's computer is the official time keeping device for the Sweepstakes.

Eligibility. The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia, who, as of the time of entry, are at least [AGE (18)] years of age. Void where prohibited or restricted by law.
