# **Resident Selection Criteria**

- 1. All Adult applicants age 18 or older must submit a fully completed, dated and signed residency application with application fee. Applicant must provide proof of identity. A Non-refundable application fee will be required for all adult applicants. Applicant may be required to be approved by a condo/homeowner's association and may have to pay an additional application fee or an additional security or damage deposit.

- 8.
