BOARD MEETING MINUTES 18 January 2007

Chairman Sally McCullough called the regular monthly meeting of the Longwood Homeowners' Association to order at 7:42 p.m. at the home of Jean Newell. The following were present: Sally McCullough, George McDaniel, Tom Sylvester, and Jean Newell. Absent were: Dale LeVey and Bill Harris. Sally McCullough requested Tom Sylvester to take the minutes.

The minutes of the 21 December 2006 meeting were distributed and reviewed. MOTION (Newell – McDaniel) Approve the minutes. PASSED (4-0)

The Treasurer's Reports for November and December 2006 were distributed and reviewed. MOTION (Newell – McDaniel) Approve the reports. PASSED (4-0)

OLD BUSINESS:

<u>LAWNS/SPRINKLERS</u> – George McDaniel reported that the lawn service is continuing to work on regular assignments and repairs to the centerline shrubs on the medians. He also shared that the main sprinkler valve on island #7 is broken.

<u>CANALS</u> – George McDaniel shared that the skimmer box is still missing. Sally McCullough said she would follow up with the city to see if they have the box. Resulting trash near the outflow box was cleaned up.

<u>FENCES</u> – Sally McCullough reported no success at this point with contacting the fence contractor who bid on fence repairs. She will check with Bill Harris to see if we need to look elsewhere for repair service. It was also noted that the canal chain link fencing was still not repaired by the shopping center. (Addendum: Dale e-mailed me on Friday, 1/19/07, to let us know that he would call the shopping center management to follow up on repairs needed to the recently damaged East canal fence.)

PORTOFINO - No action.

<u>LIGHTING/FLAGS</u> – Flags remain at half-staff until the 24th of January.

GAZEBO – No action.

WEB SITE – The web site has been updated with recent community news.

STORAGE – The holiday decorations have been returned to the storage site.

<u>DUES</u> – There are 3 unpaid 2006 dues amounting to \$603.00. Liens have been placed on these properties. To date, 198 homeowners have paid their 2007 dues and 77 remain outstanding but not yet delinquent.

NEW BUSINESS:

<u>POLICE ACTIONS</u> – Jean Newell reported a recent flyover and hover of a police helicopter. Sally McCullough thought it resulted in the arrest of a youth in Longwood relative to a robbery.

<u>COMPLAINTS</u> – Board members reported various problems with cars parked on lawns or sidewalks. The resident at 2594 Longwood Boulevard was spotted digging trenches in his front yard and inserting sewer piping that was channeled to the RV on the side yard. Jean Newell has a friend who works with such problems for the county and that person offered to contact the city for possible action. Sally McCullough also indicated she would call the city.

<u>MEETING LOCATION</u> – The next board meeting will take place on Thursday, 15 February 2007, at the home of Bill Harris (pending his acceptance).

<u>ADJOURNMENT</u> – Sally McCullough indicated that our business was completed. MOTION (Newell – McDaniels) Adjourn the meeting. PASSED (4-0) Sally adjourned the meeting at 8:35 p.m.

 garbage cans (out of sight). Do not park vehicles on grass. Park RVs/Boats/Campers/Personal Watercraft in
 back of house (behind a fence).
- Homeowners were asked to talk to neighbors who might need some assistance in keeping up their homes
- City code enforcement can assist you better than the Board when you have specific complaints. Listings of some City offices are on the Web Page; others will be added.
- The Board is not normally proactive in enforcing deed restrictions and code violations but rather operates based on specific written complaints from homeowners.
- If you have a valid complaint, submit a letter to any Board member.
- Board members, being homeowners, may initiate the complaint for fragrant violations

13 Fireworks Jean Newell

Jean explained that buying fireworks for farm use is legal, but detonation of fireworks is illegal (unless protecting your crops). The Police will be out on the 4^{th} of July looking for violators. Each year damage occurs to Longwood property from illegal fireworks.

17 **Melbourne Code Enforcement**

Ralph Keller / Gary Thron

Code Enforcement was invited to this year's annual meeting. Ralph Keller and Gary Thron gave a presentation on how Melbourne Code Enforcement works. They gave everyone present a handout on the most common code violations and a handout on watering rules. Their presentation included the following:

- Code enforcement is not proactive; almost all inspections start with a complaint.
- Complaints may be anonymous or documented by name.
- Complaints are public records and may be inspected by anyone.
- Up to 6 steps are involved in the process with last involving fines of up to \$250 per day for non-compliance of violation.
- The fifth step involves mailing a registered Letter AND posting the letter on a stake in the yard for all to read.
- The term Business License has been replaced state-wide with Business Tax Receipt.
- The grass area between the sidewalk and road is called an easement.
- The local Code Enforcement officer for Longwood is Matt Daszuta (674-5701); he works for Dan Porsi.
- Garage sales are limited to two household per year.
- Overgrowth must be 12" high to warrant a violation.
