Annual Dues 8 unpaid annual dues from 2011. 2012 dues have been paid by 178 (64.7%) homeowners at the end of December, 2011. 81.5% (224) have paid their 2012 dues by 1/19/12. The report was moved, seconded and accepted by the board. A request was made for an update on the preparation of a letter and billing for Portofino for past canal usage. The Treasurer indicated he needs to retrieve the records stored in our long-term storage facility in order to due to recalculations for the billing and will check with Bill Harris for access to the storage facility.

Copies of Mailboxixchange price lists for the mailboxes were shared indicating a cost of \$30,599.00 for a total of 38 mailbox units. Total for the entire project estimated at \$42,899.00. June Lewis will contact USPS to get their requirements to be sure the bids match up with their needs and our funds. Mike confirmed that Gary Cunningham still intends to store the mailbox units until installation. It was hoped that the project could be completed before the annual meeting.
