NOW, THEREFORE, Declarant hereby declares all of the properties more particularly described as:

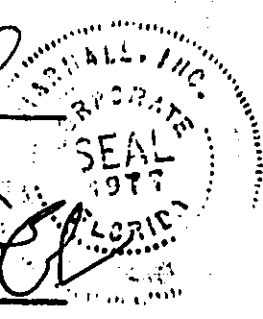
