Once those happen, we hope to hear some positive results. Cross Lake and Pokegama are also both working together with the DNR on a pan fish initiative. Part of the initiative is to work on the quality of the pan fish size and increase the population in the lake.

The draft of the Bylaws should be on the website by October 1, 2020, for review and a finalization vote at the May meeting. If you have any questions relating to any changes, please email me. Some changes are housekeeping and outdated language to comply with the Minnesota Statutes 317A for nonprofits. You may or may not be aware that CLA is a registered 501(c)(3) with the Federal government and is considered a Charity with the Minnesota Attorney General's office. With that in mind, our main purpose is water quality and the improvement of the lake and river as stated in the Bylaws.

On another positive note, the plus side of the lockdown seems to have more people out enjoying the lake with the great weather we've been having. Our family has been on the lake almost every day with our grandchildren, their favorite All Members are encouraged to apply, activities being of course pulled on the tube. These pancakes are really yummy and a great fall breakfast treat. If you haven't had a chance to try something like this, you will thoroughly enjoy it! Happy cooking!

Ingredients:

- 2 cups all-purpose flour
- 2 tablespoons brown sugar
- 1 tablespoon white sugar
- 2 teaspoons baking powder
- 1 teaspoon baking soda
- 1/2 teaspoon salt
- 1 cup pumpkin puree
- 1 teaspoon ground cinnamon
- 1/2 teaspoon ground ginger
- 1/2 teaspoon ground allspice
- 1 egg
- 1 1/2 cups milk
- 2 tablespoons vegetable oil
- 2 tablespoon lemon juice
- 2 teaspoons grated lemon zest
- 1 teaspoon vegetable oil



Instructions:

- 1. Combine flour, brown sugar, white sugar, baking powder, baking soda, and salt in a large mixing bowl, and whisk together for two minutes to aerate.
- 2. In a separate bowl, combine pumpkin puree, cinnamon, ginger, allspice, egg, milk, 2 tablespoons of vegetable oil, lemon juice, and lemon zest. Mix in the flour mixture, and stir just until moistened. (Do not over mix.)
- 3. Coat skillet with 1 teaspoon vegetable oil over medium heat.
- 4. Pour batter into skillet 1/4 cup at a time, and cook the pancakes until golden brown, about 3 minutes on each side.

Safety Around the Water by Joe Paget



This past week Minnesota boaters have been involved in a number of tragic incidents, including:

- A skier striking a Sheriff's boat
- A 24 year old drowning after falling off an inner tube
- Two individuals injured after falling off the the front of a moving pontoon boat

All of these incidents are tragic and life changing for those involved and their loved ones and can be prevented!

Be a good example for passengers in your boat, as well as for others sharing the water around you. Navigate at a safe speed with plenty of space between other watercraft.

If you are unsure of your swimming skills wear a proper personal flotation device (life jacket). Finally, operate your watercraft within the recommendations of the manufacturer. Enjoy the lake- safely and responsibly.





Hi Lakers!I thought it would be a good idea to give you an update on what the Water Quality Committee has been focusing on throughout the year and how we've utilized funds.

As you know due to COVID, everything has been at either a standstill, shut down or, at a snail's pace this summer for anything water quality throughout the State. We started off this spring barely getting our lake spot checked for invasive species by the DNR.

One of the reasons were able to get checked was the ability to get the permission to spray signatures in a quick hurry. I'd like to thank everyone for your extraordinary quick response to get them back to me. It was definitely a team effort! You made this happen for Cross Lake. Other lakes in the area were not so fortunate and were not tested this year for AIS, so I'm counting our blessings.

Every year in January the Lake Association applies for funds with Pine County to help out with AIS awareness and prevention.

Cross Lake was awarded the following amounts for 2020:

AlS Control for Cross Lake and the Snake River near the railroad bridge: CLA was granted \$6,000 to treat Eurasian Water Milfoil and Curley Leaf Pondweed. CLA spent a total of \$497 on Eurasian Water Milfoil and \$2,039.30 on Curley Pond Weed for 2020.A one-time application is applied each year.

County Wide Zebra Mussel Detection Program: \$500 - total spent approximately \$500.

County Fair - Education Giveaway Items (pens, magnets, key floats, etc.: \$3,500 was granted. The Water Quality Committee will discuss at their next meeting what we could do for the 2021 fair booth.

Educational Mailings. \$2,000. In Kind Contribution is \$200. Pine County has allowed CLA to submit the cost of the yearly new letters. So far this year we have spent \$800. Our mailing is around \$800 to all members. By end of year we will have spent approximately \$1,600.

The Zebra mussel plates were put together in July. A total of 80 were made. Directions will be included with each plate on how to use them and identify Zebra mussels. Please email me at maryreuter@gmail.com and I will be sure you get one. We will be distributing them as requested. Otherwise, we will distribute at the May 2021 meeting.

I Attended a class with the University of Minnesota called **Aquatic Invasive Species Management 101**. The class was tailored to learn more about aquatic invasive species (AIS) management, improve one's understanding of AIS management strategies, and looking at new AIS control efforts for lake improvement.

AIS Early Detection Training: (up to 15 individuals) County Lake Associations \$3,000. I attended an Aquatic Invasive Species Management 101. The tuition fee was \$50.

Topics covered during this course included:

- An introduction to AIS control and aquatic plant management.
- A better understanding of pesticides, how they work, and the regulations surrounding their use.
- Insight on non-chemical treatment options.
- A better ability to understand and evaluate management outcomes.

The Water Quality Committee continues to meet every other month. If you are interested in being a part or would like the email updates for events, meetings or classes or what we are planning for 2021, please email me and let me know and I will add you to our email list. Topics covered this year was strategic planning for the future, looking at new ways of controlling phosphorus in the lake.

DON'T MISS OUT ON AN OPPORTUNITY FOR SHORELINE RESTORATION

I have something going on here that I'd like Cross and Pokegama Lakes to think about.

Jill Carlier, District Manager for Pine Soil and Water is asking Cross Lake and Pokegama residents to think about a cost share initiative that she would like to implement in 2021.

Currently Big Pine Lakes Association has been working with Aitkin SWCD (on the Aitkin county side of things) to do small shoreline projects. The projects are cost-shared so the district pays for a portion of each project. There is a specific consultant/contractor that they work with. Someone designs the projects, and hosts a workshop at the property of the project. The landowner invites their fellow lakeshore owners to help with the labor.

The lakeshore owners learn about healthy shorelines/buffers/plants, etc. from the workshop, and provide much-needed labor. The landowner gets the project installed without any labor charges. (They do typically provide lunch the day of the workshop). These projects typically don't involve much (if any) excavation – it is typically all plantings. If excavation is necessary, a contractor will handle that end of it.

The workshops have been very successful and the landowners are really happy with them. Pine Soil and Water District is currently doing a pilot this year on the Pine County side. The contractor is great to work with and has approved 6 projects so far. **There still are funds to do projects**. The projects are all pretty small (under \$5,000) since there is very little excavation involved.

If you are interested in doing something like this or if you would be interested in helping out at one of their workshops to see how it rolls please contact Jill. This could be a really beneficial program for all lakes in Pine County. Jill would like to offer it Cross and Pokegama lakes first for next summer. Please think about it, talk about it, and let Jill know. If you are interested in the next workshop let her know that to and she will get you in touch with the landowners.

More Money Available or Shoreline Restoration through the Snake River Watershed Management Board

For 2020, the Snake River Watershed Management Board set aside about \$76k for projects for Snake River.75% of this funding was set aside for projects in the "restoration" sub watersheds in the Snake River. Cross Lake is in a restoration sub watershed so about \$57k is available to residents of Cross Lake.

As of May, there has been only one project brought to the Board and approved. There still is quite a bit of money to allocate. The good news is, it doesn't disappear if it isn't spent, but it would be great to get some conservation going in the ground. So, don't panic if you feel you missed this opportunity, the same amount of funding is set aside for 2021.

There is potentially a 25% - 50% cost share to a project, which is at the Board's discretion, as well as a written contract.

A rain garden style project and a stream bank stabilization are currently being done on the Snake River east of Pine City funded through the Snake River Board. If you would like to get in on this cost sharing opportunity contact Twyla Hill.

Secchi Disk Monitoring - Why Monitor?

As part of the water quality initiative, Don and I have been testing the water on Cross Lake with the HACH Quanta Hydrolab this summer. One of the other tests we do is testing water clarity using the Secchi Disk. The disk a very simple piece of equipment that can tell a high-level story on the condition of the lake and river.

How to Use a Secchi Disk

Secchi disk depth is the simplest and one of the most effective tools for estimating a lake's productivity. The Secchi disk, is a metal disk that is 8 inches in diameter with a cord attached to the center. The cord has a black mark at one-foot intervals and a red mark at six-inch intervals. To use, lower the disk on the shaded side of a dock or boat until the disk disappears from sight then raise the disk until it is again visible, Record the depth reading to the nearest half foot.





The Secchi depth is a measurement of water clarity. Water transparency directly affects the amount of light penetration into a lake. Algae and suspended particles from erosion make the water cloudy and decrease the Secchi transparency in a lake; therefore, the lower the Secchi depth, the higher the algal concentration and lake productivity. Because a lake can vary in water transparency seasonally, it is important to take numerous Secchi disk readings throughout the summer. It is suggested that testing be done at least once a month from May to September, however, every two weeks is even better. Rooted plant growth is generally taken to be limited to twice the Secchi disk reading at lowest seasonal depth reading.

CLA has collected data throughout the years and we can now use it analyze water quality trends. The Secchi disk can help us see if there are high levels of nitrogen and phosphorus which most often come from agricultural run off or waste water – e.g. a mixture of storm water, industrial wastewater, domestic household waste, and resulting residues running off of land into the lake and river.

The ability to look at water quality trends over years can help us see if the water quality of the lake is improving or declining. This summer we have tested the original three areas: Norway Point, the mid-east side of lake, and mouth of River entering Cross Lake at deepest part (30 ft). A comparison for July 2019 and July 2020:

In feet	Norway Point	Mid-East Side of Lake Mouth of River into Cro	
July 2019	5.5	4	4
July 2020	4	4	5
Aug 4, 2020	3.5	3.5	3.5
Aug 18, 2020	3.5	3.5	3.5

In August we added 3 additional areas to test:South end Bay, and two areas on the Snake River, one by the boat landing and the other by Snake River bridge. We are also looking at possible winter testing.

Lake and River Testing

OK, I am not qualified for a "Lake Detective" title but I love the sound of it, and it is a tip-of-the hat to Joe Suecheri (surely misspelled) a fellow alumni of Hill High Maplewood and it is something I aspire to.

What I have been focused on is restarting the lake and run-off testing. I had been assisting Jerry Trent last year in run-off sampling, but I had not been involved in lake testing. Jerry is the father of testing here for us and we owe him a great deal for the amount of time and effort he put into testing in our watershed. From all of us Jerry, Thank You! Jerry however is no-longer a spring chicken and he has asked me to assume responsibility for this work, as he now needs to step back and not do the field work any longer. I am honored that he thinks that I will be a suitable replacement for him in this work.

Our current status is this: Mary Reuter and I have been doing lake testing for the last 2 months. We are taking meter readings and sampling at 3 spots on the lake. These are the historic testing sites, and I believe we need to continue testing at the same locations as this establishes our historic baseline data. Baseline data is the key to understanding data as single data points have little value and provide not much in understanding about what is going on in the lake. My understanding of how these 3 locations were selected is as follow:

Snake River Inlet. This is sampled at the deepest point of hole formed just after the snake river enters the lake. It is testing parameters on what is basically the river waters themselves.

Mid-lake region east shore deep water: This is intended to represent the lake waters in their entirety.

Norway Point: This sampling is done just south of Norway Point in deep water. The selection of this point was the idea that most of the, "dirty waters", entering the lake was from agricultural sources at this end of the lake.

Regarding stream and run-testing there has been no testing this year. This testing is usually done only after significant rains. I do have hopes of getting this testing on-line yet this year. The hard part is always just to get started.
