So many questions ran thru my head the day the news hit social media. Where? What? Who? followed the threads meticulously trying to decipher fact from fiction. Is it tents? Is it RVs? It is a marina? Where exactly is it? There was so much conjecture and rumors on Facebook, I wanted to find a way

way for the Association to provide value to its members by getting this candid audience the details. I didn't know the details so I thought, why wouldn't we just go the source and get the Hegge's to spell out their plans in a fact-based article to the residents of Cross Lake? I wanted our members to have the details as best as they could be conveyed to form their own, educated opinion and how they could get involved, if they so choose. Little did I know what a heated topic it would become.

In the midst of it all, I managed to lock horns with fellow board members and despite the disclaimer, some interpreted the publishing of the article as the Association being in support of the campground. Neither of which was intended or desired. I didn't have the facts and rather than try to make them up, I figured why not go to the horse. Seemed like the logical path, at the time.

What is Our Role?

I am not here to justify the article or the decisions to include it, but it does beckon the question, what is the Association's role in these matters? I looked to our bylaws for guidance, no such luck. I reached out to sister lake associations for their experience, as well as reaching out to zoning authorities to educate myself on what capacity the Association could potentially have in these matters. Talk about a crash course in zoning!

The Association has about 200 households that are members of the total 600 properties around the lake. At best, at any point in time, regardless of what stance we take, we "might" align with about 50% of the 200 members. The numbers don't add up for the Association to take an official position on development. Literally, political suicide. As individuals we are entitled to our opinions but as an Association, we must try to remain neutral. That doesn't mean that we aren't involved and that we can't add value.

What Can We Do?

One example of what we are doing is conducting a Recreational Carrying Capacity Survey on the lake. We heard over and over through the zoning hearings, social media et al, how busy residents felt the lake is. This survey will provide a statistical baseline to use further discussion on potential impact the lake and its ability to handle the capacity proposed development activities. LimnoPro Survey Update By: Mary Reuter

Hello Lakers! Summer is in sight! I wanted to explain some of the findings from the Limnopro survey and all the various types of plants you may find along your shoreline. I hope I can help you understand why your lakeshore may not be getting treated for invasive species (AIS), although you may find an abundance of plants in your beach area. (Photos to follow on the next page). The information in this article is from the Limnopro survey 2021 CLA that was conducted last summer. You can find the full Limnopro report on the CLA website. The report summary was written and prepared by Daniel C.

The Water Quality Committee will participate in the following activities this summer. On May 21, we will be a part of an environmental festival for the Pine City area. It will be held at Robinson Park from 11:00-3:30 after the annual meeting.

Aquatic Science, Inc.

The Committee will be having a booth and doing a demonstration. We look forward to seeing you there! If you're interested in volunteering, please reach out to me. End of May or early June the Committee will be conducting a boat count survey on the lake this summer. A study like this

will show the recreational carrying capacity of a lake. Such a study will show the amount of development a lake can tolerate before it deteriorates. With the help of Caleb Anderson, from Soil and Water, will help map the project. The subcommittee will need people to help with the boat count at the two boat landings; what the survey may show is if there is currently an overload of boating. Excess can lead to poor water quality, negative environmental impact, decrease in

safety, potentially reduced lake enjoyment, and reduction in property values. With the significant



increase in current and potential development on Cross lake, such a study could provide valuable baseline data now and for the future. Email me and let me know if you want to volunteer for this project. August - Pine County Fair booth. The Water Quality Committee puts together various water quality displays at the county fair

every year. We have been able to display materials from the U of M Duluth, but we are always open to suggestions for new concepts, such as


demonstrations etc. If you have a display you'd like to see, please contact me or Joe Paget who is the Chair for the Fair Committee. June thru September. The Water Quality

Committee also conducts several types of water testing on the lake, such as E. coli and phosphorous. We also check water temperature, dissolved oxygen, conductivity, depth, and turbidity with a Quanta monitoring system. Water samples are also collected and sent to a professional lab in Duluth to check on different pollutants. This year we are collaborating with the Minnesota Pollution Control Agency to monitor seven streams in addition to the lake using a Secchi disk and tube. The data we collect throughout the summer will be sent to MNPCA for analysis.


Data sheets will be submitted to MNPCA at the end of the season. Let me know if you'd like to help.



Cross Lake (18015500) Sediment Type (06/21/21- 08/17/2021) Cross Lake Association





The four maps show the new areas that will potentially be treated for curly leaf pondweed and eurasian water milfoil this spring. The DNR has not conducted the rake toss as of yet. Once that is completed, we will know what areas will be given a permit to treat and lake management will come out to spray. Treatment is 150 ft. from the shoreline. Only the two invasive plants are treated. (Not shown is an area from the trestle bridge to the mouth of the lake that is also treated) North and middle of the lake prior to the dam.



WHATIS A WEED?

Dear Lake Association members:

I wish to write a very basic piece about weeds and lake weeds. In part I am embarrassed to write this, as I believe most everyone knows what I am going to be covering, at least if they stop and think about it.

WHAT IS A WEED

Some plants everyone can agree are weeds is easy. Common weeds are plantain, dandelions, creeping charlie and lamb's ear. These are unwanted nearly universally. Now let us think about this like a farmer or a gardener. The best definition for this is a weed here is any plant growing where you do not want it to grow. A potato in a corn field is a weed. It won't be



cultivated, cared for or harvested. It is in the way. The potato is consuming fertilizer and water and the field is improved if it is not there. A petunia in an onion patch, same thing, it does not belong there, it is a weed. I know this may rankle some feathers, but it is a weed. A plant growing where it is unwanted.



Going from the field to the lake however, we need to think how we got here and where we are now. Historically any plant growing in the lake is a weed. Folks did not connect any good with plants in the water, weeds were a problem. Plants made it hard to access the lake. Plants were undesirable to swim in. Plants fouled propellers. Plants made it harder to fish. So that makes any plant in the lake a "lake weed", a plant growing where it is unwanted. In today's world aquatic biologists try to teach everyone that we must have plants in a lake. Plants provide shade and oxygen. Plants are used for fish reproduction and fish rearing. Plants provide life to all waters. Further, we know of two basic "types" of plants in lakes and rivers. These plants are Native plants and Invasive plants. Native plants we understand as those which have been in our waters for many thousands of years. Invasive plants were introduced to our local waters from elsewhere in the last 200 years. Invasive plants have a bad habit of taking over a water body, as the factors that limited growth in it's natural habitat are absent. Native plants -"good'. Invasive plants - "bad".

In Cross lake and the Snake river watershed we have two species of invasive plants, curlyleaf pondweed and eurasian watermilfoil. Present also in Cross Lake are an additional 29 species of aquatic plants. The problem in Cross are too many individual plants of the invasive types and low individual numbers of the native plants.

When we talk about lake weeds is is just better to use invasive and native plants and not use the words "lake weeds". Our Lake association has and will continue to try to contain and remove invasive plants on the lake. We do not remove or treat native plants anywhere on the lake. We do not know of an effective way to treat invasive plants on the river at this time. Thanks for taking the time to follow me through this.




The Lake Association Booth

RULES OF THE ROAD By: Shanie Berry



As we gear up for another busy season on the lake, it's a good time for refresher of the rules of the "road". There is nothing worse than a beautiful day on the lake and some ding-dong flies by, sending the kids flying, soaking the sandwiches or **WORSE!** (I perish the thought)

It's evident that pretty much anyone can just get in a boat drive it. The kids, the wife and even the dog...no license required nor an ounce of common sense. As parents, grandparents, and lake property owners, we have a unique opportunity. Get them while they are young! Consider encouraging/requiring your kids, their friends, and your guests to be familiar with the rules of the road. The MN DNR has an excellent Boating Safety course that they endorse, that provides a great online learning experience.

I've taken it and will probably do a refresher this season, as well. I was born and raised houseboating on the Mississippi and have been on and around boats my whole life. I would have considered myself pretty boat savvy. Nope! I'll be honest...I learned a **ton** from the course. We've required our daughter to



complete the course, her friends, and regular guests to be certified before anyone jumps in the driver seat of a jet ski or at the helm of a boat. Our hope is to make for one less 'ding-dong' on the lake and make it safer and more enjoyable for everyone. I hope you will

consider doing the same.

But there is more! This course is not just for the kids. I think it is a great course for all skill levels. I would encourage everyone to take the course. It covers more than



just safety; it includes maneuvering techniques and boat operational items. It's online, an easy read, you can start and stop as often as you like. I believe it is even free up until the point of certification if you so choose to certify.

Top 10 Rules of the Road

According to the MN DNR, the top 10 rules to respectful boating are...(Cue the Tonight Show music)

Remember, these are guidelines and should not serve as a replacement for learning the rules, regulations, and laws for your local body of water. Whether you're a novice or veteran boater, learn more by taking a boating safety course.

- **1. Respect the ramp**. Good boating etiquette starts before you enter the water at the dock. Prepare your boat and equipment before getting into position to launch. Anything else is disrespectful to fellow boaters.
- 2. Own your wake. The fastest way to make the wrong kinds of waves is to literally throw a big, obtrusive wave at another boat, swimmer, angler, or shoreline owner. This is much more than being a nuisance or disrupting others' experience on the water. It's dangerous to those unable to tolerate a large wake. Stay at least 200 feet from the shoreline and other boaters.
- **3. Keep the tunes in check.** Sound is amplified over the water, so keep the music at a decent level. Not only is it a disturbance to others but the operator may not hear the spotter.
- **4. Pack in. Pack out.** Seems like common sense, right? Yet shorelines are still lined with trash being thrown overboard. Take care of the body of water you love and dispose of any trash you have. Do not throw it overboard!
- **5. Slow your roll.** Does the body of water you're on have a speed limit or slow-no-wake restriction? It's your responsibility to know it and respect it. You are responsible for any damage you cause to other people's property.
- **6. Rules of the road.** Become familiar with waterway markers and navigation rules, which dictate how you operate your vessel to prevent collision.
- **7. Be prepared** .If you are the captain, you need to be prepared with the safety rules for your craft and make your guests aware as well. Know state and local laws for the body of water you're on. Set a good example by always wearing a life jacket and have enough life jackets for each person onboard. Beyond that, make sure to have the appropriate fit.
- **8. Fuel and go.** At the fuel dock, get fuel, pay your bill, and move out of the way. If you need to buy additional supplies, relocate your boat. Don't forget to run your blower before starting.
- **9. Anchoring and mooring.** Enter an anchorage or mooring area at a slow speed. Don't create a wake that will disrupt other anchored boats. The first boat sets the tone. Mimic how they tie off, how much line you use and how much distance you allow between you and other boats. The busier the boat, the more space you should give yourself.
- **10. Be polite give a wave.** When passing another boat, give a little wave hello. Boating is all about having fun and being part of the boating community. Embrace it, enjoy it, and share it for generations to come.

I want to wish you all a great summer filled with memories of family and friends enjoying the lake but most of all, I pray you all have a SAFE summer on the lake.

So, where the heck did, they go? The word on the lake is that many have taken a trip over the dam and are headed for the "Croix" or have simply disintegrated.

Tribal knowledge on the lake is dwindling. Knowing where the sunken island is, the DNR cribs and other nuances of the lake are waning. If you have taken a ride around the lake, you know there is a lot of development happening. We are seeing the demographic of our lake residents changing significantly over the last few years. Lots of new, younger families moving to the lake now that more and more people can work remotely and no longer need to make the trek to the cities. These hidden dangers are becoming less than obvious, add cocktails and inattentive driving and we have a recipe for disaster.

With that said, the Association identified this as great opportunity to return value to our membership. We have reached out the Pine

PROPERTY AND DEVELOPMENT AND ZONING AROUND CROSS LAKE

If it wasn't evident in the past, it is definitely evident today; Cross Lake is a desirable place to be! We've all heard the stories about Minnesotans migrating to rural properties and lake communities through the pandemic and this has been abundantly observable on Cross Lake. New houses are springing up, skidsteers and excavators can be seen teetering the shoreline to do work, and new larger scale developments are being proposed.

With all the commotion, it seems worthwhile to step back and provide a brief primer on how lakeshore zoning and property development is regulated...

The state shoreland rules provide a statewide baseline suite of zoning regulations that apply to properties within 1,000' of a lake, 300' of a river, and the 100-year floodplain. These rules serve to protect the economic and aesthetic value of the landscape as well as water quality and habitat. Pine County has the default obligation to administer the property development regulations (permits, setbacks, tree and shoreline alteration, subdivision of land, etc.) outside of Pine City



limits. However, townships are authorized to adopt and administer their own shoreland zoning regulations, provided they are as restrictive and effective as the County. Pokegama Township, which covers the northwest side of Cross Lake, has elected to serve as their own zoning authority and handle all permitting associated

with the state shoreland rules. The City of Pine City serves as their own zoning authority and has adopted



shoreland regulations as well. While there may be differences of regulation interpretation, dedication of resources for administration and enforcement, and permitting procedures, the bones of the regulations should be fairly consistent, as they are all rooted in the same state rules.

Unfortunately, there is another layer of complexity; the federal and state floodplain regulations are also passed down to the local permitting authority. While floodplain rules are related to shoreland rules, they function as an independent set of regulations. In Pokegama Township, the Township has not elected to regulate floodplain development. Therefore, projects within the 100-year floodplain (often boathouses or grading and filling) require permits from both the County and the Township.

Why does this matter to you? Many Cross Lake residents care about the lake and appreciate the concept of a well administered permitting program for quality control on lake property development. If you see projects that you feel are not consistent with this shared value, it is important to understand who your zoning authority is and engage with them. Believe it or not, not all projects that people take on are permitted or legal! Phone calls from concerned citizens are an important quality control measure for the program. By having this background, you can help your neighbors understand where to turn for project permits and applicable regulations. Together, we can preserve the economic and aesthetic value of our lakeshore communities to keep them of high quality for generations to come.


