Best Barbeque Sauce:

- 1 ½ Cups chopped yellow onions
- 1 tablespoon minced garlic
- 1/2 cup vegetable oil
- 1 cup tomato paste (10 ounces)
- 1 cup cider vinegar
- 1 cup honev
- 1 tablespoon creamy peanut butter
- 1 tablespoon sugar
- ½ cup Worcestershire sauce
- 1 cup Dijon mustard
- 1/2 cup soy sauce
- 1 cup hoisin sauce
- · 2 tablespoons chili powder
- 1 tablespoon ground cumin
- ½ tablespoon crushed red pepper flakes

Directions:

In a large saucepan on low heat, sautee the onions and garlic with the vegetable oil for 10 – 15 minutes, until the onions are translucent but not browned

Add everything else and simmer uncovered on low heat for 30 min.

Launch time

When it comes time to launch your boat, here's some tips so you don't end up being "that guy" at the launch. The tension at the launch can often run high as people are in a hurry to



get on the water. In the evening as the sun sets, they want to get loaded up and home. The bugs can make it even worse.

When you arrive, be prepared when you get in the line to drop in. If there is a long line, you can do your prep while you wait as long as you can keep moving. Remove your tie downs, have all your PFDs for each passenger loaded, your coolers, personal items should all be loaded in the boat. Install your drain plug, your the battery switch on, pump the bulb, tie your lead rope and be ready to run. Give it a crank to make sure your battery is still charged.

When you get to the pad the clock is ticking. If you have passengers, you need to have one that can operate the boat, or the tow vehicle. There is nothing worse than 6 guests standing around while one guy launches the boat & leaves it blocking lane, while he goes to parks the vehicle and leisurely walks back. Don't be "that guy".



One person should be able to competently back the trailer down the ramp and unhook, while another fires it and pulls it clear of the trailer. Don't unhook the bow line until the engine is running, in case of a problem. After you launch, wait til your driver returns and then

pull back to the dock and pick up everyone. It's often much easier to launch/pull without passengers in the boat. If you don't have an able body to help, you need to lead the boat out of the launch area to the shore or opposite side of the dock. Your passenger can hold it there or tie off. If you regularly launch with the same person, you should teach them one job or the other. For safety's sake, having more than one person in the boat who can operate it is a very good idea in case of an emergency.

If you're waiting to launch, feel free to lend a hand to someone who is either alone or may be having some trouble. People often are reluctant to ask for help, but will always appreciate a hand. This is especially true with larger boats and pontoons. Older folks can struggle when it's windy/wavy as well.

When you return from the day, being able to drop someone at the dock to retrieve the tow vehicle reduces congestion at the docks. You can wait in the harbor area till your turn is up. Keep the docks clear for others to drop passengers and do the same.

Be sure your trailer has a safety chain to the bow eye. This is especially important with a roller trailer. If your lead strap breaks, the boat could end up on the launch ramp without a safety chain. I've seen it happen. Don't launch or pull out unless this is attached.

As usual, after you pull, make sure to remove the plug, pull any weeds from the trailer and give the boat a quick inspection for any invasive species. One thing I like to do is bring a bucket with and rinse the boat a little while it's being pulled out. This is real important late summer when the algae is floating on top of the water. I also bring a garden sprayer with clean water to rinse as well. Any lake residue will be much easier to remove now.

Hey Cross Lakers! We had a really good turn out at our May Board meeting and Caleb gave a fantastic presentation on shoreline restoration. Jerry Trent also presented a short presentation on shoreline restoration and what he is doing to restore his shoreline by adding a three foot buffer using Prairie Restoration Services. Since our last newsletter the Water Quality committee has been meeting regularly since January preparing a special informative letter to all Cross Lake residents. It should be finalized by the time this newsletter hits your door. Although we have had more than enough rain this spring we have not had the water rise like last year, which is good news because we aren't seeing the huge bog movement like we did last year. Although there are some very large bogs, they aren't the size of small islands like we saw last year. So, if you find one morning that there is a nice size bog floating towards your shoreline one thing you can do if you are able is to try and redirect back toward the middle of the lake and away from your dock. Some people may want these because they are losing shoreline, it is ok to let them plant in. Once they take root they are nearly impossible to move. Once rooted and you want it removed you will need to obtain a permit from the DRN and other expensive resources to get it moved. CLA as an organization does not move bogs due to liability reasons. They can do considerable damage to docks especially if the water is rapidly moving.

Water Quality is still looking for volunteers to sign up for AIS detection. The Association will reimburse you for the course once you show successful completion. We can use as many certified detectors as we can get. The learning is a lot of fun. We have an incredible water quality team this year with years of professional and technical experience in some form of water expertise. I feel so blessed that we have such an awesome group of people so interested in caring for our lake and the future of it. If you have a passion for our lake and want to help please join us. We meet once a month. Most meetings are scheduled for the 2nd Saturday of the month at 10 a.m. There are also lots of opportunities to get involved in meetings, sell rakes, test weeds, test water quality etc. the sky is the limit - just send me an email at info@ crosslakeassociation.org or check our website for further details on how to sign up https://crosslakeassociation.org. You can also send me a text at 612-209-6886.

We had great success on receiving our Permission to Spray forms. Somewhere around 150 people responded right up to the deadline. The really good news is we were sustainable – we did not spend one penny on paper or stamps. Everything this year was done electronically through email and text messaging. I want to thank you for all of your help with this. Next year we will work hard to make the form easier and hopefully be able to do electronic signature. The DNR was very pleased at the positive response of residents. Our DNR resource Rich came out in May and checked for curly leaf and milfoil. Treating with the herbicide cannot be done until the water is at least 50 degrees, otherwise the herbicide does not work as well. Spraying was completed mid-May of approximately 3 acres.

The Three Most Destructive Weeds in the Lake *Starry Stonewort has not been found in Cross Lake yet.



Curly Leaf Pondweed

Curly-leaf pondweed has caused problems in lakes by producing extensive mats in 3 to 10 feet of water. The plant is often a problem in lakes with low water clarity, mid-summer Secchi depths of three feet or less. The most important action is to remove all vegetation from your watercraft before you move it from one body of water to another.



Eurasian milfoil

Eurasion milfoil can take over a lake in two years. Large masses of Eurasian milfoil can lead to flooding and interfere with fishing, swimming and boating. Eurasian milfoil mats can increase mosquito habitat and decrease oxygen levels.



Starry Stonewort

Invasive species cause recreational, economic and ecological damage—changing how residents and visitors use and enjoy Minnesota waters. Starry stonewort impacts: Dense mats at the water's surface inhibit water recreationists.

Overtakes habitat and outcompetes native aquatic plants, potentially lowering diversity.

Provides unsuitable shelter, food, and nesting habitat for native animals.

We ask that you keep an eye out for the these three lake killers. If you think you may have one of these species, send me a photo or give me a call and I will come out and take a sample. Once a sample is obtained it will be immediately sent to the DNR for confirmation. Once confirmed as an invasive, a DNR representative will come out and evaluate. If warranted, spraying may occur.

Three Natives that look like Invasives and the most complained about

Wild celery is a predominantly submerged plant which grows narrow succulent leaves from 1 to 7 feet in length. Toward the end of summer the leaves emerge and lay flat on the surface. The plant can be identified at this time by the spring-like stem holding the submerged seed head. Wild celery grows best in shallow open water areas with full sunlight where it can take root in soft bottom sediment. Wild celery provides



an excellent source of food for waterfowl and fish. Both will feed on the aquatic insects attracted to its leaves. Waterfowl will feed on all parts of the plant. Additionally, wild celery provides excellent cover for fish.

Coontail receives its name from the bushy ends that resemble a raccoon's tail. Like chara it does not have true roots. It's a good plant for reducing problematic algae as it takes in phosphorus from the water. Coontail is a great addition to a pond or lake, but needs to be managed so it does not become excessive.



So what can be done about the natives?

Aquatic plant regulations

Under Minnesota law, aquatic plants growing in public waters are the property of the state. Because of their value to the lake ecosystem, they may not be destroyed or transplanted unless authorized by the Commissioner of the Department of Natural Resources as stipulated in the Aquatic Plant Management Rules. A "public water" is generally any body of water 2.5 acres or larger within an incorporated city limit, or 10 acres or larger in rural areas. If you are unsure whether a particular lake is public, please contact your local https://files.dnr.state.mn.us/fisheries/apm/apm-staff-locations.

Activities NOT allowed:

- · Excavating the lake bottom for aquatic plant control
- · Use of hydraulic jets PDF
- Destroying or preventing the growth of aquatic plants by using lake bottom barriers.
- Removing aquatic vegetation within posted fish-spawning areas.
- · Removing aquatic plants from an undeveloped shoreline.
- Removing aquatic plants where they do not interfere with swimming, boating, or other recreation.

Control methods which MUST HAVE a permit (blue highlighted can be found on DNR website listed above)

- Destruction of any emergent vegetation (for example, cattails and bulrushes).
- Cutting or pulling by hand, or by mechanical means, submerged vegetation in an area larger than 2,500 square feet.
- · Applying herbicides or algaecides.
- Moving or removing a bog of any size that is free-floating or lodged in any area other than its place of origin in public waters.
- Transplanting aquatic plants into public waters.
- Use of automated aquatic plant control devices (such as the Crary WeedRoller).
- Physical removal of floating-leaf vegetation from an area larger than a channel 15 feet wide extending to open water.

When a permit is NOT needed

If you are a lakeshore property owner who wants to create or maintain a swimming or boat-docking area, you may cut or pull submerged vegetation, such as Elodea, without a DNR permit under certain conditions:

 First, the area to be cleared must be no larger than 2,500 square feet. Second, the cleared area must not extend more than 50 feet along the shoreline or one-half the length of your shoreline, whichever is less.

The 2,500 square foot area may also include a boat channel up to 15 feet wide, and as long as necessary to reach open water (the boat channel is in addition to the 2,500 square feet allowed). The cutting or pulling may be done by hand or with hand-operated or powered equipment that **does not significantly alter the course, current, or cross-section of the lake bottom**. Such control cannot be done with draglines, bulldozers, hydraulic jets, suction dredges, automated aquatic plant control devices, or other powered earth-moving equipment. After you have cut or pulled aquatic plants, you must dispose of them on land to prevent them from drifting onto your neighbor's property or washing back into the lake.

In floating-leaf vegetation a lake shore property owner may maintain a channel 15 foot wide extending to open water by mechanical means without a permit. Any other destruction of floating-leaf vegetation requires a permit. If you have questions on control activities that do not require a permit, please contact your local aquatic plant specialist PDF.

If you plan to dispose of the aquatic vegetation someplace other than on your property you will need to download the aquatic plant transport authorization form PDF. This form allows you to transport the aquatic vegetation to a suitable location for disposal.

A DNR permit is not needed to gather aquatic plants for personal use (except for wild rice) or for constructing a shooting or observation blind.

Apply for a permit online

Fees for aquatic plant management permit depend upon the kind of control that you are doing, but generally will run about \$35.

Fee Information: The aquatic plant management fee information in the table below is provided for your reference. Maximum permit fees apply when multiple applicants are applying for a permit on a single application.

ZEBRA MUSSEL TRAPS

Update: The Zebra mussel traps are on their way! Sign up on line to receive yours if haven't done so.

This year Pine County Soil and Water is providing free Zebra mussel traps. We will provide instructions with the trap once we get them. All you need to do is check them once a month for anything that attaches itself to it and give us a call.
