The City Clerk then read the following Ordinance:

ORDINANCE NO. 105-85

AN ORDINANCE REGULATING SPEEDS UPON ALL STREETS

AND HIGHWAYS WITHIN THE CITY OF

CORDOVA, ALABAMA, AND ITS POLICE JURISDICTION

BE IT ORDAINED by the Mayor and City Commission of the City of Cordova, Alabama, as follows:

SECTION I: WITHIN CORPORATE LIMITS GENERALLY.

The speed limit on any street or highway located within the corporate limits of the City of Cordova shall be twenty-five (15 miles per hour, except as otherwise specifically provided in this article.

STATE LAW REFERENCE: Powers of local authorities, Code of Alabama 1975, §32-5-1; reasonable and prudent speed, Code of Alabama 1975, §32-5A-170, speed limit between working signs, Code of Alabama 1975, §32-5-93.

<u>SECTION II</u>. WITHOUT CORPORATE LIMITS BUT WITHIN POLICE JURISDICTION OF CITY GENERALLY.

The speed limit upon any street or highway located outside of the corporate limits of the city, but within its police jurisdiction, shall be forty-five (45) miles per hour, except as otherwise specifically provided in this article.

SECTION III. SPEED LIMIT - SCHOOL ZONES

- (a) It shall be unlawful for any person to drive or operate any automobile, motor truck, motorcycle or other vehicle on any portion of a street designated as a school zone at a rate of speed greater than fifteen (15) miles per hour during the hours of seven (7) a.m., and four (4) p.m., on any day on which the school in the vicinity of such school zone street is in session.
- (b) For purposes of this section the following areas will be designated school zones:
 - (1) North Street in its entirety.
 - (2) East Highland Street in its entirety.
 - (3) Atkins Street in its entirety.
 - (4) Massachusetts Avenue from one hundred fifty (150) feet north of Atkins Street intersection to a point one hundred (100) feet south of Highland Street intersection.
 - (5) All roadways and accessways which are on school board or city property and which service the schools but are not declared streets.

SECTION IV. SPEED LIMITS ON ROADS WITHIN FEDERALLY SUBSIDIZED PUBLIC HOUSING.

The speed limit on all roads and accessways located within Federally subsidized public housing in the City of Cordova shall be fifteen (15) miles per hour.

SECTION V. SPEED LIMIT BETWEEN WORKING SIGNS.

No driver of a motor vehicle upon any street or roadway within the police jurisdiction of the City of Cordova shall drive such vehicle in excess of fifteen (15) miles per hour between the warning signs placed on the street or roadway during construction, maintenance or repairs, when signs are placed not more than one thousand (1,000) feet from the place where workmen are actually engaged in such construction, maintenance or repairs.

SECTION VI. SPEED LIMITS - VIOLATIONS

It shall be unlawful for any person to drive any motor vehicle on any street, highwya, or roadway or portion thereof in the city or in its police jurisdiction at a speed in excess of the speed limit established in this ordinance for such street, highway, roadway or portion thereof.

Any person violating the provisions of this ordinance shall, upon conviction, be punished by a fine of not less than ten dollars (\$10.00) nor more than one hundred dollars (\$100.00). In addition thereto, any person so convicted may be imprisoned or sentenced to hard labor for the City for a period not exceeding ten (10) days, at the discretion of the Court trying the case; provided, however, no penalty shall consist of a fine or sentence of imprisonment exceeding the maximum fine or sentence of imprisonment established under State law for the commission of substantially similar offenses.
