## ORDINANCE NO. 001-2018

AN ORDINANCE TO GRANT A NON-EXCLUSIVE FRANCHISE RENEWAL FOR THE CONSTRUCTION AND OPERATION OF A CABLE SYSTEM WITHIN THE CITY OF CORDOVA, ALABAMA.

**BE IT HEREBY ORDAINED** by the City Council of the City of Cordova, Alabama, sitting in regular session on Tuesday, July 24, 2018, at 6:30 p.m. as follows:

- <u>Section 1.</u> Marcus Cable of Alabama, L.L.C. hereinafter referred to as the "Grantee" is hereby designated and renewed as a non-exclusive franchisee of the City of Cordova, Alabama ("the City") for the construction and operation of a cable system within the City on the terms set forth in the Franchise Extension Agreement, attached hereto as "Exhibit A" hereof.
- <u>Section 2.</u> The Franchise Extension Agreement, attached hereto as "Exhibit A" hereof, is incorporated by reference in full as a part of this Ordinance and its terms and conditions shall be made a part hereof as if fully set forth herein.
- <u>Section 3.</u> A copy of the Franchise Agreement to which the Franchise Extension Agreement applies is attached hereto as "Exhibit B" hereof.
- <u>Section 4.</u> The Mayor of the City shall have the authority to enter into the Franchise Extension Agreement, attached hereto as "Exhibit A" hereof.
- Section 5. This Ordinance shall become effective upon its adoption as provided by law.
- Section 6. The sections, paragraphs, sentences, clauses and phrases of this Ordinance are severable, and if any phrase, clause, sentence, paragraph or section of this Ordinance shall be declared unconstitutional by a court of competent jurisdiction, then such ruling shall not affect any other paragraph and sections, since the same would have been enacted by the City Council without the incorporation of any such unconstitutional phrase, clause, sentence, paragraph or section.
