ORDINANCE NUMBER: 2012-005

AN ORDINANCE ESTABLISHING SINGLE MEMBER COUNCIL DISTRICTS FOR THE CITY OF CORDOVA

WHEREAS, the City Council of the City of Cordova, Alabama hereby establishes seven single member council districts for purposes of the 2012 municipal elections and subsequent municipal elections, as follows:

SECTION 2. That nothing herein shall be construed as limiting the power of the City of Cordova to adjust precinct boundaries, in accordance with applicable law, provided that the geographic boundaries of the council districts described in Section 1, hereinabove, are maintained.

SECTION 3. That the position of alderman as provided in Alabama law for each of the districts and described and established in Section 1, hereinabove, shall be filled in the election to be held for such purposes which shall be conducted pursuant to and in accordance with the election laws of the State of Alabama.

SECTION 4. That immediately upon this ordinance being adopted by the City of Cordova, Alabama and published pursuant to Alabama Law, the City Attorney and the Mayor and City Clerk shall promptly do any and all things necessary to obtain approval and pre-clearance of the council districts as described hereinabove by the United States Department of Justice, pursuant to the Voting Rights Act of 1965.

SECTION 5. All previously adopted ordinances in conflict are hereby repealed. ADOPTED sitting in regular session this _____ day of March, 2012.
