ORDINANCE ADOPTING STATE MISDEMEANORS, VIOLATIONS AND OFFENSES AS MUNICIPAL ORDINANCE VIOLATIONS

 		CORDOVA				, ALABAMA, AS FOLLOWS:					

- Section 1. Any person or corporation committing an offense within the corporate limits or the City TOWN) of Cordova , Alabama, or within the police jurisdiction thereof, which is declared by a law or laws of the State of Alabama now existing or hereafter enacted to be a misdemeanor, shall be guilty of an offense against the City (XXXXXI) of Cordova , Alabama.
- Section 2. Any person or corporation committing an offense within the corporate limits of the City (**Cown*) of Cordova , Alabama, or within the police jurisdiction thereof, which is declared by a law or laws of the State of Alabama now existing or hereafter enacted to be a violation, shall be guilty of an offense against the City (**Coxn*) of Cordova , Alabama.
- Section 3. Any person or corporation committing within the corporate limits of the City (YEWM) of Cordova ____, Alabama, or within the police jurisdiction thereof, an offense as defined by Section 13A-1-2 of the Alabama Criminal Code, which offense is not declared by a law or laws of the State of Alabama now existing or hereafter enacted to be a felony, misdemeanor or violation, shall be guilty of an offense against the City (YEWMX) of _____, Alabama.
- Section 4. Any person found to be in violation of Sections One (1), Two (2) or Three (3) of this ordinance shall, upon conviction, be punished by a fine of not less than One Dollar (\$1.00) nor more than Five Hundred Dollars (\$500.00) and/or may be imprisoned or sentenced to hard labor for the city (town) for a period not exceeding six (6) months, at the discretion of the Court trying the case, unless otherwise provided by Section 5 of this ordinance. Any corporation found to be in violation of Sections One (1), Two (2) or Three (3) of this ordinance shall, upon conviction, be punished by a fine or not less than One Dollar (\$1.00) nor more than Five Hundred Dollars (\$500.00), at the discretion of the Court trying the case.
- Section 5. Any person found to be in violation of Section 32-5A-191, Code of Alabama, 1975, as amended, shall, upon conviction, be punished by a fine of not more than Five Thousand Dollars (\$5,000.00) and/or may be imprisoned or sentenced to hard labor for not more than one year.
- Section 6. Any ordinance heretofore adopted by the City (Town) Council of the City (Town) of Cordova , Alabama, which is in conflict with this ordinance is hereby repealed to the extent of such conflict.

Section 7. If any part, section or subdivision of this ordinance shall be held unconstitutional or invalid for any reason, such holding shall not be construed to invalidate or impair the remainder of this ordinace, which shall continue in full force and effect notwithstanding such holding.

Section 8. This ordinance shall become effective on _____ December 10, 1985 ____.
